According to reports, Thursday, at approximately 1:43 a.m., Officer F. Donth, LCPD responded to Kenjo on Highway 321 in reference to a shoplifter. Upon arrival the officer noticed Stanley T. Ingram driving from the parking lot. After confirming this was the person and the vehicle involved Lt. David Flynn, LCPD stopped the vehicle.

While investigating the shoplifting, Officer Donth observed a clear cigarette

wrapper with four white pills in plain view in the drivers side door pocket. The pills were later identified as Klonopin, a schedule IV controlled narcotic.

Ingram did not have a prescription for the pills.

Ingram reportedly had a very slurred speech pattern and could not maintain his balance. Mr. Ingram was given roadside sobriety tasks and he performed very poorly on them.

Ingram agreed to submit blood for content testing and was transported to the hospital and then to the Loudon County

Jail. Once there, Officer Donth served him with a warrant for the charge of theft.

Records indicate Montgomery was in the vehicle with Ingram and the pair had gone inside Kenjo's on Highway 321. While Ingram distracted the clerk and blocked his view, Ms. Montgomery allegedly put beer and vienna sausages in her purse.

When the vehicle was stopped a little while later and Montgomery's purse was searched, officers discovered two 24 oz. cans of Bud Light, one 24 oz. can of Miller High Life, one

16 oz. can of Amp Energy Drink and one can of Armour Vienna Sausages in it.

Montgomery reportedly passed all points of payment without paying for the \$8.99 worth of items.

Montgomery is not the legal drinking age of 21, she is only 20 years old. Officer Mark Maxwell, LCPD assisted in the arrests.

Gary Lynn Nobles, 49, River Chase, Lenoir City, was charged with public intoxication.

The report states, on Sunday, around 9:05 p.m., Officer Roy Rogers, LCPD, received a complaint from Loudon County

dispatch, about a individual passed out on a paddle boat, just a few yards from the Lenoir City Park.

The Loudon County Rescue Squad was on the scene and the man had awakened and was reportedly attempting to paddle across the water when the officer arrived.

Officer Rogers went by boat with the Loudon County Rescue Squad and found Mr. Gary Nobles to be the operator of the paddle boat. He was reportedly heavily under the influence of an alcoholic beverage.

For his safety, as well as others, Nobles was placed under arrest for public intoxication.

Applications

TWRA license agent, TWRA Regional Office, or online at the TWRA Web site at www.tnwildlife.org. Mailed applications will not be accepted. (The application appears at the end of this release).

Sportsmen are reminded to read the application form carefully, fill out all requested information, double-check the form, and take it to a license agent where it will be entered into the system. When applying at any TWRA license agent, there is no fee for current Annual Sportsman License holders, Lifetime Sportsman License holders, or seniors possessing a Type 167 permit. For all other applicants, there is a \$20 permit fee for each drawing you enter plus a \$1 agent fee.

Hunters may also apply over the Internet at the TWRA Web site. There is no fee for current Annual Sportsman License holders, Lifetime Sportsman License holders, or seniors possessing a Type 167 permit. All other applicants, in addition to the \$2 internet usage fee, will be charged a permit fee of \$20.50 per drawing entered. The \$2 usage fee is collected by the company that maintains the internet site. (It is not a fee that is charged by the TWRA.)

TWRA continues to use the priority system for computer drawings. The WMA Quota Draw has an increasing priority system. Applicants, who applied but were unsuccessful for the past four years, will have a priority of 4. Applicants unsuccessful for one year will have a priority

of one and those that were drawn last year have a priority of zero.

When applying at a license agent, hunters must remain at the location while the application is processed.
