



and our joint decision to take this step have been vindicated by Patton's ouster.

County Attorney Tom McFarland stated, "Because of this case, Roane County is a safer place today than it was yesterday."

District Attorney Russell Johnson stated, "I did not enter into the decision [to file the ouster lawsuit] lightly as it is difficult and sometimes dangerous to attempt to remove a public official who was put into office by the people's vote, but Patton by his continued actions and conduct left me with no choice."

of Mark Patton's conduct went uncontroverted by Patton and his attorney, Chris Cawood, who even admitted that his client engaged in conduct that Cawood termed merely "rude and crude" while con-

tending that his ac-

tions were protected

by the US Constitu-

tion.

Our argument all along was that Patton's conduct went too far beyond what was constitutionally protected speech when he engaged in reckless conduct by nearly running a mother with four children in her car off of I-40 and laughing about it as he was doing it: by literally running an elderly lady and her son off of James Ferry Road in his personal car to try and make what he contended was a traffic stop; by provoking teenage boys at Kingston City Park into an argument. then assaulting one and spraying pepper spray on several of them; by engaging in a pattern of harassment to law enforcement officials while they were engaged in their duty of protecting and serving the public.

Patton has claimed throughout this process that he is only out to expose corrupt law enforcement and public officials. Yet our proof showed that Patton, amazingly enough, turned on law enforcement and their families because he was upset that a Kingston Police Officer arrested Patton's friend for DUI. Thus, Patton's 'vendetta' started with his own frustrated traffic stop of the same KPD Officer. We felt it was poignant that we showed Patton was merely-abusing his power in a manner in which he tried to claim that legitimate law enforcement officers were doing.
