Sheriff's Department officials charge Harriman pair in Philadelphia home burglaries (see Burglaries pg. 3)



Burglaries

2009, deputies responded to Dry Valley Road, Philadelphia, in reference to a burglary to a residence after a rock was thrown through a door window. The owner, Shannon Jenkins discovered a Hewlett Packard laptop valued at \$900 had been taken on August 7, 2009.

Joy Barron was stopped by Investigator Jason R. Smith and Lt. Patrick Upton. LCSO on Calloway Road in Loudon, Her vehicle matched the description of one that was seen leaving the scene of a residential burglary on Calloway

Road. Upon interviewing her, Barron admitted to dropping off David Aaron Gooch at the residence on Dry Valley Road and described the computer that was taken.

Barron stated she sold the laptop to a relative. The computer was recovered from the relative by Corporal Chad Estes, LCSO and identified as the laptop taken.

Gooch was apprehended after fleeing from the residence that was burglarized on Calloway Road.

Upon interviewing him. Gooch admitted to committing the burglary on Dry Valley Road and described the laptop that was stolen.

On August 7th, 2009, deputies from the Loudon County Sheriff's Office responded to Calloway Road in reference to a burglary in progress. Mr. Matthew Hicks, the homeowner, arrived and discovered a window broken out of his door and the door was open. Upon looking inside the house, he witnessed a male subject inside and saw guns and a television lying on the floor. The man ran from the residence and was followed by Mr. Hicks. who gave a description to responding officers.

Corporal Pete Mc-Ginley, LCSO discovered the suspect in a field. A search of the

suspect revealed a remote control belonging to the television from the residence.

Detective Jason Smith, LCSO and Lt. Patrick Upton, stopped a vehicle leaving the scene and identified the driver as Jov Barron. Joy Barron stated she dropped David Arron Gooch off on Calloway in front of the residence. Upon interviewina Mr. Gooch, he admitted to committing the burglary.

Investigator Jason Smith was the investigating officer and Lt. Patrick Upton and Corporal Pete McGinley assisted. Deputy Mckinzie Williams transported the pair to jail.

Brandon Andrew Russell, 20, homeless, was charged with aggravated burglary and theft over \$1000 of his 68 year old grandmother's safe in her residence.

According to an affidavit of complaint, Brandon Andrew Russell committed the offense of theft over \$1000, on or about July 11, 2009 when he made entry into his grandmother's residence and took items without her effective consent and with the intent to deprive her.

The items taken reportedly included

State quarters totaling approximately \$3000, a Smith & Wesson 9 mm handgun, a .38 caliber handgun and at least 3 pocket knives.

Records indicate the items were all in a locked safe in the residence and Mr. Russell admitted to entering the safe after he found the code to it. Mr. Russell also admitted to taking the items from the safe and using the cash to purchase narcotics, as well as selling at least one of the handguns for money to purchase narcotics.

Walk will give hikers a good look at Tellico Village lakeside and golf front homes, beautiful landscaping and plenty of panoramic views along a natural Tellico Lake bluff trail.

For peddle power enthusiasts, cycle events include 50km, 100km and 100 mile options. The 50km route will begin at Tellico Village Square, loop southeast of TN 72 traversing back roads, farmland and

The more challenging 100km tour is equivalent to approximately 62 miles. For skilled riders who can average 20 mph, the course will require about 3 hours with hydration stops along the way. shore of Tellico Lake, crossing the first span of the US 321 bridge and finishing on TN 444 at Tellico Village Square.

Jim Getchonis, project chairman for Tellico Lake Rotary club, Tour de Tellico host organization and platinum sponsor, said, "The 100 mile course aims at attracting serious cyclists. Although not a competitive event, the course is intended to provide a rigorous experience for seasoned riders."
