### 9th DAG agents nab alleged LC pedophile

Ninth Judicial District Attorney General Russell Johnson announced Thursday the apprehension of Andrew S. Krikau by members of the Missouri Violent Crimes Task Force, led by the United States Marshals.

Krikau, from Lenoir City. was arrested Wednesday at 8:30am in Wright City, Missouri, within 72 hours of the case being adopted by the

Smoky Mountain Fugitive Task Force.

On August 10, 2009, the Loudon County Grand Jury issued a true bill against Krikau for sexual exploitation of a minor. Krikau is charged with possessing explicit material depicting a minor child engaged in sexual activity.

groups, watershed organizations, and conservation groups, etc., with riparian tree planting projects.

All seedlings must be bought through the Department of Agriculture, Division of Forestry. Tree planting season in Tennessee is October through March.

Five grants, at \$500 each, are available for each of TWRA's four regional Aquatic Habitat Protection projects (a total of \$2,500 per region). The funds will be obligated as grants, so the grantee must have a nonprofit tax number. The projects the money spent, and a report submitted by June 30, 2010. In order to meet this deadline, TWRA will accept proposals through Dec. 15, 2009.

Grant proposals should include the applicant organization's name, tax ID number, address, phone, and name of a contact person authorized to enter into contractual agreement on behalf of the organization. The proposal should also include the name of the stream, county or counties involved. and the project area and description.

located is the result of having good intel and a dedicated group of officers working together" Johnson stated.

The charge against Krikau is the result of an extensive investigation by Lieutenant Detective Dan Schneider, Ninth Judicial District Internet Crimes Against Children (ICAC) investigator, agents for the Ninth District Violent Crimes and Drug Task Force, Harriman Police and Lenoir City Police detectives.

Krikau is currently awaiting extradition

to Tennessee in the Warren County, Missouri jail.

This is the second interstate flight arrest within the last few months.

James E. Fredrick was arrested in Corbin, Kentucky, on June 24, 2009, for failing to satisfy the requirements of the Sexual Offender Registry.

Fredrick was convicted in April of 1991 for aggravated criminal sexual assault on a minor in Chicago, Illinois, and had been living in Harriman.

Fredrick is being prosecuted in federal

court since he went across state lines in an attempt to evade authorities in Tennessee in violation of the Adam Walsh Act.

At the time of his arrest by members of the United States Marshals Smoky Mountains Fugitive Task Force, Fredrick was living with a woman whom he met on the internet and her two minor children.

The woman did not know that Fredrick was a sexual offender.

"We want to rid our streets of these predators and prevent them from causing further harm. Thanks to the Smoky Mountain Fugitive Task Force and their assistance; it doesn't matter if these criminals are still within the ninth district. We will go get them and bring them to justice wherever they may try to hide". Johnson said.
