LCSO thwarts madman's assault


Phil. man threatens to kill family with knife

Members of the Loudon County Sheriff's Office arrested a Philadelphia man Thursday after he allegedly attempted to get to several; family members locked in a bedroom while threatening to kill them with a knife.

Benny Lee Worley, 55, Old Lee Highway, Philadelphia, was charged with aggravated domestic violence x 4 and aggravated assault.

The report states Corporal Chad Estes, LCSO was dispatched to a residence on Old Lee Highway at 8:42pm Thursday after a woman called 911 stating her father, Benny Worley, was intoxicated and armed with a knife.

The woman advised Worley was attempting to stab her husband, herself and her 8 (see Worley pg. 3)

Worley was trying to get in the bedroom and was stabbing the door with the knife. reportedly stating he was going to kill them

Corporal Estes reported when he arrived on scene he could see through the

front glass door and saw a man standing at the bedroom door with a silver knife in his right hand. The man was making threats to the people behind the door.

The officer gave several loud verbal commands to put the knife down and the man, later identified as Benny Lee Worley, became belligerent toward Corporal Estes and started walking towards him. saying he was going to kill 'him' with the knife.

The lawman pulled his duty weapon and pointed it at Worley and gave several more loud commands to drop the weapon, and Worley would still not obey commands. telling the officer to just shoot him.

The lawman went to the yard while Worley was standing in the doorway with the knife in his hand.




