



## National Academy's 270th Class Graduates Receive Presidential Congratulations

The FBI's National Academy—a prestigious 11-week educational program for law enforcement officers from around the world—graduated its 270th class today, and on hand to congratulate the graduates were Director Christopher Wray, Attorney General Jeff Sessions, and President Donald Trump.

"I'd like to extend a

special welcome to President Trump and Attorney General Sessions," Wray said, addressing the 222 students in this session's class, who represent 49 U.S. states, 20 countries, four federal agencies, and three branches of the U.S. military.

"For more than 80 years," Wray said, "this program has served as a bridge between state and local

law enforcement to international law enforcement. Today, you join the ranks of more than 50,000 graduates from more than 170 countries."

Founded in 1935, the National Academy program offers mid-career law enforcement leaders an advanced training program at Quantico, Virginia, the same location where the FBI trains its agents. National Academy students take courses in subjects ranging from behavioral science to counterterrorism to intelligence theory and engage in intense physical training. Just as importantly, they network with their peers.

Forging friendships and partnerships, Wray said, "is what the National Academy does best. As the world becomes smaller and perils loom larger, we've learned that a threat to one of us can be a threat to all of us. We've learned that working together isn't just the best option, it's really the only option."

In welcoming Trump, Wray noted that it has been 46 years since a U.S. commander in chief participated in a National Academy graduation. "Mr. President, there is no better place to talk about the importance of partnerships than here at the National Academy, surrounded by some of the finest law enforcement leaders from here at home and

around the world."

"It is an honor to join you today and to stand with the incredible men and women of law enforcement," Trump said during his remarks. "I am here not only to congratulate you, but to honor you for your courage and devotion."

In addition to thanking the many family members in the audience, the president said, "Now, more than ever, we must support the men and women in blue." Trump addressed a number of issues related to policing and national security and said the Department of Justice has announced more than \$98 million in grant funding to help local police departments hire new officers. "If we want to bring down violent crime," he said, "then we must stand up for our police."

Wray noted that last February, the president addressed the Major County Sheriffs Association, calling for a national partnership and a new beginning between law enforcement and the citizens they serve. "By joining us today," he said, the president is "renewing that call."

Trump also recognized the National Academy's class president and spokesman, Drug Enforcement Administration officer Craig Wiles, whose

father graduated from the National Academy 40 years ago and was in the audience today for his son. Wiles reminded the graduates and their families that "evil lives around the world," noting that during his session's nearly 11 weeks at Quantico, 24 law enforcement officers lost their lives, several terror attacks occurred in the U.S., and 10,000 individuals died of drug overdoses.

But Wiles remained hopeful. Based on his experience at the National Academy, he said, "I have never been more enthusiastic and optimistic about the future of the law enforcement com-

munity." He added, "There is no greater calling than this honorable profession."

Dylan Burns, 21, Hines Valley Road Lenoir City, was charged with Criminal Impersonation, and Driving on Revoked Suspended License.

Cpl. Chris Jenkins LCSO responded to said location Hines Valley Rd. to a possible wreck with injury or a possible domestic dispute. Deputy arrived on scene and found a black male and a white female standing outside of the vehicle. Deputy then made contact with 2 witnesses and they gave verbal and written statements that the male and female was outside the vehicle arguing and the male was kicking her clothes. The male got into the drivers seat of the vehicle and when the female attempted to get in the vehicle the male almost drug her. Witnesses also stated that the male was driving when the vehicle wrecked. Deputy made contact with the female and identified her.

Deputy then made contact with the male and tried to identify him. He wrote on a piece of paper the name of Mr. Ward and a date of birth. The male could not provide a social security number or any other identifying information. Deputy then found a social security card and ran the social that came back to Mr. Dylan Thomas Burns. Mr. Burns identification was sent to Deputy phone and was identified as Mr. Burns. Mr. Burns did give false information to this officer to hide his true identity. A run if Mr. Burns license through NCIC showed Mr. Burns to have a revoked license in Tennessee for failure to satisfy 2-2017. Mr. Burns was then placed under arrest and transported to the Loudon Co., jail. The vehicle was towed by Moneymakers due to vehicle and private property damage. Private property victims and restitution are on report.

driver Coy Tinnel along with passengers Marian Chastain and a male. While speaking to Mr. Tinnel he did advise there would possibly be marijuana shake in the vehicle, as well as giving consent to search the vehicle. While searching the vehicle Deputy found in the console a blue box containing a Meth Pipe along with Crystal Methamphetamine (2.1 grams), Mr. Tinnel stated the items were his. Also, during the search Deputy found a black bag that Mrs. Chastain stated was hers, inside the bag (with her stating nothing was inside) Deputy found 2 needles along with a bottle cap with a small amount of Meth from where she was using the cap to draw the Meth from. Both subjects were taken into custody with the male being free to leave. The vehicle was towed by Malone's Wrecker Service with all this occurring in Loudon County, Tennessee.

Jessica Cameron, 36, Old Hwy 95 Lenoir City, was charged with Domestic Assault, and Simple Possession.

Deputy A. Parton LCSO, responded to Old Hwy 95 in reference to a domestic. Upon my arrival Deputy spoke to the victim who stated his wife had assaulted him and his daughter. Mr. Cameron stated that Jessica Cameron was in a verbal argument with him and his daughter when she shoved his daughter on to the couch. Jessica Cameron then went to the kitchen and picked up a large knife and chased him around the house.

She then walked

outside of the home and threw a rock at victim striking him in the chest. Deputy then went and spoke to his daughter and she confirmed victim story. Both parties filled out a domestic violence statement form and refused to be taken to a shelter or a safe place. While on scene Dep-
