of the Loudon County Narcotics Unit arrived on scene and spoke with the employees of the store. Investigators contacted Assistant Chief Paul

Curtis and his certified narcotics detection K9 partner Damus. Investigators placed three packages in a row. Assistant Chief Curtis deployed K9 Damus and conducted

an open air sniff of all three packages. Assistant Chief Curtis advised K9 Damus did alert to the odor of narcotics in the gray plastic Wal-Mart bag that Ms. Varner

attempted to ship. A search warrant was written and the bag was searched. The white powder substance was field tested and it did test positive for cocaine. The co-

caine weighed 2.39. These above actions did occur in Loudon County, Tn. There was no indication as to why Loudon County responded instead of Lenoir City inside the city limits for a drug related call.
