
Deputy was traveling South on Hwy 11 near Browder School Rd. When he observed a Black Dodge Duran-


Thomas Leach, 32, South Main Street Sweetwater, was charged with Criminal Court Capias.





## Impersonation

Jeremy Aikens, 41, Hall Street Lenoir City, was charged with Contraband in Penal Institution, Failure to Appear, Poss. of Drug Para., Simple Possession, and Criminal Impersonation.

Deputy A. Parton LCSO, was notified by Loudon County Dispatch that Jeremy Aikens was traveling in a silver Mazda on Highway 11 W near the Justice Center. Deputy then observed the vehicle with Jeremy Aikens in the back passenger side seat. Deputy then stopped the vehicle on Highway 11 at Sugar Limb Road. Deputy then asked Mr. Aikens for his identification and he handed him a Tennessee drivers license with the name of Jerome. Deputy asked Mr. Aikens to provide his real name and he stated that he was Jerome. Deputy then detained Mr. Aikens and went back up to the vehicle. While talking to the driver Deputy observed Mr. Aikens wallet with several credit cards with his name in it. Deputy then retrieved the wallet and recovered a social security card with Mr. Aikens name on it.

Deputy then advised Mr. Aikens that if he continued to lie to him about his name that he would be charging him with criminal impersonation. Mr. Aikens stated that

his name was Jerome. Deputy then placed Mr. Aikens into custody on warrant number 53gs1-2016-cr2006 and transported him to Loudon County Justice Center. While being searched Mr. Aikens was found with .04 grams of white rock believed to be crack cocaine and a orange straw used to snort the crack cocaine.

Therefore seeing the above facts. Deputy is charging Jeremy Aikens with possession of schedule II, possession of drug paraphernalia, introduction of contraband into a penal facility, and criminal impersonation. This did occur in Loudon County, Tennessee.
