
Investigation Finds UT Athletics Staff Accepted Trips and Entertainment from Vendors





New alternatives to Twitter, Google, Facebook rapidly emerging: These sites won't censor you

GoodGopher is the world's first search site that is privacy-protected and which filters out corporate media propaganda and government misinformation. The site:

- Will never spy on users
- Includes no corporate/government propaganda disguised as "news" and "information"
- Features an "Honest Relevancy Algorithm" that is applied and weighted equally across all sites, playing no favorites or blocking legitimate reporting and science from independent sources

GAB.ai
Developed by free-speech advocate Andrew Torba, GAB.ai is a Twitter-style network that combats censorship by allowing users to post whatever they want, saying what they

"If I had to pick a single event that pushed me over the edge to take action, I would have to say it was the suppression of conservative sources and stories by the incredibly biased Facebook Trending Topics team," Torba said

in an interview with Charlie Nash of Breitbart News.

Right now the site is very much in its beta form and there is a waiting list of at least 186,955 after this writer signed up to join. So clearly, as the site gains more attention and the focus on free, unlimited

be watching," Matlock said. "Instead we will be taking donations for AmVets, the veterans organization that was shamefully denied by the NFL from advertising their message on the Super Bowl."

Jimmy Matlock is the owner of Matlock Tire, which is in its 65th year in business, with locations in Farragut, Maryville, Lenoir City, and Athens. He has served as a State Representative, representing most of Loudon and Monroe counties since 2006. He and his wife, Dean, reside in Lenoir City and have three children - Lindsay, Joe, and Reagan.

Department of Audit and Compliance notified the Comptroller's Office of possible discrepancies.

Investigators determined the director of sports surface management violated university policy when he accepted at least two paid trips and related entertainment from a department vendor which had previously been awarded an equipment lease worth \$763,898. In 2016, the director traveled to Illinois for two days of golf, and he also participated in a golf scramble in Georgia. The vendor provided lodging, air fare (when applicable), green fees, and other privileges. This violated UT's policy prohibiting university employees from accepting entertainment or other gifts exceeding \$75 in value.

The director was also absent from work during a two-day trip to the Masters Golf Tournament in April 2016. Although the director reimbursed a prospective vendor for his event pass, he failed

to record two days of leave on his university time records.

In 2014, two current UT athletics department employees attended one day of the Masters Golf Tournament as guests of a potential vendor that was actively marketing its product to the university. This trip also violated the

university's policy prohibiting the acceptance of gifts or entertainment exceeding \$75 in value.

Investigators also determined the athletics department had placed restrictive mandatory requirements on its request for quotation (RFQ) to purchase or lease

30 pieces of sports surface and golf facility maintenance equipment. These restrictive requirements may have inhibited bidding competition. On June 2, 2016, the UT purchasing department awarded the contract to the sole qualifying vendor.

"The University of Tennessee may wish to consider annual or periodic employee training related to its gift acceptance policy," said Comptroller Justin P. Wilson. "Officials should not engage in actions which might result in, or create the appearance of, private gain or preferential treatment."

speech grows, so, too, will GAB.ai.

Seen.life

Another social media site that continues to grow because of its dedication to free speech and privacy is Seen.life. Its creators vow to never gather and/or sell users' personal information, and "we don't let search engines data mine your posts if you want to make that choice," the site notes. Creators also want users to know that once they delete a post on Seen.life, it's gone, because they don't retain it.

The site also features "Unity," a "reward token" redeemable on Seen.life that is built for sharing elsewhere as well. You can also chat live and get free Internet calling.

Adams says that's not all.

"We will be launching a YouTube alternative before the end of this year," he noted, giving users an alternative to the censorship that takes place on Twitter (which banned Breitbart Tech editor Milo Yiannopoulos, a gay, vocal supporter of President-elect Trump and a strident conservative).

"The Internet is rapidly fracturing, polarizing into two separate universes. On the left side, rooted in delusion and censor-

ship, you have Google, Facebook, Twitter and YouTube," said Adams, noting that NaturalNews.com is one of the sites targeted in recent assaults on free speech. "On the right, you have respect for free speech, intelligent discourse and practical problem solving to contribute to a better so-

ciety."


