



Charge for reckless homicide and arrest for maintaining a dwelling for drug use

Loudon County Sheriff Tim Guider announced today that after a lengthy investigation, James David Ingram, age 44 of Sweetwater, has been charged with Reckless Homicide in the overdose death of Jonathan Brewster. Brewster was only 34 years old at the time of his death on October 2, 2017 in Philadelphia, Tennessee.



Yet the FBI's work doesn't stop there. One of the most important


additional roles we play is assisting victims of federal crimes.

In addition, Matthew Alan Freeman, age 29 of Greenback (formerly of Philadelphia), was arrested by Loudon County Deputies today (April 12) for Maintaining a Dwelling for Drug Use. Freeman resided at the property which

investigators have identified as the property where Brewster died.

Investigators have determined that Ingram "provided the financial means" for Brewster to obtain the oxymorphone (formerly sold under the trade name Opana) that was in his sys-

tem at the time he died. A warrant for Ingram's arrest was issued on April 10th, 2018. Ingram is currently being held under other charges at the Monroe County Jail, and when he is released on those

charges, Ingram will be transferred to the Loudon County Jail.

Sheriff Guider noted that investigations into this type of circumstances take time and patience.

Law enforcement must wait on toxicology and final autopsy results, and there is tremendous investigative work in trying to trace the source of the drugs back from the victim to the source(s).

Guider went on to say that he also wants the citizens of Loudon County to know "we are making a statement" in the battle against prescription drug abuse and are actively pursuing prosecution for the sources in overdose deaths.



An important aspect of the victim assistance mission is the forensic child interviewing program, in which experts who are highly trained in child development conduct court-admissible interviews with child, adolescent, and young adult victims of crime. More than 9,000 child interviews have been conducted since the program was created, many of them involving human trafficking, sexual exploitation, or violent crime.

As the country marks National Crime Victims' Rights Week this week, the FBI's victim specialists are working every day—as they do all year long—to ensure victims and their families get access to the resources they need.

Assault charges for Lenoir City man

Justin Lowery, 43, Maple Street Lenoir City, was charged with Domestic Assault. Officer C. Dragon LCPD, was dispatched to Maple St on a physical domestic. Upon arrival, Officer met (victim) who stated that she and her boyfriend, Justin Lowery (offender), started arguing about her waking him up. She was about to go out and Justin had to watch their 3 year old son. Victim reported that Justin went to the bathroom and starting throwing her mirror and clothes out of the bathroom. She tried to get into the bathroom when Justin started threatening to

punch her in the face. After several threats, victim reported that Justin "started swatting at her, swatted in the face," and then showed her to the ground at which point she scrapped her left knee and right hand knuckle. Victim got her phone to call 911 and Justin knocked her phone twice out of her hands. Justin Lowery was identified as the primary aggressor and then taken into custody for domestic assault and transported to the Loudon County Jail without incident. There is prior call history of domestic related incidents according to Loudon County Dispatch at this address. The last domestic call was in 2015.
