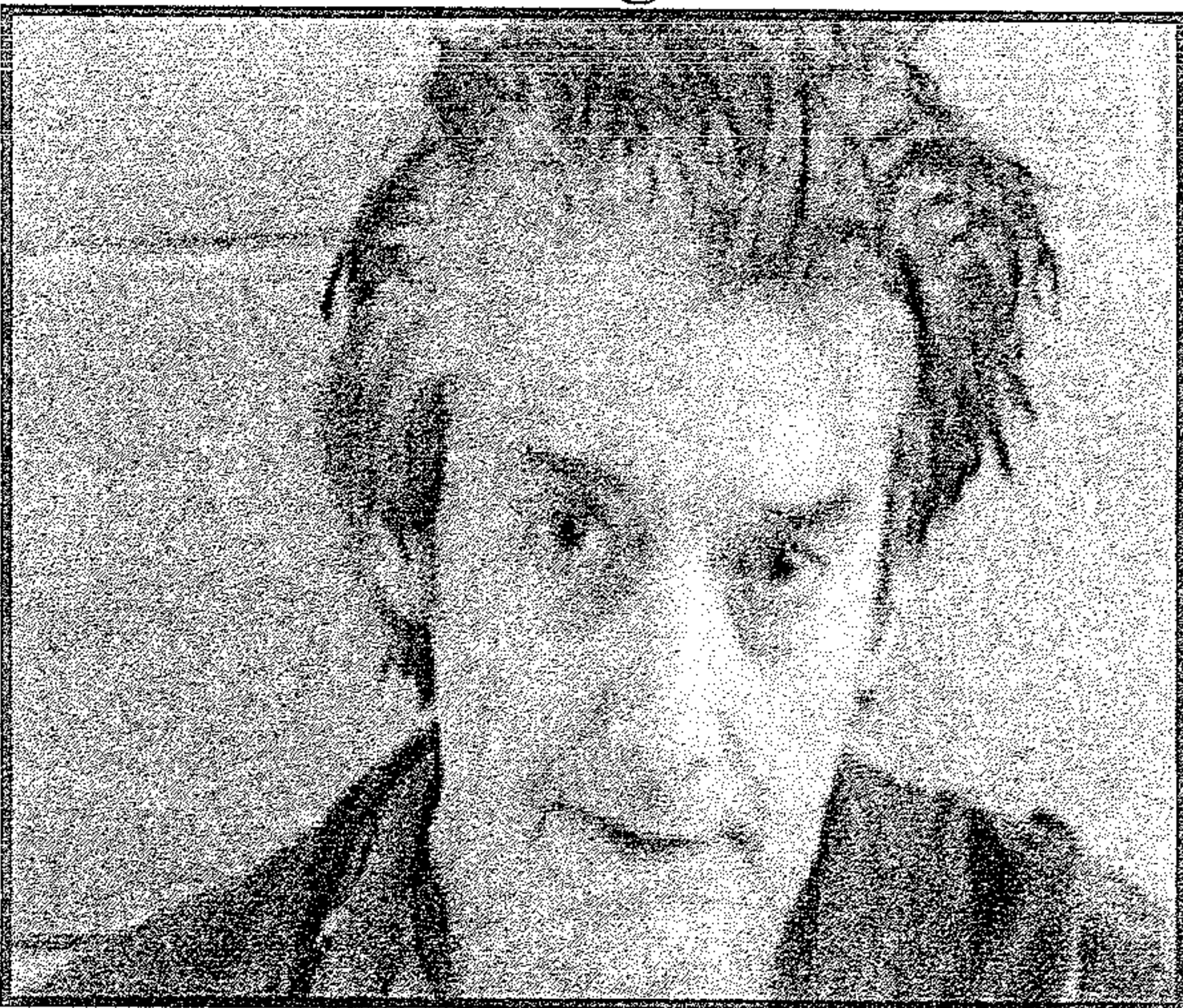

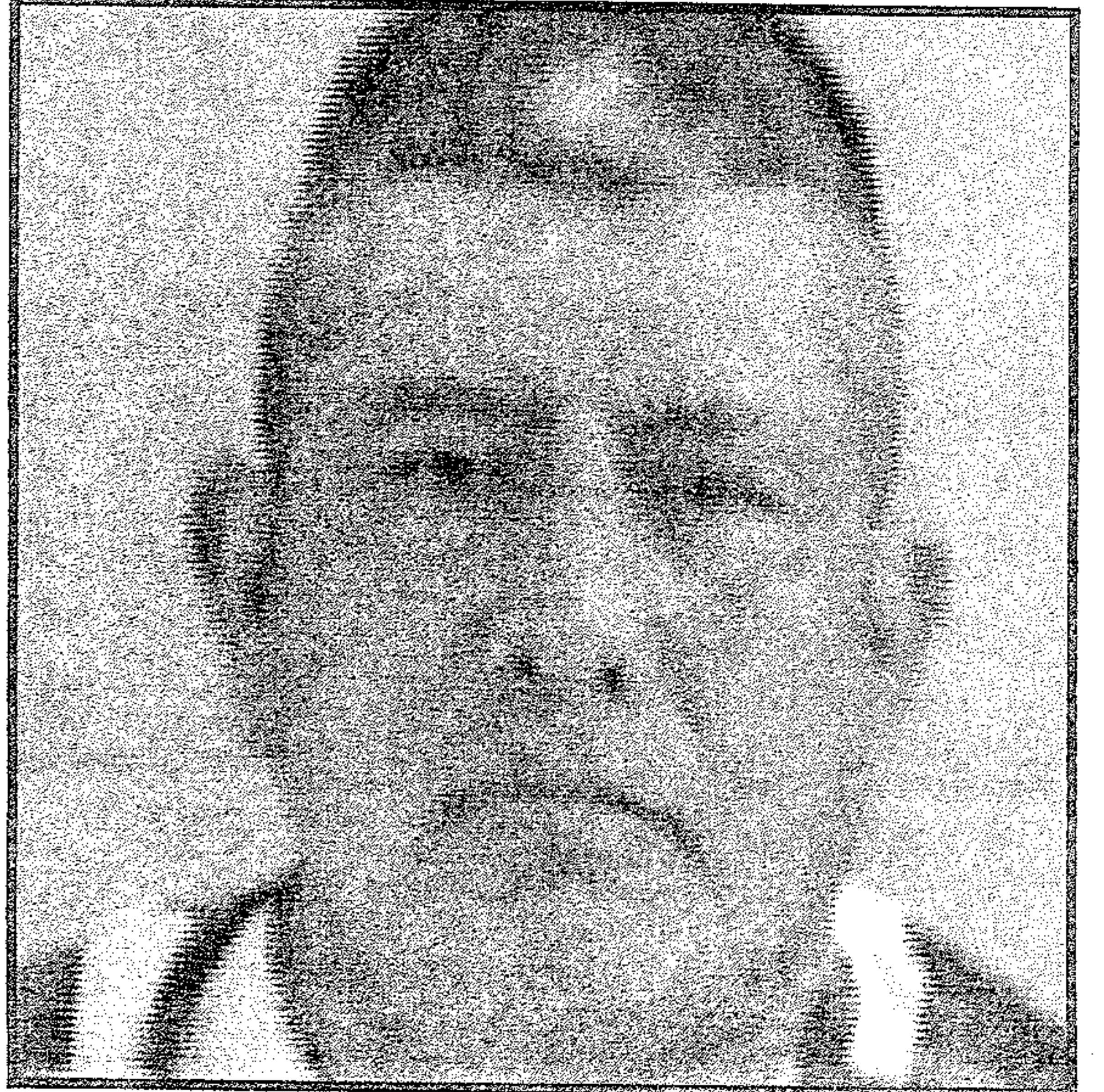

## Art Crime Stolen Ruby Slippers from The Wizard of Oz Recovered

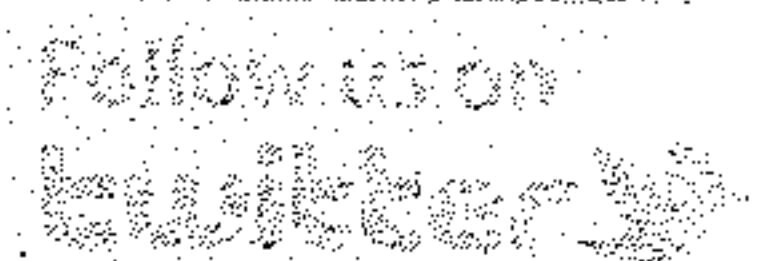
A conservator for the Smithsonian Institution's National Museum of American History analyzes one of the ruby slippers that were recovered by the FBI after being stolen in 2005.

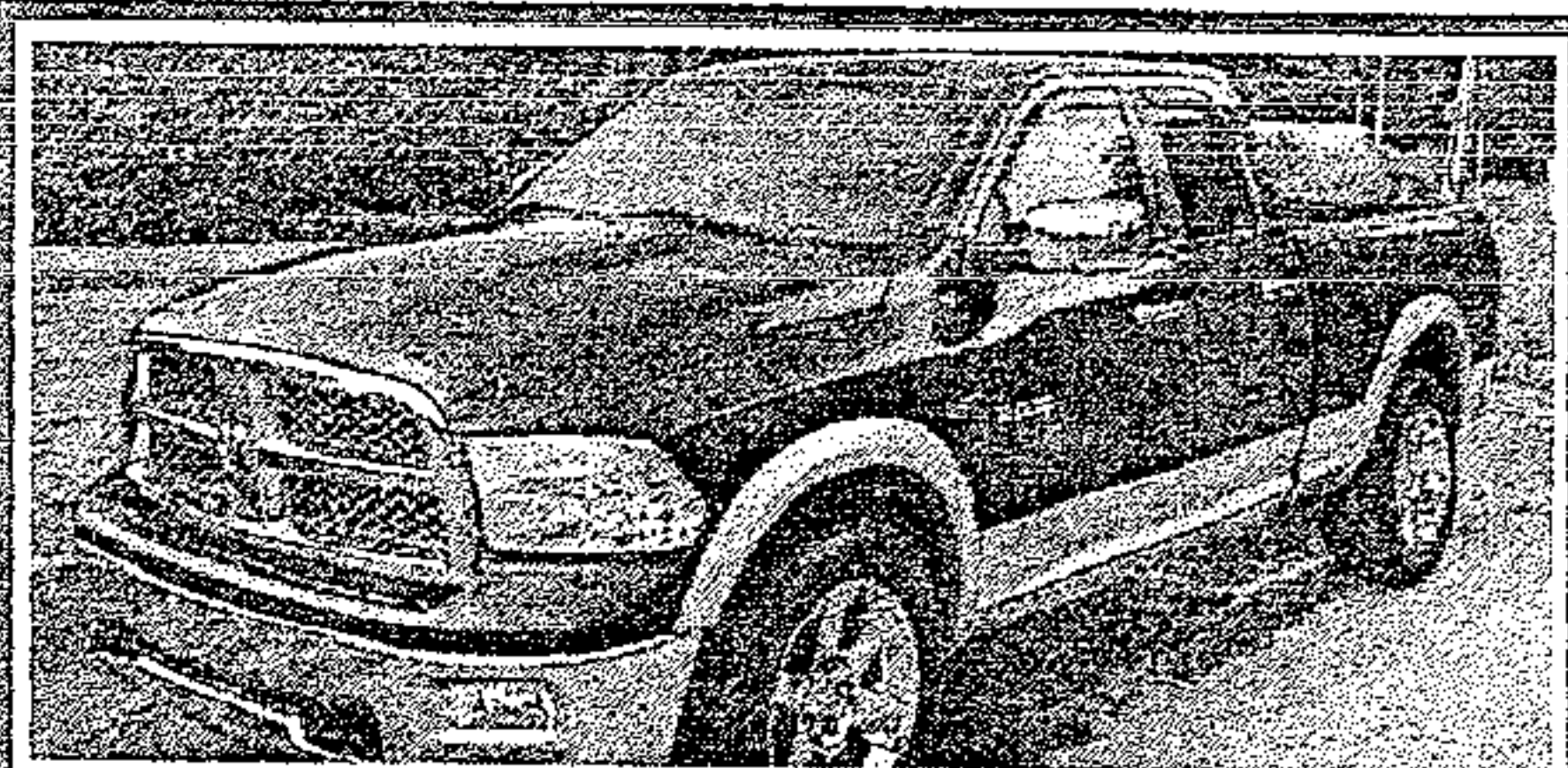

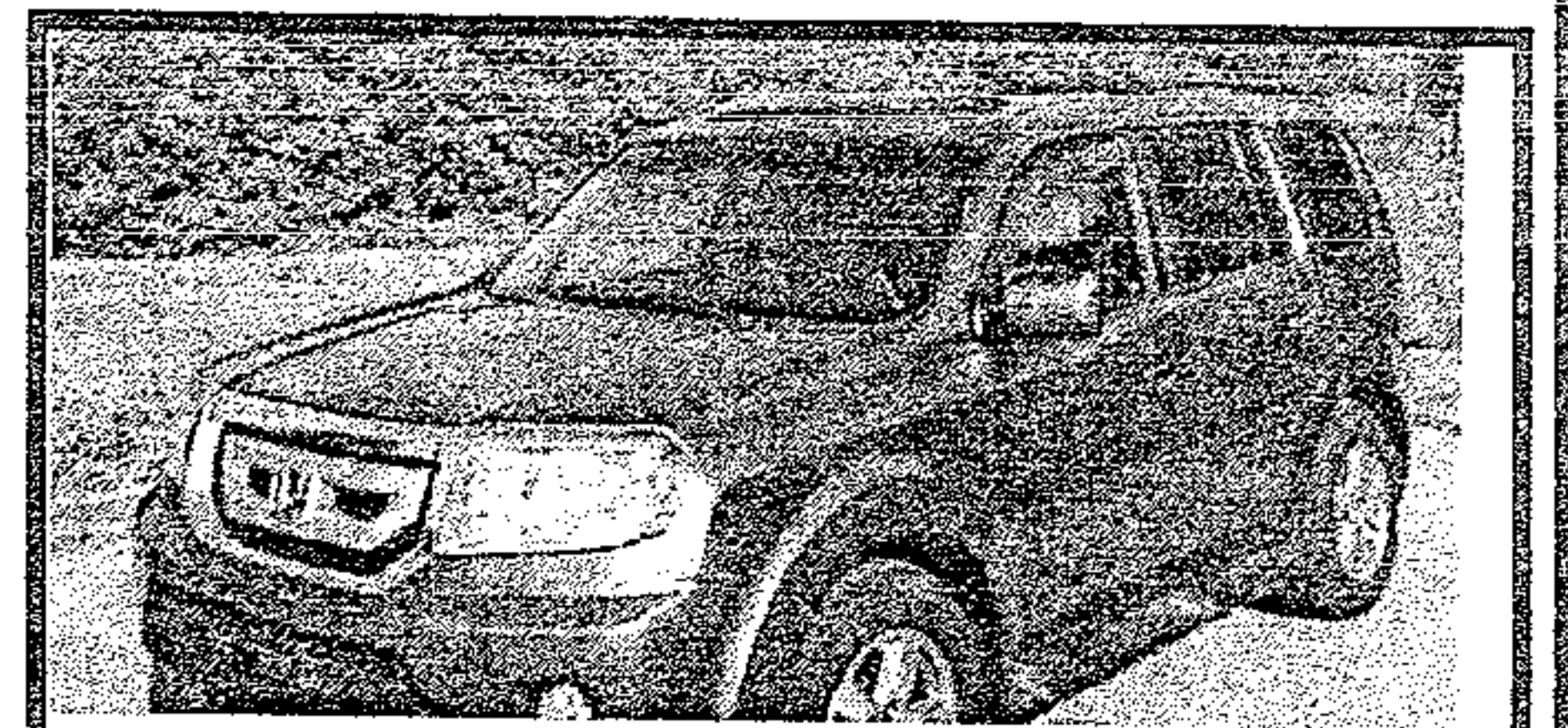

# Slippers

ago has been recovered, the FBI announced today.

The iconic sequined shoes, known as the "traveling pair"—one of at least four pairs used in the film that are still in existence—were stolen from the Judy Garland Museum in Grand Rapids, Minnesota in 2005 and recovered earlier this summer during a sting operation. But the case is far from over.

"From the outset," said Special Agent Christopher Dudley, who led the investigation from the FBI's Minneapolis Division, "our top priority was the safe recovery of the slippers." Although multiple suspects have been identified, Dudley said, "we are still work-

ing to ensure that we have identified all parties involved in both the initial theft and the more recent extortion attempt for their return. This is very much an active investigation."

Conservators at the National Museum of American History assisted the Minneapolis Division of the FBI in the case of ruby slippers from The Wizard of Oz that were stolen in Minnesota in 2005. The museum analyzed and compared the recovered slippers with a pair that has been part of the Smithsonian collection since 1979.

Judy Garland, who played Dorothy Gale in the classic fairy tale film enjoyed by generations of moviegoers around the world, wore several

pairs of the red slippers during the movie's production, dancing her way down the yellow brick road and, at the story's end, clicking her heels three times and repeating, "There's no place like home." The slippers are widely considered to be one of the most recognizable pieces of memorabilia in American film history, and are estimated to be worth several million dollars.

The star's childhood house in Grand Rapids was turned into a museum in 1975 and remains a repository of The Wizard of Oz artifacts and memorabilia. The slippers disappeared from there in the early morning hours of August 28, 2005, and the crime has weighed heavily on the community, whose identity is proudly associated with Garland's birthplace.

Despite a vigorous investigation by local authorities at the time, the slippers were not located, and no arrests were made. When the theft occurred, said Grand Rapids Police Department Chief Scott Johnson during today's announcement, "the thieves not only took the slippers, they took a piece of history that will be forever connected to Grand Rapids and one of our city's most famous children."

In the summer of 2017, 12 years after the theft, an individual approached the company that insured the slippers, saying he had information about the shoes and how they could be returned. "When it became apparent that those involved were in reality attempting to extort the owners of the slippers," Dudley explained, Grand Rapids police requested the

FBI's assistance. After nearly a yearlong investigation—with invaluable assistance from the FBI's Art Crime Team, the FBI Laboratory, and field offices in Chicago, Atlanta, and Miami—the slippers were recovered during an undercover operation in Minneapolis.

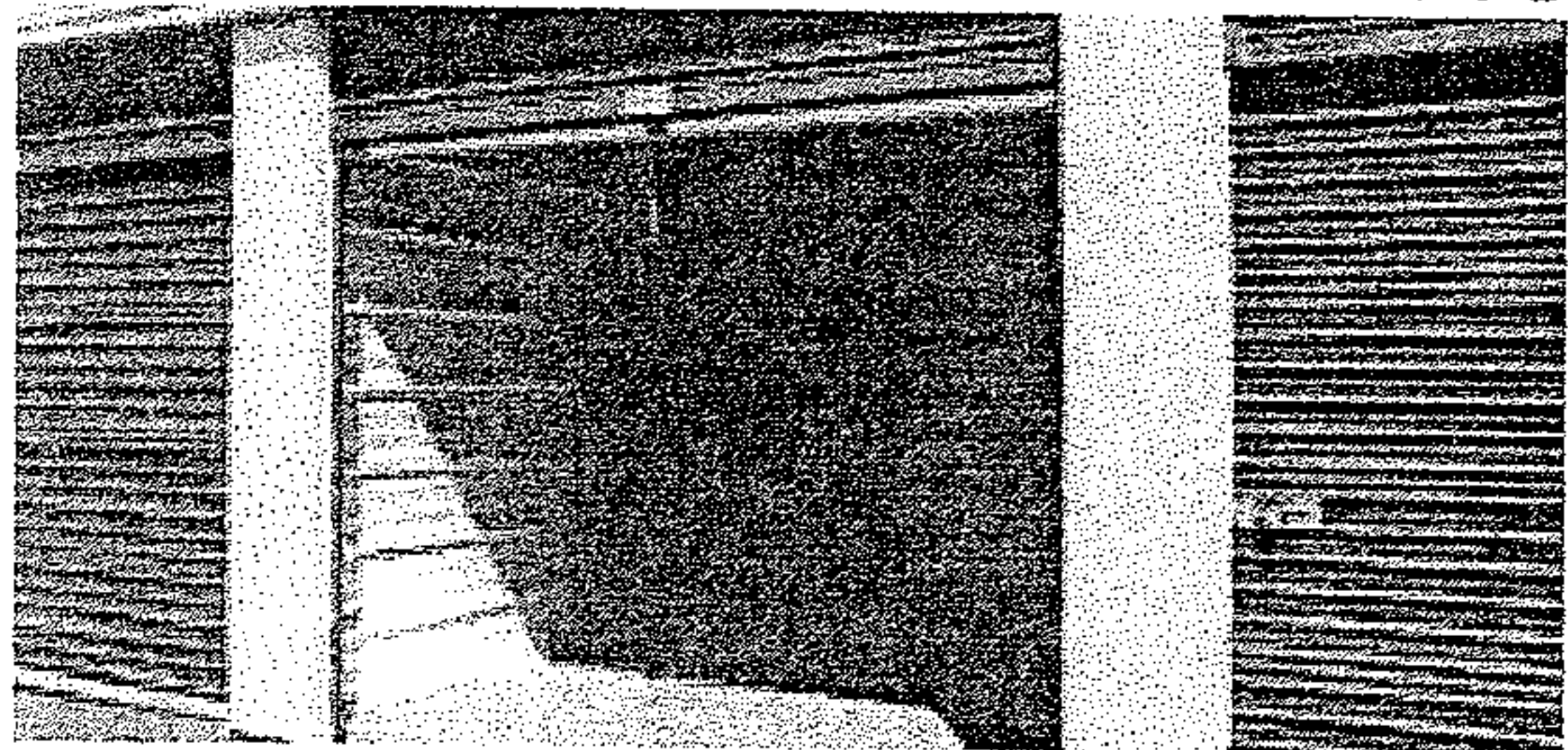

## DUI

Glen Cadieux, 57, Tuchaleechee Pike Maryville, was charged with DUI.

Officer was dispatched to a reckless driver, described as a dark colored four door car, in the area of Hwy 321 traveling Northbound from Blount County headed towards Lenoir City. Officer arrived in the area of Hwy 321 and Hwy 11 attempting to locate this vehicle.

While in the area Officer observed a dark colored Honda Civic stopped at the intersection with the high beams activated. The traffic control device located at the intersection of Hwy 321 and Hwy 11 changed from Red to Green and Officer observed this vehicle remain stopped at the intersection for a long period of time (proximately 15 seconds) before continuing through the intersection. Once this vehicle passed through the intersection the vehicle was traveling in the middle of two lanes of travel. This vehicle continued drifting from lane to lane. Officer initiated a traffic stop and this vehicle pulled into BB&T Bank, poorly parking the vehicle. Officer made contact with the driver, Glen Cadieux, who ap-

peared confused. Officer asked Mr. Cadieux if he had ingested any illegal narcotics or alcohol in which he stated he had not. Officer requested Mr. Cadieux to step out of the vehicle in order to perform Standard Field Sobriety Testing. Officer requested Mr. Cadieux to perform Modified Rhomberg in which he estimated 30 seconds to be 37 seconds. During lack of Convergence Mr. Cadieux eyes did not converge. Officer observed several clues on Horizontal Gaze Nystagmus. Due to safety concerns Officer did not request Mr. Cadieux to perform Walk and Turn or One Leg stand. Officer also observed Grass attached to the vehicle as well as front end damage to the bumper. It appeared Mr. Cadieux had traveled off the roadway into a field. Officer took Mr. Cadieux into custody and transported him to Fort Loudon Medical Center where he consented to provide a blood sample for chemical testing. Officer then transported Mr. Cadieux to Loudon County Jail and charged him with Driving Under The Influence. All the above occurred in Lenoir City, TN.

lier this summer during a sting operation.

Agents from the FBI's Minneapolis Field Office transported the recovered slippers to the Smithsonian Institution's National Museum of American History in Washington, D.C.—where another pair of the ruby slippers has been on display since 1979—for analysis and comparison.

Dawn Wallace, a Smithsonian conservator who has been working for the past two years to conserve the museum's ruby slippers, which are nearly 80 years old, said a careful analysis led to the conclusion that the recovered shoes were similar in construction, materials, and condition to the museum's pair. And it turns out the recovered shoes and the pair in the museum's collection are mismatched twins.

Smithsonian curator Ryan Lintelman, who specializes in American film history, explained that there were probably six or more pairs of the slippers made for The Wizard of Oz. "It was common that you would create multiple copies of costumes and props," he said. Somehow over the years, the pairs of shoes were mixed up.

Lintelman added that

the Smithsonian's ruby slippers "are among the most requested objects by visitors to the museum. There is an emotional response that visitors have," he said. "People's eyes light up." "Recovering a cultural item of this importance

is significant," the FBI's Dudley noted. "So many people of all ages around the world have seen The Wizard of Oz and in that way have some connection to the slippers. That's one of the things that makes this case resonate with so many."
