





make strategic investments to increase their efficiency, safety, and profitability.


With the survey responses, TDA plans to identify opportunities to improve cost share offerings and set

the vehicle. While officer was searching, Stanley Ingram did state to him that he did indeed steal/take a red Nike back pack from the Shoe Show that was in the back seat. At that time, a wallet was found in Stanley's possession belonging to victim. Sev-

eral items were found in the wallet like victim TN ID, social security card, insurance card, etc. Victim made a Theft report last night (yesterdays date) to officer Cole Morgan for the Theft of her wallet, credit cards, etc, with Stanley Ingram being the main suspect. Stanley also had a wallet in his right back

pocket with several other credit cards, one with the last four digits which was confirmed to be owned by victim which was used yesterdays date by several other subjects at Walmart in Lenoir City that was caught on camera. Stanley Trey Ingram was arrested for Theft, Fraudulent use of a Credit card, and Theft (shoe Show). Suspect was transported to Loudon County Jail without incident.

Terrell Johnson, 22, Patton Road Sweetwater, was charged with Man/Sell/Poss. Of Controlled Substance. Officer Cog-

The Tennessee Comptroller's Office, in conjunction with the United States Department of Transportation, Office of Inspector General, and the Tennessee Valley Authority Office of Inspector General, has completed a two-year investigation resulting in federal indictments against Diana Threadgill, the former executive director of Mississippi River Corridor – Tennessee, Inc. (MRCT).

MRCT was a 501(c)(3) nonprofit organization that was focused on economic development, land conservation, environment and wildlife preservation in six West Tennessee counties near the Mississippi River. The MRCT Board of Directors voted to dissolve the nonprofit on March 1, 2017. MRCT funded its operations through private donations and grants from federal and state agencies. Investigators reviewed 62 of MRCT's reimbursement requests and payments received from state and federal agencies. 57 of those reimbursements included unallowable costs according to state and federal laws and grant regulations.

In total, Comptroller investigators identified \$1,083,264 of improper reimbursements received by MRCT from March

2011 to March 2017. This included reimbursements for architectural and contracting services that were not properly bid, reimbursements that were supported with missing or falsified documentation, and reimbursements for personal expenses including meals, entertainment, fuel, and baby shower supplies. MRCT also doubled up on reimbursements by receiving payments from multiple grantors for the same expenses. Investigators noted \$176,196 in duplicate expenses submitted on various grants to various agencies that were subsequently paid to MRCT.

Comptroller investigators also determined that Threadgill instructed staff to falsify accounting records. She also continued MRCT operations after the board of directors voted to dissolve the nonprofit in March 2017, and she even requested and received additional funding in May 2017.

MRCT's failure to meet grant requirements has resulted in two abandoned and failed projects in West Tennessee. MRCT received public funding totaling \$856,685 for the Reelfoot Lake interpretive visitor center, which was demolished in October 2018. The Dyersburg River Park and Blueway project

cost \$357,275 and is currently abandoned. In February 2019, Diana Threadgill was indicted by a federal grand jury in the Middle District of Tennessee, Nashville Division, on three counts of mail fraud.

"This investigation points to multiple failures at many levels," said Comptroller Wilson. "The MRCT Board of Directors and Advisory Council members not only had potential conflicts of interest, but they failed to provide adequate oversight. State agencies must also do a better job of monitoring and reviewing how grant funds are reimbursed."
