

**Pedro Cortez-Gomez sentenced to serve 15 years in prison for conspiring to distribute methamphetamine**  
*Conspiracy centered in Greene County*


On April 29, 2019, Pedro Cortez-Gomez, 36, of Greeneville, Tennessee, a citizen of Mexico, was sentenced by the Honorable J. Ronnie Greer, Senior U.S. District Court Judge, to serve 15 years in federal prison for his role in a methamphetamine distribution conspiracy. Since Cortez-Gomez was residing in the United States illegally, he faces deportation after serving his sentence in federal prison. Cortez-Gomez pleaded guilty in January 2019 to conspiring with his girl-

## Knife

Kenneth Shackelford, 51, West Hills Drive Lenoir City, was charged with Aggravated Assault, and Domestic Assault x2.

According to the report, Officer Green LCPD, was dispatched to West Hills Drive in reference to a possible active domestic assault. Dispatch advised the complaint/victim ad-

vised the offender was armed with a knife and held it to one of the victim's throat.

Officer arrived on scene with Sgt. Rayfield and attempted to locate the offender Kenneth Shackelford, which had went to the basement and ran out the back door into the woods. Officer observed Shackelford laying in the woods and took him into custody.

Officer returned back to the residence and spoke with the victims which stated Shackelford had been drinking throughout the night when victim returned home. Shackelford began yelling at her asking for money, the other victims heard him yelling upstairs and went up to help the victim.

Once up stairs Victim observed Shackelford push the other victim against the door. One victim tried to help the other by trying to push him off the victim. Shackelford then pushed the other victim. At this time the 3rd victim arrived home and observed the altercation and became involved.

As one victim attempted to retrieve her cell phone from the bedroom and the other 2 victims attempted to keep Shackelford upstairs. Shackelford pushed the 2 victim and rushed towards victim one. After victim one called 911 Shackelford pushed victim 2 onto the couch where he retrieved a butterfly knife in which he held against victim's throat. Shackelford was aware law enforcement was close so he ran to the basement and out the back door into the woods. The knife was recovered from Shackelford's waist and id by all 3 victims. Kenneth Shackelford was transported to the Loudon Jail.

friend Kayla Leanne Reaves, 25, of Afton, Tennessee; Casey Hannah Howren, 27, of Elizabethton, Tennessee; and others, to distributing between 1.5 and 4.5 kilograms of actual methamphetamine or "Ice."

On April 22, 2019, Reaves was sentenced by Judge Greer to serve 41 months in federal prison for her role in the conspiracy. Sentencing for Howren is set for July 8, 2019.

Agencies involved in this investigation included Third Judicial District Drug Task Force, Greene County Sheriff's Department, Greeneville

Police Department, Elizabethton Police Department, Johnson City Police Department, Tennessee National Guard-Counterdrug Task Force, U.S. Immigration and Customs Enforcement-Enforcement and Removal Operations, FBI and ATF. Assistant U.S. Attorneys Christian Lampe and Robert Reeves represented the United States in court proceedings. The investigation is a result of the Department of Justice's Organized Crime and Drug Enforcement Task Force (OCDETF) program, the centerpiece of the Department of Justice's drug supply reduction strategy. OCDETF was estab-

lished in 1982 to conduct comprehensive, multi-level attacks on major drug trafficking and money laundering organizations. Today, OCDETF combines the resources and expertise of its member federal agencies in cooperation with state and local law enforcement. The principal mission of the OCDETF program is to identify, disrupt, and dismantle the most serious drug trafficking and money laundering organizations and those primarily responsible for the nation's drug supply.

with One World Circus, and run experiments in the Science Village with Dr. Hazari and The Muse. What's a festival without puppets? Cattywampus Puppet Council will be on hand to share their craft.

"We are really excited to launch our Read City USA program at the Festival this year. The Read to the Moon program encourages everyone to crack open some books over the summer," said Knox County Mayor Glenn Jacobs. "We are working with the schools, the library, and the community to elevate the importance of reading from birth. This is a community response to support our schools, who are doing a great job once students enter schools. The sad truth is, though, that only 40% of our third-grade students are reading on grade level. This is a call-out to all of us to be part of the solution."

Currently, Knox County schools rank

28 out of 144 Tennessee school districts in third grade reading rates. Summer reading programs help students retain their academic skills over the school break. Research shows that struggling students can lose as much as 1.5 years of academic progress between

grades 1 and 6 if they don't read over the summer. Furthermore, summer reading offers children and youth a chance to explore books that are of personal interest. Studies show that when readers are encouraged to choose their own books, they become stronger and more en-

gaged readers. The Children's Festival of Reading is made possible by the generous support of the National Endowment for the Arts, Friends of the Knox County Public Library, Humanities Tennessee, Tennessee Arts Commission, BCBST Community Trust, Knox County Public Library
