ical altercation. A baggie with a brown substance believed to be heroin was retrieved from Aikens pocket weighing .5 grams. Sgt. Bowen retrieved a baggie with a white crystal substance believed to be Crystal meth in a cigarette pack weighing 1 gram. Aikens did poorly on sobriety test, and was placed under arrest.

Reckless

Christina Devaney, 31, Dry Ridge Road Loudon, was charged with Driving on Revoked/Suspended License, Man/Sell/Del/Resale Sch. II, and Reckless Endangerment. Officer Bennie Houser LPD, was dispatched to a vehicle all over the roadway I75 southbound. The vehicle exited the interstate at the 72 exit. Officer

then got behind the vehicle, and engaged his emergency equipment on Hwy 72 in front of the Exxon and the vehicle continued to the Shell and stopped at the gas pump. Booze

Lenoir City Police Department is partnering with the Tennessee Highway Safety Office (THSO) for Booze It and Lose It from August 16th to September 3rd, surrounding. Booze It and Lose It is a statewide campaign to increase impaired-driving enforcement and reduce fatal crashes.

The Lenoir City Police Department will be conducting a sobriety check point on Friday August 23rd from 8pm to 10pm on Adesa Boulevard. The department will also be increasing enforcement during those dates focusing on impaired driving.

Increased state and national messaging about the dangers of drunk driving, coupled with increased sobriety checkpoints and high visibility enforcement, aim to drastically reduce the number of drunk-driving

crashes, injuries, and fatalities this year.

The consequences of a single DUI conviction for a first-time offender in the state of Tennessee may include costly fines, court costs, legal fees, jail time, mandatory drug and alcohol treatment, and/or the installation of an ignition interlock device in his/her vehicle.



War lo-launched, liquid propelled Intercontinental Ballistic Missile, or ICBM that carried a nuclear warhead; when launch it was specifically designed to fly to another continent. This rocket was stored in a hardened underground silo and was ready to launch at all times by military personnel also located in those underground silos. The rocket was developed at a time referred to as the "Cold War" between the United States and the former Soviet Union from the 1940s to about 1991. These rockets were set to launch only through some very interrogate and precise launch procedures and only through a very short chain of command. Jim Roger's military service involved him in that process where his training was so vital to a launch that only a few military

Commanders were between him and the President of The United States. At a recent American Legion meeting of Post 256, Mr. Rogers gave his fellow Legionnaires very explicate and detailed history of the method and proce-
