Hawkins County Resident Arrested for Tax Evasion

The Special Investigations Section of the Tennessee Department of Revenue conducted the investigation that led to the indictment and Tuesday arrest of Jon Phillip Gardner. His bond is set at \$5,000.

On August 17, 2020, the Hawkins County Grand Jury indicted Gardner on two felony

counts of tax evasion. These charges stem from Gardner providing false and fraudulent information to the Hawkins County Clerk's Office regarding his registration of a boat and an ATV. If convicted, Gardner faces a maximum of two years and fined \$3,000 for each count of tax evasion.

"The Department of Revenue promotes voluntary taxpayer compliance by educating taxpayers, aggressively pursuing criminal sanctions and demanding accountability when taxpayers engage in fraudulent activity," said Revenue Com-

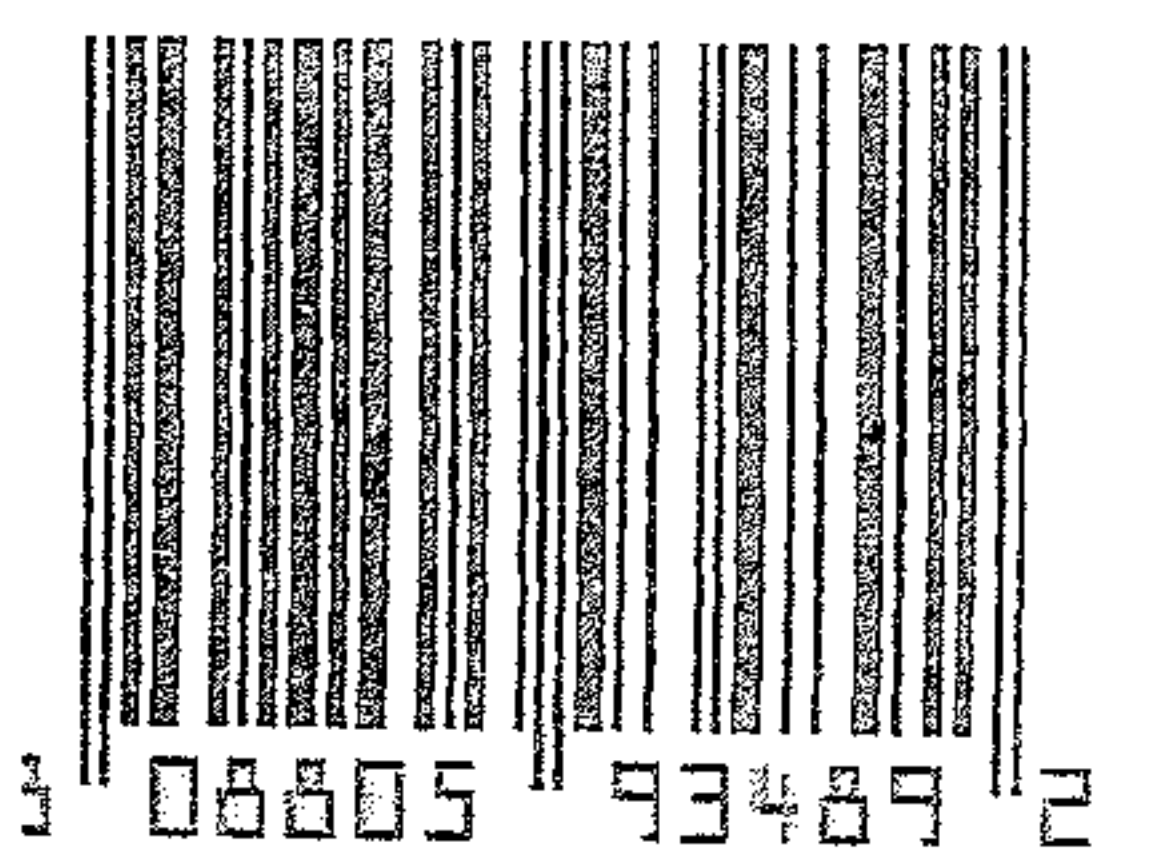

Ryan Jordan, 35, Pardue Lane Lenoir City, was charged with Aggravated Burglary, Poss. Of Burglary Tools, Theft, and Poss. Of a Firearm.

Jeremy Wample, 37, Rawhide Trail Lenoir City, was charged with Aggravated Burglary, Theft, and Poss. Of Burglary Tools.

Sgt. Detective Jerramie Bowen did respond to Browder Hollow Rd. Lenoir City on a suspicious vehicle. Cpl. Jenkins, Cpl. Smith, Deputy Swinney and Deputy Parks were already on scene. Cpl. Jenkins stated that when he arrived he did find that the back door to the residence was open and he announced himself. At that time there were 2 individuals stated that they were inside the residence. They did come out the back door and they made contact with them and later identified them as Ryan Jordan and Jeremy Wample.

Cpl. Jenkins asked if they were supposed to be there and they did not say anything at the time and Cpl. Jenkins replied he take that as a no. Wample and Jordan then stated they were there uninvited. Deputy then read Mr. Wample his

rights and he did sign a wavier. He did talk to Deputy and state that he did not live there and that he had went in the back door and walked around for about 30 minutes until Deputies arrived and found them inside. Deputy read Mr. Jordan his rights and he did also sign a waiver.

Deputy then asked if he lived there and he also stated no and that he went in the back door and was there about 15-30 minutes until Deputies arrived and found them inside the residence.

Both offenders stated that they were looking for a homeless subject and Mr. Jordan did state that they had been in 3 or 4 houses before this one. Deputy asked Mr. Jordan if he took anything from the residence and he stated that he had taken .30 cents and that is was on the hood of his van.

Deputy asked Mr. Jordan if he could search his vehicle and he did give verbal consent. Deputy did find a black bag containing 2 two way radios along with rubber gloves and binoculars and a flat head screwdriver in the door pocket.

All the items located are consistent with burglary tools.

Deputy then asked Mr. Jordan who the backpack belonged to and he stated that it was his. Deputy then asked if he could pat Mr. Jordan down and he stated yes but was hesitant and Deputy asked if he had any weapons and he stated that he had a firearm on his right hip in his waistband. Deputy did retrieve the firearm and it was loaded. There was evidence of forced entry that was consistent with a screwdriver to pry the back door open. The homeowner did state that no one was supposed to be there and that the door was secure when she left the residence.

Deputy then placed both subjects under arrest for Aggravated Burglary Possession of Burglary tools and Theft. Mr. Jordan was also charged with Possession of a weapon during a dangerous felony. This did occur in Loudon County.

Christopher Smith, 25, Whitney Avenue Lenoir City, was charged with Man/Sell/Del/Resale Sch. IV x2, III, Public Intoxication, and Poss. Of Drug Para. Officer S. Runyan LCPD, was dispatched to the Kenjo on Hwy 321 to a call of a male inside the store that was under the influence and stumbling. The caller stated the male drove a Chevy and it is parked in front of the gas pumps. Officer arrived on scene and observed a male in the store very unsteady on his feet and slurring his words. The male was identified as Christopher Smith, and placed him under arrest for PI. A inventory of the vehicle was completed before tow, and Officer located the following items inside the vehicle: a black backpack

with 49 yellow pills believed to be clonazepam, 11 green pills believed to be alprazolam, and 60 buprenorphine subtext were located inside the backpack. Christopher Smith was transported to the Loudon County Jail.

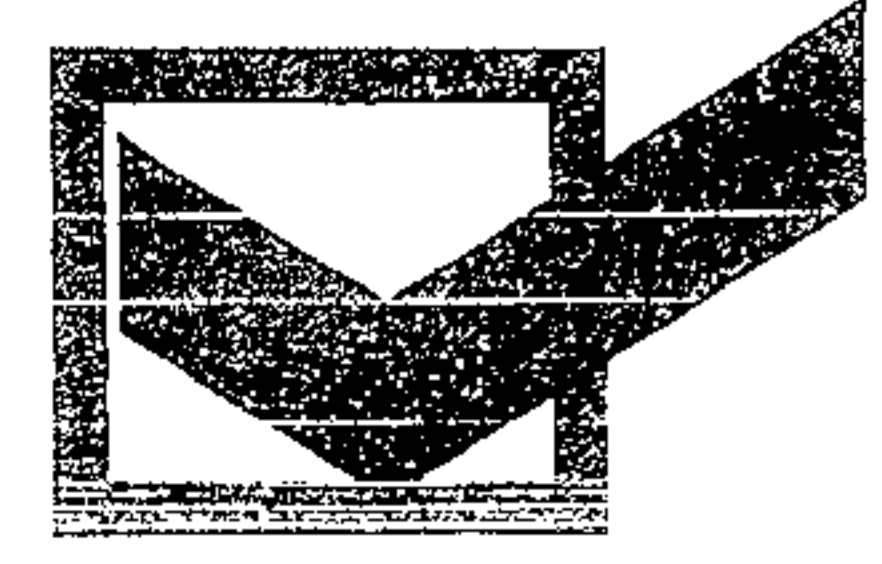

Tiffany Tate, 31, Old Callahan Drive Knoxville, was charged with Theft of Property, Simple Possession, Contraband in a Penal Institution, Man/Del/ Sale of Meth, Possession of Drugs. Officer C. Espinoza LCPD, was dispatched to Walmart regarding a shoplifter that loss prevention had in custody. Loss Prevention advised Officer that he observed Tiffany Tate deprive and conceal merchandise, and walked out without paying for items. While interviewing the female identified as Tiffany Tate dispatch advised Officer she had an active warrant out of Roane County. Tate was placed under arrest and transported to the Loudon County Jail. While at the jail Deputy Hatfield performed a body cavity search and discovered a baggie containing approx..

1.6 grams of cocaine inside Tate private area. Minutes later Deputy Harrison was clearing the restroom after the search and Tate was the only one in there located a baggie weighing approx.. 4.9 grams of meth. Both drugs were tested and confirmed by Thermo Scientific Trunarc Analyzer.



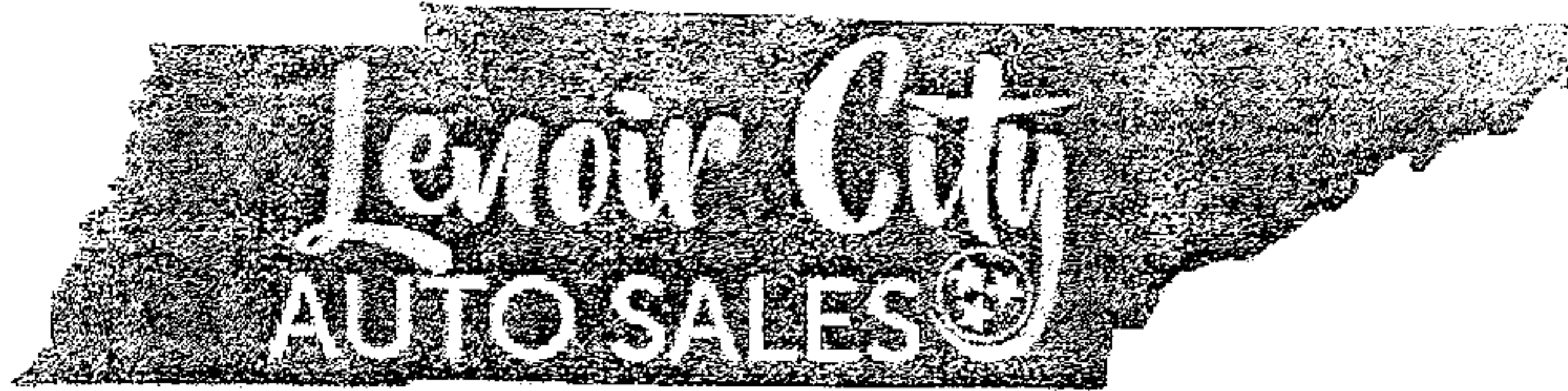


