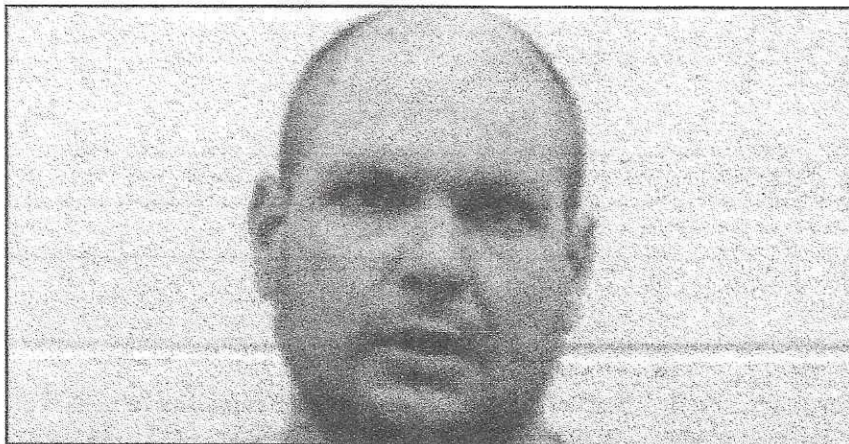

Otis Elevator Company Agrees to Pay More Than \$600,000 to Settle False Claims Act Allegation Related to Invoices for Elevator Maintenance

Otis Worldwide Corporation, an international elevator services firm headquartered in Farmington, Connecticut, which is branded and doing business as Otis Elevator Company (Otis), has agreed to settle allegations under the False Claims Act (FCA) related to invoices for preventive maintenance services

submitted to the Tennessee Valley Authority (TVA) that were not rendered pursuant to the terms of a Contract. Under the settlement, Otis will pay the United States \$616,987.02.

"A contractor, like Otis, has an obligation to submit invoices and seek reimbursement solely for work and services that have

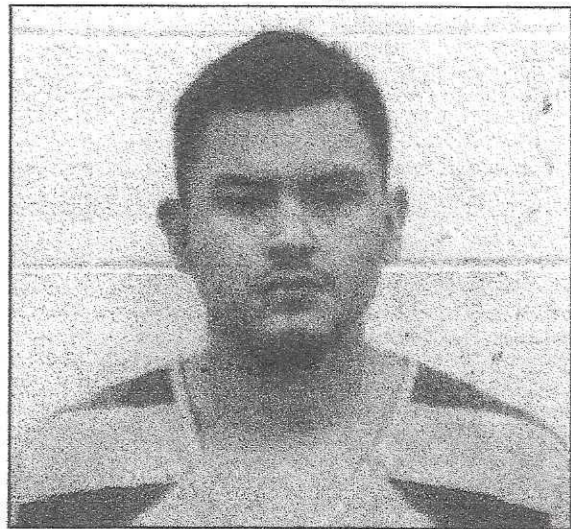

Cody Hamilton, 28, East Coast Tellico Parkway Greenback, was charged with, Criminal Trespassing, Resisting Arrest, and Assisting other Agency.

Deputy B. McCall, responded to East Coast Tellico Parkway regarding a trespassing complaint. Upon arrival, the deputy made contact with the victim and property owner, who reported ongoing issues with her neighbor, Cody Hamilton. She stated that on the evening of 06/09/2025, Mr. Hamilton was in his yard shouting obscenities and firing a gun while yelling, "Shots fired." Shortly afterward, she discovered one of her rear property cameras displaced and lying near the end of her driveway—approximately a quarter mile from its original

position. The victim provided video footage of the incident. While Mr. Hamilton's full body wasn't visible, his distinctive brown leather cowboy boots—marked with black electrical tape on the toes—were clearly seen. She noted that Loudon County deputies previously responded and took a report. The victim further reported that around 0700 hours on 06/10/2025, shortly after her husband left for work, Mr. Hamilton again shouted obscenities and appeared to fire a gun. She recorded the incident but was unable to capture a clear image of the suspect or weapon. Later that morning, while tending to her farm, the victim discovered approximately 250 feet of cable fencing—used to contain her horses—had been cut near the same area as the displaced camera. Due to pre-

vious damage to her camera system, she couldn't record the act itself, but footage did capture the suspect from the waist down. The individual wore blue jeans and the same brown boots with black tape. The victim confirmed that the individual was on her property without consent and stated she wished to press trespassing charges. Corporal Sartin, Sergeant Smith, Deputies Lewis, Parks, and McCall attempted contact with Mr. Hamilton at his residence. Though he was heard inside, he refused to answer the door. It was confirmed Mr. Hamilton had an active warrant for Failure to Appear on a domestic assault charge out of Blount County. At the time of this report, the victim were installing new security cameras. Deputy Lewis and McCall remained on

scene for further monitoring. While at the rear of the residence with the victim and their two minor children, a loud "pop" believed to be a gunshot was heard coming from Hamilton's property. Deputies moved toward the front of the property to investigate. While standing near the victim's barn, Deputy Lewis observed Mr. Hamilton walking to his mailbox. Cpl. C. Bengel and Sgt. B. Smith intercepted him and, after a brief struggle, took him into custody. At the time of arrest, Hamilton was wearing the described brown boots with black tape. Priority EMS responded to evaluate Mr. Hamilton, but he refused treatment. The deputy transported him to the Loudon County Detention Center without further incident.

been performed as claimed," said U.S. Attorney Francis M. Hamilton III for the Eastern District of Tennessee. "This settlement with Otis demonstrates that the United States Attorney's Office and federal partners like TVA's Office of the Inspector General are using all tools available to address fraud, waste, and abuse and protect public funds."

"The TVA Office of the Inspector General is committed to identifying and investigating instances where vendors fail to fulfill contractual obligations as well as false claims and overpayments that negatively impact ratepayers throughout the Tennessee Valley. We would like to thank the United States Attorney's Office for their dedicated support of such efforts," said Assistant Inspector General, Investigations D. Eric Beals of the Tennessee Valley Authority Office of Inspector General.

The United States' investigation focused on an August 2017 Contract between Otis

and TVA. The United States contended that the Contract required Otis to provide turn-key modernization and specified monthly preventative maintenance services related to certain elevators in the TVA Knoxville Office Complex. The United States maintained that it has certain civil claims against Otis arising from its performance of the Contract. Specifically, the United States contended that Otis submitted false claims for payment to TVA for preventive maintenance services that were not rendered.

The resolution obtained in this matter was the result of a coordinated effort between the United States Attorney's Office for the Eastern District of Tennessee and the TVA Office of the Inspector General – Office of Investigations (TVA-OIG).

The investigation and resolution of this matter illustrates the government's emphasis on combating waste, fraud, and abuse impacting federal agencies. One of the most powerful tools in this effort is the False Claims Act. Tips and

Commissioner Andy Holt, and State Forester Heather Slayton were joined by State Representatives Renea Jones and Rebecca Alexander in Unicoi and Washington Counties.

The visit underscored the state's commitment to supporting farmers and forest landowners as they continue to recover and rebuild from the storm, which hit the region in September 2024.

"We're dedicated to helping our agricultural community repair the damage caused by Tropical Storm Helene and restore their operations," Hatcher said. "Seeing the damage and hearing from those affected helps us understand the full scope of their needs. We're also actively pursuing additional federal funding to ensure no one is left behind in this recovery."

TDA has petitioned USDA's Farm Service Agency for a block grant to cover losses caused by Tropical Storm Helene. TDA is working with state and federal partners on solutions for losses not covered by insurance or aid programs.

In Unicoi County, they visited Miller Farm, Hilemon Ranch, Willis Family Farm, Lipman Family Farms, and Shelton-Rice Forest. In Washington County, they visited Scott's Strawberry and Tomato Farm and Chris Renfro's farm.

Hurricane Helene's economic impact to Tennessee farmers and forestland owners is now estimated at \$547 million to \$1.8 billion. This includes farm and residential structure losses, fencing and non-building infrastructure losses, direct and indirect losses, debris and damaged structure removal, and long-term reclamation across

more than 150,000 acres in Carter, Cocke, Grainger, Greene, Hamblen, Hawkins, Johnson, Unicoi, and Washington Counties.

The Tennessee Department of Agriculture Division of Forestry estimates a loss of 74,238 cubic feet of timber valued at \$59,902,544.

The state of Tennessee has taken a multi-pronged approach to help the recovery efforts. Governor Bill Lee and the Tennessee Emergency Management Agency

created the Governor's Response and Recovery Fund, a \$100 million initiative to provide flexible financial assistance for current and future unmet disaster recovery needs, including those caused by Tropical Storm Helene. Recipients of the first round of funding will be notified in July.

UTIA is hosting a free field day for farmers, producers, and citizens who need strategies and solutions for
