Pakistani National Extradited to Face Charges in Connection with Plot to Carry Out ISIS-Inspired Mass Shooting at Jewish Center in New York City

A Pakistani citizen residing in Canada, Muhammad Shahzeb Khan, 20, also known as Shahzeb Jadoon, was extradited to the United States on June 10, in connection with an indictment filed in the Southern District of New York. Khan was charged with attempting to provide material support and resources to a designated foreign terrorist organization (FTO), the Islamic State of Iraq and al-Sham (ISIS) and attempting to commit acts of terrorism transcending national boundaries. Khan is scheduled to make an initial appearance in court on June 11.

"The foreign terrorist organization ISIS remains a clear and

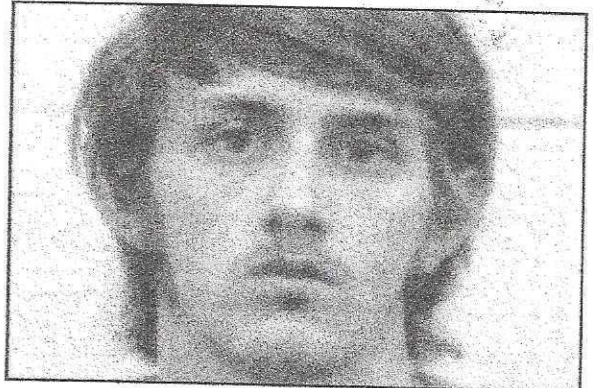

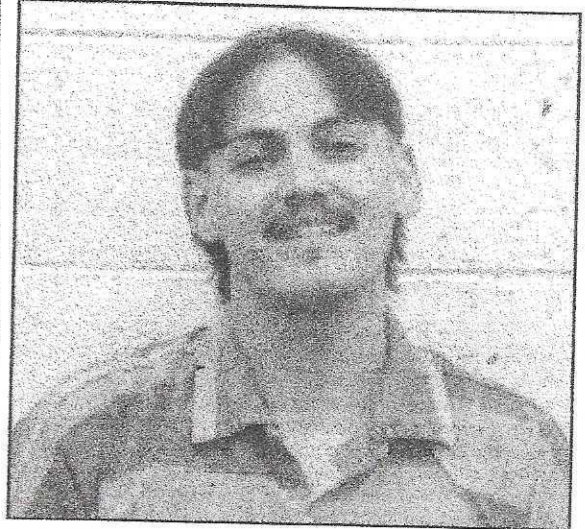

Johnny Beason, 24, Meadow Spring Place Rockwood, was charged with, DUI, License Required, Seatbelt Law, and, Prohibited Use of Wireless Telecommunication Devices or Stand-alone Electronic Devices.

Trooper Montgomery THP, was on patrol in the area of I-40 E at the 365 MM when he observed a gray Fiat bearing TN registration 817BPF traveling eastbound. The driver was visibly using a cellphone in his right hand. The trooper advised dispatch and a traffic stop was initiated. Using his troop car lights and sirens, the trooper conducted the stop. Upon approach of the vehicle, the driver had glossy, watery eyes, disheveled clothing, and had his seatbelt buckled behind him-

self and his seat. The trooper explained the reason for the traffic stop and asked for the driver's license, registration, and insurance. The driver was fumbling with his phone and papers in the car and stated that he did not have his wallet. He was slurring his words and making exaggerated motions with his arms. The driver presented the trooper with the vehicle registration and his Social Security Number. A query of the information confirmed the driver's identity as JOHN-NY D. BEASON. On the second approach, Mr. Beason showed the trooper his insurance policy information on his phone, and the trooper asked him to step out of the vehicle. He was frisked for weapons and gave consent to be searched. During the investigation, Mr. Beason admitted to drinking four beers

and having two shots around two and a half hours before our interaction. I asked Mr. Beason for consent to perform Standardized Field Sobriety Tests, and he obliged. During HGN testing, Mr. Beason exhibited, in both eyes, lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and onset of nystagmus prior to 45 degrees. During the walk and turn test, he could not maintain balance during the instructional phase and missed heel to toe, as well

as stepped offline multiple times. On the One-Leg Stand, Mr. Beason swayed and put his foot down numerous times. Mr. Beason tested poorly and was deemed too impaired to operate a vehicle. He was arrested, handcuffed, and placed in the right rear of the trooper patrol vehicle. Mr. Beason is being charged with driving under the influence, hands-free, no seatbelt, and failure to exhibit driver's license. All set events occurred in Loudon County, Tennessee.

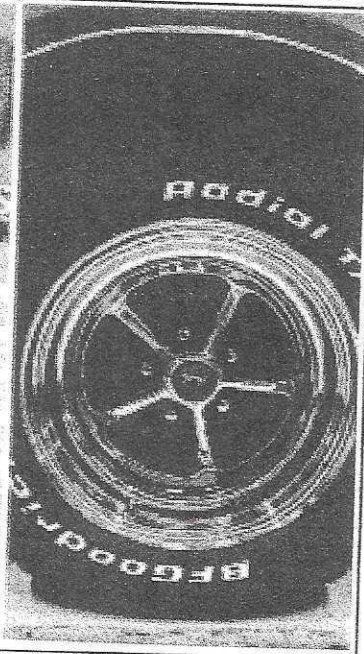

present danger to the American people, and our Jewish citizens are especially targeted by evil groups like these," said Attorney General Pamela Bondi. "The Department of Justice is proud to help secure this extradition, and we will prosecute this man to the full extent of the law."

"Khan allegedly tried to enter the United States to commit an attack on the Jewish community in New York City, planning an ISIS-inspired mass shooting around the one-year anniversary of the attack on Gaza by Hamas," said FBI Director Kash Patel. "Thankfully, the great work of the FBI and our partners shut that down, and Khan has now been extradited to New York to face American justice. I want to thank our teams and partners for their diligent work in this case and executing the mission."

"As alleged, Muhammad Shahzeb Khan attempted to enter the United States to carry out a deadly terrorist attack on a Jewish center in New York City," said U.S. Attorney Jay Clayton for the Southern District of New York. "He planned to use automatic weapons to kill as many members of our Jewish community as possible, all in support of ISIS. Khan's deadly, antisemitic plan was thwarted by the diligent work of our law enforcement partners and the career prosecutors in this Office who are committed to rooting out antisemitism

and stopping terror. Thanks to their efforts, Khan will now face justice in New York."

Khan was provisionally arrested in Canada on Sept. 4, 2024 based on a complaint filed in the Southern District of New York. As alleged in the complaint, Khan, who resided in Canada, attempted to travel from Canada to New York City, where he intended to use automatic and semi-automatic weapons to carry out a mass shooting in support of ISIS at a Jewish center in Brooklyn, New York. Khan began posting on social media and communicating with others on an encrypted messaging application about his support for ISIS in or about November 2023, when, among other things, Khan distributed ISIS propaganda videos and literature. Subsequently, Khan began communicating with two undercover law enforcement officers (collectively, the UCs).

During those conversations, Khan confirmed that he and a U.S.-based ISIS supporter (Associate-1) had been planning to carry out an attack in a particular U.S. city (City-1). Among other things, Khan said that he had been actively attempting to create "a real offline cell" of ISIS supporters to carry out a "coordinated assault" in City-1 using AR-style rifles to "target[] Israeli Jewish chabads . . . scattered all around [City-1]." During subsequent conversations, Khan repeatedly instructed the UCs to obtain AR-style assault rifles, ammunition, and other materials to carry out the attacks, and iden-

tified the specific locations in City-1 where the attacks would take place. Khan also provided details about how he would cross the border from Canada into the United States to conduct the attacks. During these conversations with the UCs, Khan emphasized that "Oct 7th and oct 11th are the best days for targeting the jews" because "oct 7 they will surely have some protests and oct 11 is yom.kippur."

On or about Aug. 20, Khan changed his target location from City-1 to New York City. After initially suggesting certain neighborhoods in New York City to the UCs, Khan decided to target Location-1, a Jewish center located in Brooklyn, New York. Khan told the UCs that he planned to carry out this attack on or around Oct. 7, 2024 — which Khan recognized as the one-year anniversary of the brutal terrorist attacks in Israel by Hamas, a designated FTO, which, on Oct. 7, 2023, launched a wave of violent, large-scale terrorist attacks in Israel. In support of his choice of New York City as his target location, Khan boasted that "New york is perfect to target jews" because it has the "largest Jewish population In america" and therefore, "even if we dont attack a[n] Event[,] we could rack up easily a lot of jews." Khan proclaimed that "we are going to nyc to slaughter them," and sent a photograph of the specific area inside of Location-1 where he planned to carry out the attack.

Thereafter, Khan continued

to urge the UCs to acquire AR-style rifles, ammunition, and other equipment for his attack, including "some good hunting [knives] so we can slit their throats." Khan repeatedly reiterated his desire to carry out the attack in support of ISIS, and discussed planning for the attack, including by identifying rental properties close to Location-1 and paying for a human smuggler to help him reach and cross the border from Canada into the United States. During one communication, Khan noted that "if we succeed with our plan this would be the largest Attack on US soil since 9/11."

On or about Sept. 4, as Khan said he planned to do in connection with his attack, Khan attempted to reach the U.S.-Canada border. To do so, Khan used three separate cars to travel across Canada towards the United States, before he was stopped by Canadian authorities in or around Ormstown, Canada, approximately 12 miles from the U.S.-Canada border.

Khan is charged with one count of attempting to provide material support and resources to a designated foreign terrorist organization and one count of attempting to commit acts of terrorism transcending national boundaries. If convicted, he faces a maximum sentence of life in prison. A federal district court judge will determine any sentence after considering the U.S. Sentencing Guidelines and other statutory factors.

Caden Slessor, 23, Coffee Lane Loudon, was charged with, Driving on Revoked/ Suspended License.

Officer Luke Hawkins LPD, was traveling in the 2400 block of River Road when he observed a black motorcycle traveling in the opposite direction. It appeared to be traveling above the posted 30 mile an hour speed limit. The officer looked at his patrol mounted radar and it indicated the motorcycle was traveling 50 mph. The officer then activated his lights and conducted a traffic stop on the black Suzuki, bearing the Tennessee registration 76196K. The officer identified the driver as Caden Slessor who advised the officer his license was revoked. The officer confirmed this with Dispatch. The officer then placed him into custody for driving on a revoked

license for DUI. The officer issued a verbal warning for the speeding violation and allowed the subjects father and brother to come retrieve the motorcycle. The officer then transported him to The Loudon County Jail without incident. All the above did occur in Loudon, Tennessee.

family. The Sackler family has also informed the attorneys general of its plan to proceed with the settlement, which would resolve litigation against Purdue and the Sacklers for their role in creating and worsening the opioid crisis across the country. Now that the state sign-on period has concluded, local governments across the country will be asked to join the settlement contingent on bankruptcy court proceedings.

"No sum of money can ever fix the devastation in-

flicted by Purdue Pharma and the Sackler family," said Attorney General Skrmeti. "Our office has delivered hundreds of millions of dollars to the Opioid Abatement Council. We will continue our fight to hold accountable those companies responsible for the crisis and work to support Tennessee communities victimized by the opioid epidemic."

Under the Sacklers' ownership, Purdue manufactured and aggressively marketed opioid products for decades, fueling the largest drug crisis in the nation's history. The

settlement ends the Sacklers' control of Purdue and their ability to sell opioids in the United States. Communities across the country will directly receive funds over the next 15 years to support addiction treatment, prevention, and recovery. This settlement in principle is the nation's largest settlement to date with individuals responsible for the opioid crisis. Tennessee is expected to receive more than \$90 million from this settlement over the next 15 years.

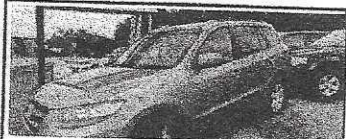

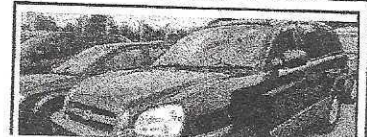

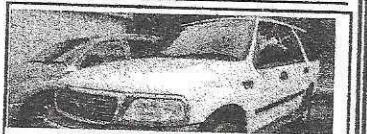

Most of the settlement funds will be distributed in the first three years. The Sacklers will pay \$1.5 billion, and Purdue will pay roughly \$900 million in the first payment, followed by \$500 million after one year, an additional \$500 million after two years, and \$400 million after three years.

Like prior opioid settlements, the settlement with Purdue and the Sacklers will involve the resolution of legal claims by state and local governments.

Christopher Goodman, 21, Seed Tick Road Loudon, was charged with, Mfg/Del/Sale or Poss. of Meth, Simple Possession, and Poss. of Drug Para.

Officer R. Miller, with the Lenoir City Police Department, was at the intersection

of Highway 321 and Highway 11 in Lenoir City, TN. While in the area he observed a gray in color Nissan sedan traveling west on Broadway (Highway 11). While observing the vehicle the officer visually observed that both the driver and front seat passenger were not wearing a seat-belt while the vehicle was in motion on a public roadway. The officer then initiated a traffic stop on the vehicle in the area of Cherry Street near Sonic and Clicks Funeral Home. Upon the traffic stop the officer made contact with the driver who was identified as a female and the front seat passenger who was identified as Christopher Goodman. While speaking with both subjects the officer noticed an odor of marijuana emitting from inside of the vehicle. The officer then had the driver step out

of the vehicle to speak with her further about a citation. While speaking with the female the officer had an additional unit arrive on scene where he then had GOODMAN step out of the vehicle to conduct a probable cause search of the vehicle. During the subsequent search of the vehicle, the officer located a grey/black sock underneath the front passenger side seat. Contained inside of the sock was a small bag containing a crystal-like substance believed to be methamphet-

amine (approx. 0.50 grams) along with a white container that contained a green leafy substance believed to be marijuana which was rolled up in rolling paper (approx. 0.86 grams). Also located in the sock was a glass pipe that had a charred bottom, which is commonly used to smoke methamphetamine with. The said items were located under the seat in which GOODMAN was sitting. GOODMAN was placed under arrest and transported to the Loudon County Jail.

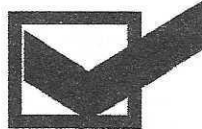
