

#### Texas Man Charged Federally for Receipt and Transport of Explosives Intended for **Use Against Law Enforcement**

A Texas man is facing federal charges after allegedly purchasing powerful explosives in New Mexico and expressing plans to use them to harm law enforcement officers and government officials during riots in California.

According to court documents, on June 12, 2025, Grzegorz Vandenberg, 48, visited a travel center in Lordsburg, New Mexico. to purchase fireworks. During the transaction. Vandenberg requested assistance in selecting

fireworks that could be thrown directly at people to cause harm. He told store employees that he was prior special forces military and claimed he could make pipe bombs. Vandenberg further stated that he was traveling to Los Angeles, California, for the riots, with the intent to kill law enforcement officers or government officials.

"This man allegedly intended to use the chaotic riots in Los Angeles as



Christian Marquez Ruiz, 32, Homeless Loudon, was charged with, DUI, Violation of Implied Consent, Driving on Revoked/Suspended License, and Littering.

Officer H. Wilkes LCPD, was conducting routine patrol on Reeves St and was traveling behind a gray Chevrolet, bearing Tennessee registration, 018BLLH. The officer observed the driver of the vehicle, later identified as Christian Marquez Ruiz, intentionally throw a glass bottle out the passenger side of the vehicle. The glass bottle was later determined to be 'Moscato Seven Daughters' (750 mL -7.5% alc.). In addition, the vehicle being operated displayed an expiration date of April, 2025. The officer conducted a traffic stop on the vehicle near the Lenoir City Middle School - Harrison Ave, and ap-

proached Mr. Marquez Ruiz. While speaking with him, the officer observed his speech to be slurred and his eyes to be glossy, pinpoint pupils, and the odor of an alcoholic beverage emitting from his person. Mr. Marquez Ruiz stated that he consumed approximately half a bottle of alcohol the night prior. The officer ran Mr. Marquez Ruiz's drivers license through Central Dispatch, where it was found that his license status was suspended. Mr. Marquez Ruiz was asked to exit the vehicle and to perform SFST's, to which he consented During HGN, the officer observed lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and onset of nystagmus prior to 45 degrees in both eyes. During the Walk & Turn, the officer observed him to stop while walking, step off of the line, and perform the incorrect number of steps.

During the One Leg Stand, the officer observed him to sway, utilize his arms for balance. and to hop several times. Due to the aforementioned, the officer placed Mr. Marquez Ruiz into my custody. Mr. Marquez Ruiz was read the Tennessee Implied Consent, where he refused to provide a blood sample. Mr. Marquez Ruiz was therefore transported to the Loudon County Jail, and his vehicle was towed per Money Makers Wrecker Service. All of the above did occur in

Lenoir City, Loudon County, Tennessee.

an opportunity to commit deadly violence against law enforcement officers," said Attorney General Pamela Bondi. 'Threats like these strike at the heart of law and order — we will not hesitate to bring federal charges against anyone who seeks to harm law enforcement or endanger the safety of our communities."

"Our message is clear: If you come after law enforcement officers, the FBI will spare no effort to find you and bring you to justice," said FBI Director Kash Patel. "This defendant allegedly intended to use explosives to attack police officers currently conducting law enforcement operations in Los Angeles and — with the help of a store cashier who took down

his license plate information - we were able to put a stop to that plan. Law enforcement officers put their lives on the line to serve the American people and the FBI will always do our part to protect them."

"Targeting law enforcement with violence is not protest — it's a crime," said U.S. Attorney Ryan Ellison for the District of New Mexico. "Anyone who attempts to harm officers or undermine public safety will be held accountable. Protecting the safety of our communities and upholding the integrity of lawful demonstrations are priorities, and those who cross the line into violence will be prosecuted swiftly and to the fullest extent of the law."

Store staff reported that Vandenberg asked for the largest explosives available and invited

an employee to join him and his platoon in California. He also claimed to have mortar explosives in his possession and reiterated his plan to use them at the riots to kill officers. Vandenberg purchased six mortars, each containing 60 grams of gunpowder, and 36 large fireworks before leaving the store in a vehicle with Montana license plates, heading west on Interstate

Vandenberg is charged with transporting explosives in interstate commerce with the knowledge and intent that they would be used to kill, injure, or intimidate individuals. He will remain in custody pending trial, which has not yet been scheduled. If convicted of the current charges, Vandenberg faces up to 10 years in federal prison.

The Las Cruces Resident Agency of the FBI's Albuquerque Field Office investigated this case with assistance from the Tucson Resident Agency of the FBI's Phoenix Field Office, Tucson Police Department, U.S. Air Force Office of Special Investigations, and Homeland Security Investigations (HSI), FI Paso.

Kyle Neuman, 26, Cedar Park Drive Loudon, was charged with, Criminal Impersonation, Public Intoxication, and Indecent Exposure

Deputy Ezell, responded to the area of Highway 72 North and Stockton Valley Road following reports of indecent exposure. Dispatch informed me that they had received multiple reports of a naked male walking in the roadway. While the deputy was in the area, the deputy observed a male walking on the side of Highway 72, wrapped in a sheet. The deputy stopped the suspect and identified himself as law enforcement. While the deputy was speaking with the male he turned to face him and by doing so he exposed his genitals to him and the vehicles behind him. The male was detained and transported to the intersection of Highway 72 and Stockton Valley Road, where he was provided with

his Miranda warning. He consented to speak with deputies without an attorney present. The male identified himself as Ryder. He was unable to explain where he was going, and when asked why he was haked, he stated that he had taken off his clothes because he felt like they were "burying" him.

When asked about the sheet. he claimed that a passerby had thrown it at him while he was walking along the road. Deputies inquired if he had used any narcotics that day, to which he replied he had not However, he admitted to using narcotics in the past. The deputy observed that Mr. Ryder had dilated pupils, which is a sign of narcotic use. Based on his behavior and statements, along with the condition of his pupils, the deputy believed Mr. Ryder to be under the influence of an intoxicant. Mr. Ryder was taken into custody for public intoxication and indecent exposure, he was transported to the Loudon County Detention Facility without incident. The deputy attempted to confirm his identity by having Dispatch run his information through NCIC, but they were unable to locate any identification that matched the information provided by Mr. Rvder. He also stated that he did not know his social security number. Given the possibility that Mr. Ryder was lying about his identity, he was booked as John Doe later identified as Kyle Neuman.



rule making process, rather than fees being set by the legislature. The legislation established that any increase in fees could not exceed the amount of Consumer Price Index (CPI) increase. After the TFWC fee setting process, the rules are reviewed by the General Assembly's Joint Government Operations for either approval or denial.

Due to a more than 30 percent increase in CPI since the agency's last license fee increase in 2015, the agency has been operating in a significant deficit from increased expenses. The proposed package of license fee increases represented \$12 million dollars of additional revenue needed to correct the deficit.

During the committee meeting, many members acknowledged the need for additional funding but ex-

pressed concerns about placing further financial burdens on their constituents - concerns the agency understands and shares. Importantly, a majority of Committee members verbally committed to work collaboratively with the agency to identify alternative long-term funding sources. with several offering to carry legislation. This commitment represents a meaningful step forward in laying the groundwork for a viable funding

Speaking during the Committee Rule Review, Rep. Monty Fritts said, "I don't know why we wouldn't take care of something that takes care of all Tennessee. Shifting the additional cost to citizen taxpayers in a time when there are those other options, I don't think it's the right thing to do... I think that changing to a more sustainable model, especially on the law enforcement side of

things, is going to warm the public, and I think it'd be a good thing."






