Chrystal Hatley, 47, County Road 304 Sweetwater, was charged with, Man/Sell/Del/Sch. II, and Poss. of Drug Para.

Officer Garren LCPD, conducted a traffic stop on a silver Dodge Caravan, bearing Tennessee Registration 18515PD, trav-

eling west on East Depot St for expired registration. The final stop of the traffic stop was in the parking lot of the Lenoir City Public School Office at 200 E Broadway. Upon contact with the driver, the driver was identified as Chrystal Hatley, by her state issued drivers license. Chrystal, during normal conversation of the stop, stated

that she had been trying to stay out of trouble and stated her last arrest was a few months prior. Chrystal explained that it was for simple possession of methamphetamine out of Monroe County. The officer asked Chrystal if she had any on her and she denied. The officer asked Chrystal for consent to search, in which Chrystal gave consent. During Consent Search the officer located a plastic tube with white powder residue in it. The tube was located in Chrystal Purse. The officer located two clear plastic bags in a black pouch, with crystal like residue in them, lodged between the passenger seat and center console. The officer locat-

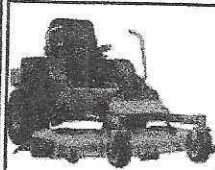
ed a black box underneath the radio of the vehicle, which contained a plastic bag of methamphetamine weighing .67grams and a meth pipe. Based on the evidence found of multiple bags with crystal residue and the bag of .67grams of methamphetamine, Chrystal was placed into custody for a Class B felony, possession of a controlled substance schedule II with weight greater than .5grams (TCA 39-17-417.) The narcotics were also located within 1000ft of a school building, which intensifies this to a Class A felony, per TCA 39-17-432. 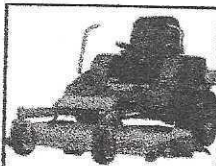

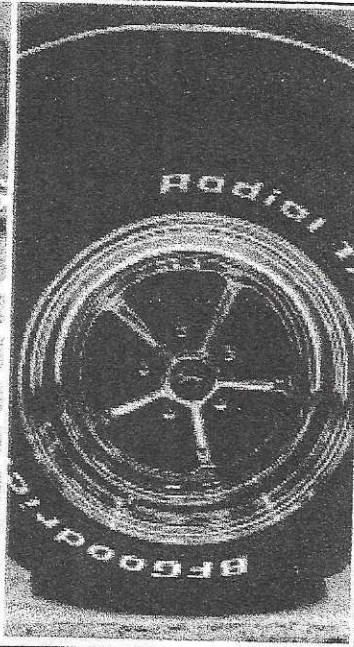

pipe and straw with white powder residue. Christel was transported to Loudon County Jail without further incident. The above did occur in Lenoir City, Loudon County, Tn.

DUI

Gabriel Macias, 39, Watson Road Loudon, was charged with, DUI, Poss. of Drug Para., and General Session Capias.

Deputy Owens LCSO, observed a car traveling on Highway 72 with a light-law violation. The deputy ran the registration through dispatch, and dispatch advised that the registration had expired in November of 2022. The deputy conducted a traffic stop on the car on Highway

72 at Burger King. Contact was made with the driver, who was identified as Gabriel Macias. The deputy explained to Gabriel the reason for his stop, and he advised that he had bought the vehicle from a friend a couple of months prior, and he was waiting for her to receive the title so that he could register the car in his name. Gabriel also stated that he did not have any insurance on the vehicle. The deputy asked Gabriel if he had been in trouble before, and he said he was arrested the week prior for possession of drug paraphernalia. The deputy asked if there was anything illegal in the vehicle, and Gabriel said "no." the deputy asked for consent to search the car, and Gabriel consented to a search. A glass pipe with

residue was recovered from the center console of the vehicle. Gabriel admitted to using it to smoke meth with one of his friends. Gabriel admitted to Sergeant Pesterfield that had smoked meth earlier in the night and that he believed himself to be at a 4 out of 10 as in how under the influence he was. Gabriel also admitted that he shouldn't be operating a motor vehicle.

A check through dispatch revealed that Gabriel had a warrant for failure to appear out of Loudon County. Gabriel was then placed under arrest. Implied consent was read to Gabriel, and he consented to give a blood sample. He was transported to Fort Loudon Medical Center, where his blood was drawn, and he was then transferred to the Loudon County Jail without further incident.

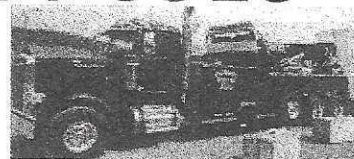

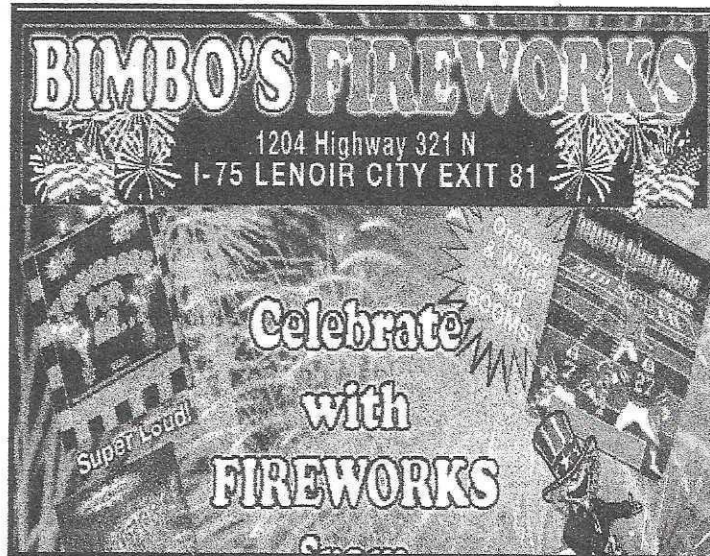

several people at a pro-Israel gathering in Boulder, Colorado, and threw two Molotov cocktails at the group, injuring at least nine people. This attack followed a separate attack in late May 2025, in which an individual shot and killed two Israeli Embassy staffers after they attended an event at the Capital Jewish Museum in Washington, DC. The Capital Jewish Museum attacker allegedly cited Israel's treatment of the Palestinian people when taken into custody.

The ongoing Israel-HAMAS conflict may motivate other violent extremists and hate crime perpetrators with similar grievances to conduct violence against Jewish and Israeli communities and their supporters. Foreign terrorist organizations also may try to exploit narratives relat-

ed to the conflict to inspire attacks in the United States. The FBI and DHS therefore urge the public to remain vigilant and to report any threats of violence or suspicious activity to law enforcement.

Joshua Rice, 36, Strutt Street Oliver Springs, was charged with, Aggravated Stalking, and Violation of Order of Protection/ Restraining Order.

The victim contacted the Lenoir City Police Department in reference to receiving harassing messages from her ex-boyfriend, Joshua Farris Rice. Investigator Jason Smith, advised the victim to state to Mr. Rice not to

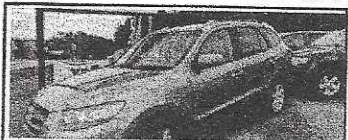
contact her. On May 12th, 2025 the victim came to the Lenoir City Police Department to report that Mr. Rice continued to message her after she sent the message to him to not contact her. The victim stated that the

messages have annoyed, alarmed and frightened her. Probable cause was established, and a Loudon County General Sessions warrant (2025-CR-600) was issued against Mr. Rice for harassment. The warrant was served on May 14th, 2025 and Mr. Rice was arrested and bonded out two days later. An order of protection was heard on May 19th, 2025 by Judge Rex Dale in Loudon County Sessions Court. Docket number 2025-DV-87 was granted by default judgment after Mr. Rice failed to appear for the hearing after having been properly served. On Friday, May 30th, 2025 the victim re-

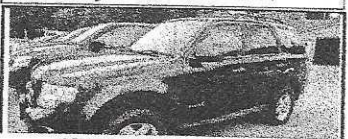

Project Introduction

Lenoir City Utilities Board (LCUB), an independent agency of Lenoir City, provides electric, natural gas, water, and wastewater services to more than 95,255 customers in Lenoir City and parts of four surrounding counties, making LCUB the eighth-largest utility among TVA distributors.

LCUB's electric system serves a 208-square-mile service area and relies on 2,349 miles of service lines to serve approximately 76,388 customers daily. LCUB will upgrade its electric grid and implement innovative technologies that improve reliability and efficiency to meet its customers' changing needs and expectations.

In addition to improving LCUB's electric system, the electric fiber network required for these systems will position LCUB to provide broadband services to meet the growing needs of its customers and community. Many applications for these improvements depend on fast and reliable communication throughout the service territory, which an extensive fiber system can best provide.

Project Overview

Fiber infrastructure plays a critical role in future system applications that require low latency and high-reliability communication to make real-time decisions for the electric grid. Over the next several years,

- LCUB plans to expand its Fault Location Isolation and Restoration (FLISR) program from 12 to 250 devices across the electric distribution system.
- LCUB will eventually connect all LCUB infrastructure and improve the reliability of

- LCUB's Supervisory Control and Data Acquisition (SCADA) network.
- The fiber infrastructure will improve communications for Distributed Energy Resources (DER).
- The fiber system will allow Volt/VAR Optimization applications to be deployed.
- The fiber infrastructure will position LCUB to implement Demand Response (DR) programs on the electric system and offer customers controllable thermostats, water heaters, and other heavy electric load devices within their homes.
- The fiber infrastructure will provide next-generation Automated Metering Infrastructure (AMI) options.
- The broadband services that LCUB will offer will help offset the cost of its infrastructure upgrades for the benefit of its electric utility customers.

During the first year, areas were built to serve approximately 22,000 eligible customers. The infrastructure for the remaining 54,388 customers will be built over the next two years of deployment, resulting in a three-year deployment for the entire electric service territory. LCUB anticipates approximately 1,500 miles of fiber to be constructed over the three-year build-out period. The completed build is projected to serve more than 20,000 customers while passing more than 58,000 homes and 11,000 businesses with internet and voice services across a four-county area. The fiber build will add to the existing fiber network and will be a mix of 55% aerial / 45% underground.

The network uses PON to interconnect LCUB's devices and offer multi-gig services to 100% of LCUB members via XGS-PON.

Project construction plans started in 2022 Q1.

Project Scope:

This RFP will provide pricing for the installation service of fiber optic cable into existing primary and secondary electrical conduits by qualified personnel who work near or around high-voltage lines. In some cases, this will require entry into utility transformer cabinets or entry through existing transformer bases to pull nonmetallic fiber cable adjacent to secondary power, and in some cases, primary power. LCUB Journeyman Lineman will be present during all installations.

Safely enter existing transformers or transformer bases and install (pull) nonmetallic fiber cable alongside secondary power in existing underground conduit. This would be from an outside transformer inside a building. Once inside, the cable would need to break outside the meter bases or power box and be coiled for internal connections. In addition, crews may need to follow primary (7200V) conduit from riser poles in transitional applications from aerial to underground handholes/vaults or possibly transformer pads. Crews may also be requested to place small or large handholes on job sites and place conduits between handholes, poles, or transformers. This could include hand digging, excavating, or other methods.

○ **Line Items**

- Contractor will report and receive all work from LCUB's Fiber OSP Manager
- LCUB will provide the necessary material to perform each job. The contractor will coordinate with the material warehouse to collect the required materials to complete the installation. Consumables are the Contractor's responsibility.
- Contractor will install the fiber and vaults per LCUB Installation standards.

- The contractor will have an LCUB journeyman lineman present for each installation of fiber in power conduit
- Contractor will provide weekly updates on progress and completions.

RFP Terminology:

- Throughout the RFP documents, references to "Bidder", "Company", "Contractor", and "Partner" mean the company proposing LCUB for this project.

The final proposal must have physical paper copies in a sealed bid in the hands of LCUB by the Proposals Due Date. Any proposals received after that will not be accepted.

Unsigned proposals will not be considered. Telephone or electronic versions of proposals will not be accepted. All Proposals must reference the RFP name on the outside of the returned proposal. Overall, this project will have multiple RFPs. If a Contractor chooses to provide a proposal on additional RFPs that are issued, each RFP must be sent in separately, with the RFP clearly marked on the outside of the envelope. Do NOT include multiple RFP responses in the same envelope.

The proposal will need to provide a Solution to cover the following areas:

- **Price per foot for installation of various fiber sizes in power conduit**
- **Price per vault installation for various sizes**

Each proposal will be required to meet a set of minimum mandatory requirements. Proposals that do not meet these criteria will not be considered. Compulsory minimum requirements are:

- Proposals must be signed.
- Contractor must be licensed to perform the Work described in Tennessee and the Town of Farragut.
- Contractor must have previous experience in installing fiber optic cable in power conduit systems
- The proposal includes the appropriate bond required.

ceived a text message from Mr. Rice stating he had dark spots spreading and that it was stage 2 syphilis. Mr. Rice

also texted he would not text her again. On Saturday, May 31st, 2025 the victim received a phone call from Mr. Rice which she did

not answer. She then received a text from his phone stating it was a "pocket dial". On Monday, June 2nd, 2025 the victim reported that Mr. Rice called her place of employment, Hampton Inn Lenoir City, multiple times. She stated she recognized his voice and that he stated he couldn't believe she got him arrested. The vic-

tim stated Mr. Rice called approximately ten times in less than one hour, including while Lenoir City PD was on site regarding the harassment. Mr. Rice has engaged in a course of conduct comprised of two or more separate non-continuous acts of harassment against the victim causing emotional distress. This did occur in Loudon County.

No License

Jose Lara-Hernandez, 39, Unknown Loudon, was charged with, DUI, and No Driving License.

Deputy Owens, was traveling on East Lee Highway when I observed a vehicle traveling in the opposite direction cross the double Yellow line multiple times, slightly entering my lane of travel. It was also obvious

that the car was traveling well over the posted speed limit. The deputy turned around on the car and noticed the car crossed the fog line as well. The deputy conducted a traffic stop on the vehicle and made contact with the driver. Upon speaking with the driver, the deputy could smell the odor of an alcoholic beverage emanating from his person. The deputy also noticed that as he was talking to him, he was attempting to put a fresh piece of gum into his mouth. The driver was identified as Jose Hernandez. There was a language barrier, so the deputy proceeded to use Google Translate to talk to Jose. Jose said he did not have a driver's license, and he admitted to drinking 2 alcoholic beverages earlier in the day. Due to the language barrier and no translator available, field sobriety was not conducted. Due to the totality of the circumstances, the deputy

believed Jose to be operating a motor vehicle on a public roadway while under the influence of an intoxicant. Jose was placed under arrest for DUI and also driving with no driver's license. An empty Modello was found in the backseat passenger floorboard well in reach of Jose. Jose was asked on a scale of 1-10 how intoxicated he was, and he said he was at a 4. Jose's sister-in-law responded to the scene and was able to translate for the deputy. Implied consent was read and translated to Jose, and he consented to give a blood sample for chemical testing. The vehicle was released to the registered owner, and Jose was transported to Fort Loudoun Medical Center, where the blood draw was conducted. After the blood draw was completed, Jose was transported to the Loudon County Jail without incident.
