



John Mize, 49, Sevierville Pike Knoxville, was charged with, DUI, Violation of Implied Consent, Driving on Revoked/Suspended License, and Man/Sell/Del/Resale Sch. II.

Deputy Billy Lewis LCSO. responded to a wreck with no injury Highway 72 at Mayo Road. While working on the accident, the deputy contacted Mr. John Mize, who was driving a Ford Taurus with Tennessee registration BSL2025. John said that he had fallen asleep, causing him to strike the vehicle in front of him. Deputy Reagan LCSO, conducted SFSTs, at which time John Mize failed. Upon checking his Tennessee ID through dispatch, the deputy was advised he was suspended. John was read the Tennessee Implied Consent and refused. Deputy Reagan located a cigarette pack inside a plas-

tic bag, which contained .06 grams of Methamphetamine, confirmed by TruNarc (2931 scan number). The deputy took Mr. John Mize into custody for DUI, Man/sale/del of schedule two, Violation of Implied Consent, and driving on a suspended driver's license. John Mize was transported to the Loudon County Jail without incident. This did occur in Loudon County, Tennessee.

Ramon Constantino. 31, Finley Drive Lenoir City, was charged with; Domestic Assault.

Officer Cole LCPD, was dispatched to a domestic within the western patrol district at Finley Drive. Upon arrival, the officer observed a male and female to be in a heated verbal argument in the car port of the residence. The male subject, Ramon Constantino, appeared visible upset and exhibited signs of intoxication including slurred speech and a strong odor of alcohol emitting from his persons. Mr. Constantino had a small laceration above his right eye and was

bleeding at the time of being interviewed. He initially claimed the female had struck him. However, officer investigation and witnesses determined the injury was sustained when Mr. Constantino stumbled and fell into the table prior to the physical altercation. The female/victim, had blood on her hands and appeared visibly shaken from the incident; upon investigation it was confirmed the blood was from Mr. Constantino's laceration. It should be duly noted the victim had no signs on her persons to indicate aggressive physical contact; the victim was observed to have long, delicate nails that were still intact lead-

not closed-fist strike Mr. Constantino. However, the victim did advise officers she pushed him away in self-defense after Mr. Constantino approached her in an aggressive manner subsequent to injuring himself. Based on the evidence on scene including: the victim account of the events, the physical findings, Mr. Constantino's inconsistent account and his level of intoxication resulted in officer's identify Mr. Constantino as the primary aggressor. Mr. Constantino was placed into custody and transported to the Loudon County Jail without further incident. All of the above did occur within Lenoir City, TN



Gunner Callis, 18, East Highway 52 TN, was charged with DUI.

Officer M.Flynn LPD, was patrolling on Mulberry St when Officer Flynn Observed a Red Nissian Altima with a TN tag, BRP8060 running next to the dumpster of GT Oil, a business which is closed at this time of night. Officer Flynn made contact with the offender Gunner Callis who was sitting in the driver seat. Officer Jenkins who is ARIDE certified conducted Standardized Field Sobriety Testing on Callis. It was based off his performance on testing and statements that Callis told officers that Allis was impaired by Cannabis and should not have been driving. Officer Flynn locate keys to the Vehicle in Callis' front left pocket. Officers took Callis into custody without incident. Callis consented to a Blood Draw for chemical testing. 
