**Loudon County Criminal Court
Grand Jury Report
December 12, 2006**

This is the Grand Jury report for the December 2006 term of the Criminal Court in Loudon County, Tennessee as reported by the Grand Jury on December 12, 2006.

The Grand Jury reviewed the following facilities and found these items that need attention:

Loudon County Courthouse

1. Back entrance doors too narrow.
2. Muddy water in sinks and toilets.
3. Mold in main courtroom.
4. Water damage in several places. Records covered with tarps in places.
5. Outside sidewalks crumpling in places and holes or dips in the yards.
6. Need streetlights on Annex side.
7. Floors sagging in places, especially the room across from Clerk's office.
8. Basement has numerous problems that are obvious and too numerous to list.

Because of safety and compliance regulations and the liability associated with the Courthouse use we strongly recommend the hiring of an architecture/engineering firm to assess the building against approved standards such as the Southern Building Code for recommendations to bring the building in compliance, and implementing them.

Annex

1. Stairs leading from parking lot to front of building slope downward and have no handrails. Could be especially dangerous if icy.
2. Bushes need trimming back at lower entrance at back of building.
3. Both front and rear doors need sanding and refinishing, especially front, to prevent having to replace in future.
4. Attention needs to be made to make the building more "handicap friendly" as most doors, especially entrances, are difficult to maneuver even by a lot of able-bodied people.
5. Rails on back of building at steps are rusting and need repair and refinishing.
6. Light is out in main entrance going downstairs.
7. Some minor stains (leaks) are showing up on ceilings in County Commission Assembly Room, County Clerk's Office and Register of Deeds Office that will probably only get worse.
8. It was reported that there were water stains in the ladies restroom and also muddy water from the sink.

Justice Center


1. General Sessions Clerk's office is in desperate need of some records storage facility to ease some of the clutter they're dealing with.
2. Even though it wasn't a court day, everyone is aware of what a problem the parking is on these days. At these times, it is so bad it becomes a serious safety issue.
3. Courtroom II needs more seating. Courtroom I is also inadequate for seating, but not much room left for it.
4. Sheriff's office needs more patrol officers. All juror's were "shocked" at the small number on duty each shift.
5. Patrol cars became another issue. Four have more than 160k miles and probably would be much more cost effective to replace than maintain.
6. Ceiling tiles are missing in holding rooms for courtrooms.

County Jail

1. Simply put, more space needed. The department seems to do an excellent job with what they have, but as probably the case at many jails, space is inadequate. It might be feasible to overbuild additions and offset the costs by housing prisoners from elsewhere.
