INTERPLEADER COMPLAINT

Plaintiff ASSURANCE TITLE COMPANY, LLC ("AT"), by its undersigned attorney and for its Interpleader Complaint against TERRY G. VANN, MIKE ROSS, TRACY RIEDL, and the UNITED STATES OF AMERICA (collectively, "Claimants"), states as follows:

- This is statutory interpleader action filed pursuant to 28 U.S.C. §§1335,
 1397, 2361, and 2410.
- At stake is \$78,713.30 ("Stake") in proceeds remaining from the assets of
 AT.
 - 3. AT is a neutral stakeholder, and it makes no claim to the Stake.
 - The Claimants may have conflicting claims to the Stake.

- As a disinterested party, AT seeks to avoid becoming embroiled in litigation over Claimants' conflicting claims to the Stake.
- AT has deposited the Stake into the Court by tender of a check in the amount of \$78,713.30 dated July 2, 2008.

II. PARTIES AND JURISDICTION

- 7. AT is a Tennessee limited liability company. Its principal place of business is located in Maryville, Tennessee. AT has filed, with the Tennessee Secretary of State, Articles of Dissolution, in pursuit of the termination of the existence of AT.
- Upon information and belief, Claimant Terry G. Vann ("Mr. Vann") is a citizen and resident of the State of Tennessee and can be served with process at 110 Kingston Street, Lenoir City, Tennessee 37771.
- Upon information and belief, Claimant Mike Ross ("Mr. Ross") is a citizen
 and resident of the State of Tennessee and can be served with process at 1010 William
 Blount Drive, Maryville, Tennessee 37801.
- 10. Upon information and belief, Claimant Tracy Riedl ("Ms. Riedl") is a citizen and resident of the State of Tennessee and can be served with process at 1010 William Blount Drive, Maryville, Tennessee 37801.
- 11. The United States of America can be served by serving a copy on the Civil Process Clerk, United States Attorney's Office, 800 Market Street, Suite 211, Knoxville, Tennessee 37902, with a copy on Michael Mukasey, Attorney General, United States Department of Justice, 950 Pennsylvania Avenue, NW, Washington, DC 20530, and with

a copy to United States of America, Department of the Treasury, Internal Revenue Service, Collection Division, 710 Locust Street, Suite 400, Knoxville, Tennessee 37902.

- 12. The Stake at issue has a value of \$500 or more.
- 13. Two or more adverse Claimants may claim to be entitled to the Stake, and AT has deposited the Stake into the registry of the Court, there to abide the judgment of the Court.
- 14. Because one of those adverse Claimants is the United States of America, and because this is a civil proceeding arising under an Act of Congress providing for Internal Revenue, and this Court has jurisdiction of this interpleader action pursuant to 28 U.S.C. §1340. This Court also has jurisdiction pursuant to 28 U.S.C. §2410 as the Stake constitutes personal property on which the United States has or claims a lien.
- Venue is appropriate in the Eastern District of Tennessee because at least one claimant resides here. See 28 U.S.C. §1397.

III. FACTS

- 16. AT was formally in the business of closing real estate transactions and issuing policies of title insurance.
- At a called special meeting of the members of AT, held on September 18,
 2007, a vote was taken to dissolve and terminate the limited liability company.
- 18. In the course of filing Articles of Dissolution and winding up and terminating its affairs, AT has found itself holding the sum of \$78,713.30, attributable to and payable to Terry G. Vann.

19. Of record in the Register of Deeds Office for Loudon County, Tennessee, at Book L25, Page 329 is a Notice of Federal Tax Lien in the stated amount of \$170,573.16, filed against "all property and rights to property" belonging to Terry G. Vann "for the amount of these taxes and additional penalties, interest, and costs that may accrue." For the purpose of complying with 28 U.S.C. §2410(b), the following information is provided:

- 20. Mike Ross and Tracy Riedl are named in this Complaint as they too are members of AT, and may have some claim to the Stake.
- 21. AT has no claim to the Stake, and tenders the Stake to this Court to allow the Claimants to determine which is entitled to what sum.
- 22. AT has not prepared this Interpleader Complaint at the request of, or in collusion with, any Claimants, and AT has not been indemnified by any Claimants. AT files this Interpleader Complaint solely to avoid being injured on account of the matters described herein.

IV. PRAYER FOR RELIEF

WHEREFORE, Plaintiff respectfully requests that this Court:

- (a) Take jurisdiction of this matter and cause process to issue for all Claimants;
- (b) Order Claimants to interplead and settle their rights to the Stake;
- (c) Enter an order restraining Claimants from commencing any action against AT in any State or United States court relating in any way to the Stake until further order of this Court;
- (d) Hear and determine the case, discharge AT from further liability, make the injunction permanent, and make all appropriate orders to enforce its judgment;
- (e) Enter an order forthwith permitting AT to file its Articles of Termination
 with the Tennessee Secretary of State;
- (f) Award AT its reasonable attorney fees and costs related to this Interpleader
 Complaint; and
 - (g) Award AT any further relief this Court deems proper.
