It's 8:30 a.m., and the temperature in the Arizona desert is already approaching triple digits.

Inside an FBI training facility, 50 new special agents listen to instructions from FBI SWAT on how to enter a building with an armed suspect inside. It's the fifth and final day of the new agent Indian Country Onboarding Program.

This is not a new program in the FBI, but for the first time, it's being hosted by the FBI Phoenix Field Office. Phoenix has several Native American tribes in its area of responsibility, including the Navajo Nation. Because of this proximity, Phoenix offers firsthand experiences and knowledge to this training and can develop the program further than before.

Within the FBI, more than 150 agents work as the primary law enforcement body on reservations. The FBI has jurisdiction in Indian Country crimes when a major crime happens against a member of a federally recognized tribe within the boundaries of a reservation. The FBI partners on these investigations with the

Floyd Jenkins, 44, Enterprise Lane Chattanooga, was charged with Man/Sell/Del/Resale Sch. II. Mfg/Del/Sale or Poss. of Meth, Simple possession, Driving while in Possession of Meth, and Display of Registration plate.

Deputy A. Gann LCSO, observed a red Toyota Camry on Interstate 75 going northbound. Deputy observed the vehicle traveling in the slow lane and starting to decrease speed causing multiple cars behind the vehicle to swerve out of the lane to avoid causing a collision. Deputy then observed a registration cover over the license plate. Deputy ran the registration through dispatch and he was advised it was not on file through Ohio, which is the state the deputy believed the registration belonged to at the time. Deputy made a traffic

stop on the vehicle and during the investigation of the traffic stop, he could smell an odor of marijuana coming from the car. Deputy asked the driver, Mr. Floyd Jenkins (offender) why the smell of marijuana was omitting from his vehicle. Mr. Jenkins originally stated he did not have any marijuana in his car and did not smoke. Mr. Jenkins was asked to step out of the vehicle. Mr. Jenkins then admitted to smoking weed in the car and also admitted to having a blunt inside his vehicle. A vehicle search was performed. Deputy then found what is known to be a blunt rolled with a green leafy substance inside believed to be marijuana in the center console. Deputy then found a backpack in the vehicle's trunk containing 2 black magnetic boxes. Upon opening the boxes, a large bag of a crystal-like substance believed to be methamphetamine was found

inside one of the boxes. Mr. Jenkins was asked what the bag was, to which Mr. Jenkins stated he did not know what it was. Mr. Jenkins was then placed in custody. The other black magnetic box contained more bags of a crystal-like substance along with more bags of a brown, rock-like substance believed to be heroin-fentanyl. The crystal-like substance weighed out to be 235.9 grams. The brown rock-like substance weighed out to be 47.9 grams. The green leafy substance weighed out to be 7.8 grams. Mr. Jenkins was then read his Miranda Rights and stated he

understood the rights that were read to him and was willing to answer questions without an attorney present. Mr. Jenkins was asked again what the drugs were and Mr. Jenkins admitted to it being ICE also known as methamphetamine. Mr. Jenkins was transported to the Loudon County Jail. Narcotics investigators were called and tested the crystal-like substance, which tested positive for methamphetamine. The brown, rock-like substance was also tested and tested positive for Heroin-fentanyl. This did occur in Loudon County, Tn.

Justin Bettis, 39, Little Valley Road, was charged with Aggravated Assault.

Corporal Christina Wallen LCSO, along with Sergeant Brandon Pesterfield, responded to Little Valley Rd., Loudon, on the report of a possible armed person. Loudon County Dispatch received a 911 call where a female could be heard saying, "Put the gun down and leave." The call disconnected and a 3rd party caller advised that they could hear a possible domestic disturbance between a male and female in the front yard on Little Valley Rd. Upon arrival, Sgt. Pesterfield and Cpl. made contact with a male and female on the front porch of the residence. The male was detained and the parties were separated prior to the interview. The female, (victim), and male,

Justin Bettis (offender), both stated that the two of them are married but going through a separation at this time. The victim previously had a male visitor at the shared residence, and this angered Justin. Justin left his place of employment to go home and confront the victim. Once Justin was at the residence, the male visitor was already gone, and an argument ensued between the victim and Justin. This argument then turned physical with Justin assaulting the victim by placing his hands around victim's throat and "throwing" the victim around. The victim did not lose consciousness as a result of Justin grabbing her around the neck. The victim had visible red marks around her neck. The victim also sustained minor abrasions to her right knee and the top of her right foot. All of these observable inju-

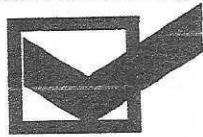
ries were consistent with the mechanism of injury reported. Justin also had a loaded firearm that he pointed at the victim head and his own head and he threatened to kill them both. The victim stated that she was able to get her phone to call 911, and after making the 911 call, she stated that Justin had calmed down. Justin was taken into custody without incident and charged with Aggravated Domestic Assault TCA 39-13-111. Cpl. did recover a

loaded CZ P-10 C semi-automatic, 9mm handgun with 14 rounds of ammunition from the sofa in the living room of the residence. The handgun was made safe, checked through NCIC with no stolen record, and then seized as evidence. Sgt. Pesterfield transported Justin to the Loudon County Detention Facility without incident. All of the above did occur in Loudon County, TN.

Ariel Nasulme, 28, Blarglen Court Georgia, was charged with Simple Possession x2, and Poss. of Drug Para.

Deputy Harrison LCSO, observed a silver Nissan traveling 77mph in a posted 70mph zone on Interstate 75

northbound and maintaining its travel in the left-hand lane of the roadway. Deputy conducted a traffic stop on the vehicle on Interstate 40 eastbound at the 368-mile marker for the moving violations.

According to the report, Upon contact with the driver, and passenger Ariel Nasulme, Deputy observed


marijuana rolling papers in the center console. Deputy had the driver exit the driver seat and come back to his vehicle while deputy issued a written warning for the moving violations. While speaking with him, he stated they were traveling from Georgia to Kentucky to see the passenger's family for a couple of days. Deputy asked Ferguson if he smokes marijuana to which he stated yes, and deputy asked how much was in the vehicle due to the rolling papers in plain view and he advised there was less than an ounce near the center console in a clear baggie. Ferguson later stated that Nasulme gave him the marijuana for the trip earlier in the day. Deputy Kirkland arrived to assist with a probable cause search of the vehicle. Deputy had Nasulme exit the vehicle and during his search, in

a small brown shoulder bag, she was possessing deputy located a loaded Smith and Wesson 380 semi-automatic pistol, approximately 1.2g of meth in a clear zip lock baggie, a meth pipe with residue, and two more meth pipes with residue in a separate backpack. The bag also contained a Venmo card with the offender's name on it. Behind the center console, deputy located a mason jar containing approximately 26.4g of marijuana. Ariel Nasulme was placed in custody and once read Miranda denied possession of the narcotics.


Narcotics was notified and a TruNarc scan will be conducted. Deputy Kirkland transported the offender to the jail and the driver was released with a written warning. This did occur in Loudon County, Tennessee





Bureau of Indian Affairs and any local law enforcement partners working on the reservations.

But what makes the work in Indian Country unique and challenging is the isolation. An agent working in a populous like San Francisco or Boston has more immediate access to personnel and facilities that can aid in an investigation.

But agents working in Indian Country more often than not work alone. As Supervisory Special Agent Jerry Grambow puts it, "When you're working Indian Country, you may be just yourself and a tribal investigator with you out in the middle of nowhere, and you may not even have cell phone reception. You're going to have to make command decisions and be able to act responsibly and accordingly."

As such, the Indian Coun-

try Onboarding Program develops agents to operate with more autonomy and survivability and a more comprehensive investigative technique.

During the course, agents learn and reinforce previous training on a variety of subjects, including conducting homicide interviews, finding witnesses, defensive tactics, and remote medical care. They also learn about the cultural differences between them and the Native Americans living on this land and how to communicate better with and assist the communities in seeking justice.

For FBI Phoenix, this is hopefully the first of more programs to come. They expressed gratitude for the learning experience they gained as hosts and plan to solicit feedback on how to improve future trainings. The program is "designed to be scalable and flexible so that

we can meet the needs of our agents," said Akil Davis, head of FBI Phoenix.

One agent who completed the training said that "working in Indian Country is the closest an FBI agent can get to being a police detective." For him, it was a great way to hone many of his skills, including executing search warrants, learning the internal systems and procedures, conducting arrests, and more.

He appreciates how the Indian Country program helps him become a more independently capable agent and that he gets more work and experience working in Indian Country than he might in other parts of the FBI: "There is more work, it's faster paced, and you become better at technique and better at relating to individuals you might not have a lot in common with."

Former Elementary PTO President Pleads Guilty to Theft

Money stolen from Indian Springs Elementary PTO in Sullivan Co.

An investigation by the Tennessee Comptroller's Office has resulted in Misty Ritchie, the former PTO president at Indian Springs Elementary in Kingsport, pleading guilty on two counts.

Investigators determined that Ritchie misappropriated at least \$11,016.63 in PTO funds while she was serving as the president from February 2020 through November 2020.

Ritchie employed two schemes to perpetrate her theft. She misappropriated

\$10,016.63 by using PTO funds to make seven payments toward her husband's personal credit card account balance. She also wrote a \$1,000 PTO check payable to "Cash" and used the proceeds from this check for her personal benefit.

Investigators also noted additional questionable PTO checks with no supporting documentation totaling \$3,750; however, without adequate documentation, investigators were unable to determine whether the funds were used for appropriate PTO business purposes.


In April 2023, Ritchie told investigators she misappropriated PTO funds because she was unable to work in 2020 and needed financial help. She left her position with the PTO in May 2022.

Based upon this investigation, on September 13, 2023, Misty Ritchie pled guilty to one count of theft of property over \$10,000, and one count of forgery and was granted judicial diversion relief and placed on supervised probation for a total of six years. Ritchie was also fined \$100 for each count, and restitution was paid in full prior to the entry of the plea.

"All school support organizations, such as PTOs, are required by law to ensure funds and property of their organizations are safeguarded," said Comptroller Mumpower. "In addition to not providing adequate oversight, PTO officers should also ensure invoices, vendor receipts, and other supporting documentation are acquired and retained to prevent the opportunity for misuse."
