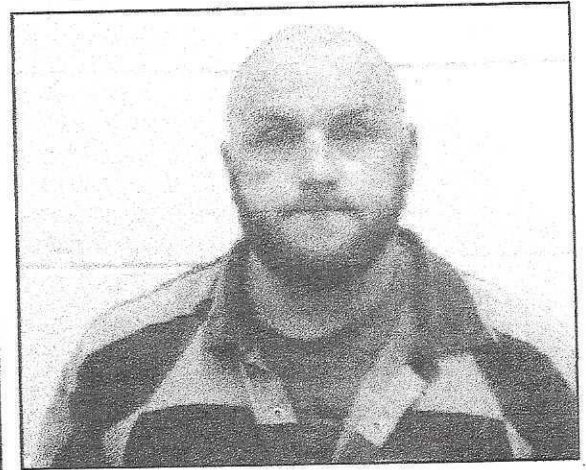

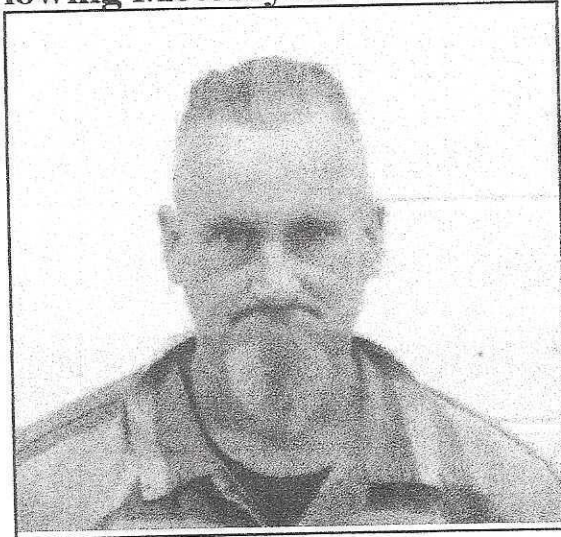

Lending a Hand in Lahaina

FBI teams gathered on Maui to assist with wildfire recovery efforts

When a wildfire devastated the island of Maui on August 8, killing at least 97 people and destroying more than 2,000 homes, the FBI was quick to offer assistance to our law enforcement partners in Hawaii.

Driving through Lahaina the next day, special agents from the FBI's resident agency on Maui saw surreal scenes of

melted cars and traffic lights. Boats anchored 100 yards offshore burned in Lahaina's harbor. It's estimated the fire's temperature reached 1700 degrees Fahrenheit.

They immediately contacted Maui law enforcement to see what help was needed. The relationships the FBI has with local partners were strong to begin with, which helped efforts immensely. Maui

Police Department (PD) invited the FBI to a briefing at the county's Emergency Operations Center.

Some initial concerns facing Maui PD were maintaining a perimeter around the search and rescue area—where active fires were still burning—and supporting the county's morgue and evidence response

Charles Snipes, 45, Rushbrook Lane Lenoir City, was charged with Man/Sell/Del/Resale Sch. I, DUI, and Driving on Revoked License.

Brieanda Melton, 43, Rushbrook Lane Lenoir City, was charged with Poss. of Drug Para.

Officer Eldridge LCPD, was dispatched to the Chick Fil A in reference to a suspicious vehicle's occupants being under the influence. An employee called in and stated that a male and female in a Nissan Rogue (376BFTV) in the parking lot appeared to be "on something". Officers arrived and made contact with the male (Charles E Snipes Jr) and female (Brianda Melton) and immediately noticed both individuals to be extremely lethargic and Snipes to be unsteady on his

feet. Snipes consented to a SFST and performed poorly. Snipes was also given field sobriety via ARIDE by Officer Arden and performed poorly on that as well. While speaking with both subjects outside of the vehicle, Officers noticed Melton to have an obstruction in her shirt/bra area and was asked to pull it forward without exposing herself. A cut straw did fall from under her shirt at that time and both subjects were placed in custody. Snipes admitted to driving the vehicle and had a revoked license and was read implied consent and agreed to give blood. While at the hospital, Melton was transported to the jail and the vehicle was towed by Malones wrecker service. After giving blood, Snipes was transported to the jail where he admitted to having contraband hid on his person. A small baggie that

contained 0.9 grams of Fentanyl (Tested by TruNarc) and a cut straw was taken

off his person on scene at the jail. This did occur in Lenoir City, Loudon Co, TN.

Wreck

Justin Marsh, 47, Mount Pleasant Road Vonore, was charged with DUI, Violation of Implied Consent, Simple Possession, Driving on Revoked/Suspend License, and Poss. of a Handgun while Under the Influence.

Deputy Jackson LCSO, responded to a suspicious person call at Peterson Road. The caller stated that a male subject came to his door and told him that he was in a motorcycle wreck, and asking for water. Upon arrival, Deputy saw a subject, later identified as Justin Marsh, lying in the front lawn area of the residence. As the deputy exited his vehicle, Mr. Marsh got up off the ground, and appeared unsteady on his feet as he approached the deputy. The deputy noticed the barrel of a pistol sticking out of his inner jacket pocket, and retrieved the firearm from him. Mr. Marsh explained to the deputy, and CPL. Wallen, that he was on his way home from Oak Ridge, and due to being tired ran his motorcycle off the side of the road. Deputy

asked if he needed EMS to assess him, and he refused. Upon checking Mr. Marsh's License through Loudon County Dispatch, it was found that he was suspended. While speaking with us, Mr. Marsh appeared lethargic, at one point falling asleep. Deputy asked Mr. Marsh if he would consent to SFST, and he refused. Deputy placed him in custody, and read him TN Implied Consent, to which he refused. He was transported to the jail, without incident. This occurred in Loudon County, TN.

Police beat

April McDaniel, 48, Arthur Avenue Maryville, was charged with Domestic Assault.

Officer Sparks LCPD, was dispatched to E 3rd Avenue in reference to a domestic disturbance. Upon arrival, officer spoke with the complainant, who advised that her sister, victim, had been in an altercation involving her, her mother and others. It was found that on 09/10/2023, April McDaniel arrived to the residence on E 3rd Avenue to pick up her son, and take him back to her residence.

While there, an argument between Ms. McDaniel, and victims began regarding a family matter.

The argument then escalated and Ms. McDaniel allegedly punched victim in the chest. After doing so, Ms. McDaniel's mother, attempted to intervene. Ms. McDaniel then struck victim 2 on her left ear and left side of her face with a "closed fist". Victim 2 then returned into the residence, and called 911. Witness statements were gathered

from all willing parties, and it was determined that Ms. April Michelle McDaniel was the primary aggressor, and was placed into custody for Domestic Assault. Victim 2 did have redness on the left side of her face were her and multiple witnesses stated she was struck by Ms. McDaniel. Ms. McDaniel denied striking the victims and stated that striking was in self-defense. Ms. April McDaniel was transported to the Loudon County Jail without further incident.

Timothy Wheeler, 31, Edith Lane Lenoir City, was charged with DUI.

Deputy Watson LCSO, observed a dark colored truck on Highway 321 traveling at 61 Mph in a 40 Mph zone. Deputy clocked the vehicle's speed using his in car radar. The vehicle made a U-turn on Highway 321 and drove up on the median. The vehicle then pulled into the parking lot of the Bimbos gas station. Deputy stopped the vehicle for the above infractions. Upon approaching the driver side of the vehicle, the deputy made contact with Timothy Wheeler (Arrestee/Offender) in the driver seat. Mr. Wheeler was the sole occupant of the vehicle. Mr. Wheelers eyes appeared blood shot and the deputy detected a strong odor of an alcoholic beverage emitting from inside the vehicle. Deputy asked Mr. Wheeler if he had been drinking to which he answered no. Deputy asked Mr. Wheeler to exit

the vehicle for further investigation. Mr. Wheeler consented to perform standardized field sobriety and performed poorly. Mr. Wheeler admitted to consuming alcohol approximately 45 minutes prior to my stop at a bar in Maryville. While Mr. Wheeler was speaking to him, the deputy detected a strong odor of an alcoholic beverage on his breathe. Officer Parmer with the Lenoir City Police Department assisted with the investigation. Officer Parmer located a bottle of whiskey with the lid unscrewed tucked under some clothing in reach of Mr. Wheeler in his vehicle. Mr. Wheeler was placed into custody and secured in his patrol vehicle. Mr. Wheeler was read implied consent and consented to a blood draw. Deputy transported Mr. Wheeler to the Fort Loudon Medical Center and obtained a sample of his blood. Mr. Wheeler was transported to the Loudon County Jail without incident. The vehicle was towed by Money-makers Wrecker Service to their lot.

team, which were quickly becoming inundated with remains of the deceased.

Within days of the fire, FBI resources such as the Evidence Response Team (ERT), forensic identification, and victim services deployed to Lahaina. FBI Honolulu Division's professional support staff immediately responded with resources to support Maui PD

and the FBI throughout the response.

"It is a privilege and an honor for the FBI to play a role in this endeavor," said Special Agent in Charge Steven Merrill of the FBI Honolulu Division. "Our employees live, work, raise their children [on Maui]. And this is a big part of what we do in the FBI. We have resources that other agencies may not have. And even if they

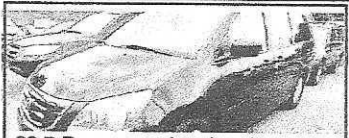

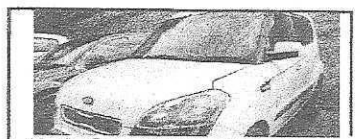

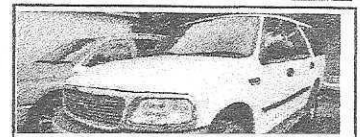

do have them, we want to be in a position to complement them. When the [Maui police] chief asked for our help, we didn't hesitate."

Identifying the Missing

In the fire's aftermath, Maui authorities received reports of over 2,500 individuals who were unaccounted for. Names came from Maui PD, the Red Cross, shelters, hotels, and airlines.

Jeff Felmann, a supervisory special agent in Honolulu, volunteered to lead a command post with agents, intelligence analysts, and professional staff to produce a consolidated list of the unaccounted for. Not every name on the list was a full name. Some were just partial names or nicknames.

Analysts searched public records databases and scoured social media for leads. Agents called the loved ones of unaccounted for individuals to request more information. Sometimes agents spoke with those reported as missing—"definitive confirmation," Felmann said—or analysts saw posts on social media stating the missing were alive.

On August 24, Maui County officials released to the public the first version of an FBI-validated list with first and last names of unaccounted for individuals. All names are associated with a verified phone number of a person

who reported the individuals as missing. Law enforcement continues to update the list.

Because of the fire's intensity and extreme temperatures, some victims may unfortunately never be found. Still, the Bureau continues its work to identify those who perished and help their families.

Evidence Response and Forensic Resources

When FBI Honolulu's ERT deployed to Maui, Special Agent Earl Asato knew it would be a challenging assignment. He told his 11-person team that "no one has seen to that magnitude" what they would see in Lahaina.

In addition, the fire's devastation personally affected some of the team. Three ERT members have relatives on Maui, and Asato's mother grew up near Lahaina. It was hard to comprehend the reality of the destroyed restaurants and mom-and-pop businesses his family had frequented.

While on Maui, ERT members assisted with autopsies in the morgue at Maui PD's forensic facility in Wailuku, about 45 minutes from Lahaina. The team worked continuously with medical examiners and autopsy technicians to photograph remains and associated personal effects, handle and maneuver remains for examination, sift through remains and debris for possible identifying information, and document findings.
