## LC Man Charged After Nearly Hitting Another Vehicle

Giovanni Gonzalez, 32, Homeless, Lenoir City, was charged with DUI, and Violation of Implied Consent.

Officer Law LCPD, was on routine patrol in the area of 1100 Highway 321 North when he observed a white Chrysler 300 (TN Tag 679-BFNQ) failing to maintain its lane of travel by driving in and out of lanes almost striking another vehicle. Officer then conducted a traffic

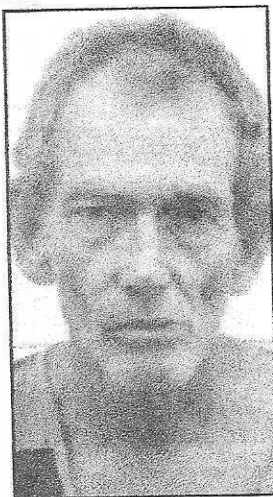

## Annual Report to the Nation Part 2: New cancer diagnoses fell abruptly early in the COVID-19 pandemic

New diagnoses of six major cancer types in the United States fell abruptly in early 2020, coinciding with the start of the COVID-19 pandemic, according to findings from part 2 of the latest Annual Report to the Nation on the Status of Cancer. The volume of pathology reports also declined sharply in early 2020, suggesting that fewer cancer screenings and other cancer-related procedures were performed during that time. Taken together, the findings suggest that many cancers were not being diagnosed in a timely

manner during the early part of the COVID-19 pandemic, likely due to interruptions in medical care.

"These missed opportunities for early cancer detection are alarming, particularly for those vulnerable populations that continue to face significant barriers in accessing cancer care," said Monica M. Bertagnolli, M.D., director of the National Cancer Institute (NCI). "This report highlights the urgency in helping all Americans get back on

track with their cancer care so that we can avoid unnecessary deaths and complications from cancer. That's exactly why expanding cancer screening access and awareness is a key priority of the Biden-Harris administration's Cancer Moonshot."

This study is the largest to date using population-based data from central cancer registries to assess the impact of the COVID-19 pandemic

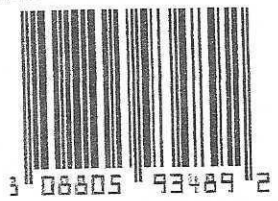
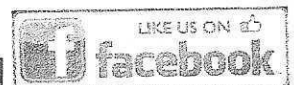

Amilou Fazio, 25, Matlock Alley Philadelphia, was charged with Simple Possession x3.

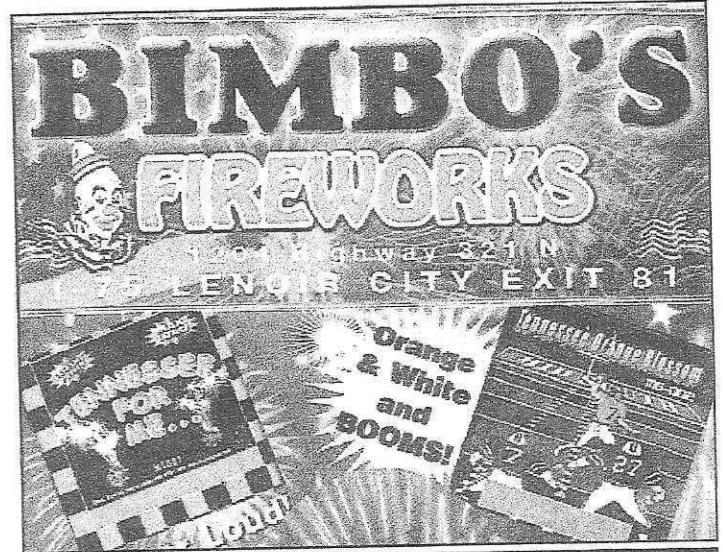
Kenneth Ashmore, 56, New Clear Ranch Road Rocky Top, was charged with Man/Del/Sale or Poss. of Meth, Simple Possession, Poss. of Drug Para., Violation of Drug Free School Zone, Driving while in Poss. of Meth.

Deputy Davis LCSO, conducted a traffic stop on Matlock Alley and West Lee Highway. The reason for stop was due to the vehicle not having operational tag lights. Deputy made contact with the driver Kenneth Ashmore and the passenger Amilou Fazio. While speaking Kenneth and Amilou, he could smell the odor of marijuana coming from the vehicle. Amilou later advised she had marijuana in her purse located in the passenger seat of the vehicle. Deputy conducted a probable cause search on the vehicle. The deputy located two small

baggies containing marijuana (approximate field weight 14.61g) in Amilou's purse. Deputy located one small baggy with a white crystalized substance (approximate field weight .7g) in Amilou's purse. Amilou later advised the white crystalized substance was methamphetamine. The deputy located a small baggy with four orange 400mg gabapentin capsules and six white 600mg gabapentin capsules in Amilou's purse. Amilou later advised she was not prescribed the gabapentin capsules. The deputy later located a large bag containing a white crystalized substance on the driver side floorboard. Kenneth later claimed ownership of the large bag with the white crystalized substance (approximate field weight 55.1g). Kenneth and Amilou were both taken into custody. During search incident to arrest, the deputy located two suboxone pills and one meth pipe in Kenneth's front left and right pocket. Amilou was charged with simple of pos-

session of schedule II, V, and VI. Kenneth was charged with manufacture, delivery, sale or possession of methamphetamine, possession of schedule III, possession of drug paraphernalia, possession of methamphetamine while driving. Kenneth was also charged with violation of drug free school zone, due to the location of the stop being within 1000

feet of the school real property. Deputy Chance Gray tested the white crystalized substance with the TruNarc machine, and the substance tested positive for methamphetamine. Both Amilou and Kenneth were transported to the Loudon County Detention Facility. This incident occurred in Loudon County Tennessee.

during HGN Officer observed lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and an onset of nystagmus prior to 45 degrees in both of Mr. Gonzalez's eyes. Mr. Gonzalez stated he could not perform the walk and turn, or the one leg stated due to his hurting his legs prior. After placing Mr.

Gonzalez under arrest, he was read the Tennessee Blood and/or Breath Consent Advisement. After reading the consequences, Mr. Gonzalez refused to submit a blood sample to determine his blood alcohol content. Mr. Gonzalez was then transported to the Loudon County Jail without incident. All the above occurred in Lenoir City, TN.

on cancer incidence (new diagnoses of cancer) in the United States. The report appeared September 27, 2023, in Cancer.

The Annual Report to the Nation on the Status of Cancer is a collaborative effort among NCI, part of the National Institutes of Health; the Centers for Disease Control and Prevention (CDC); the American Cancer Society; and the North American Association of Central Cancer Registries to provide information about cancer occurrence and trends in the United States. Part 1 of the latest report, which focused on national cancer statistics, was released in October

2022.

Part 2 of the latest report focuses on changes in cancer diagnoses in the United States during the first year of the COVID-19 pandemic. The authors suggest that these changes were due in part to interruptions in medical care. In particular, early 2020 saw a decline in cancer screenings. In addition, diagnoses made as a result of early symptoms or in the course of routine medical visits may have been delayed when people held off on seeing their doctors.

The authors analyzed cancer incidence data for 2015 to 2020 using data from select popula-

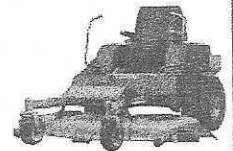
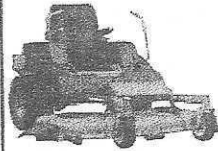

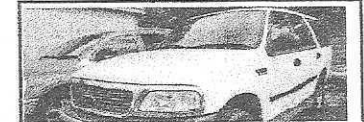

tion-based cancer registries that participate in CDC's National Program of Cancer Registries or NCI's Surveillance, Epidemiology, and End Results (SEER) Program.

The authors compared the number of newly diagnosed cases of cancer in 2020 with what was expected based on previous years. They looked at female breast, lung, and colorectal cancers, which are often diagnosed through screening tests or other forms of early detection that may have been disrupted by the pandemic; thyroid and prostate cancers, which are often diagnosed incidentally; and pancreatic cancer, which is usually diagnosed when the patient presents with symptoms. The authors also compared the volume of electronic pathology reports sent to central cancer registries in 2020 with the volume sent in 2019.

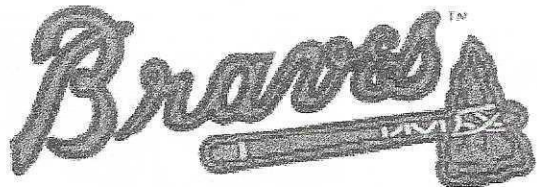
From March to May 2020, new cases of all six cancer types fell sharply. By July 2020, however, diagnoses of all cancer types except prostate cancer had returned to pre-pandemic levels, with little difference between observed and expected numbers during the second half of the year.

Over the same period in early 2020, the volume of electronic pathology reports also declined steeply before returning to pre-pandemic levels. Because these reports are transmitted automatically to cancer registries, the findings suggest that the decline in new cancer diagnoses was not due to delays in reporting caused by pandemic disruptions but rather to missed screenings and delays in other cancer-related procedures.

The authors also looked at declines in new cancer cases by cancer stage at diagnosis, sex, age, and population group. For each cancer type in the study, new cases of early-stage cancers fell more sharply than new cases of advanced cancers. The declines were greatest for the cancers typically diagnosed through screening (female breast, lung, and colorectal cancer). For example, 7,147 cases of early-stage colorectal cancer were expected to be diagnosed in 2020, but only 5,983 cases were diagnosed—meaning that potentially more than 16% of early-stage colorectal cancer cases weren't caught.
