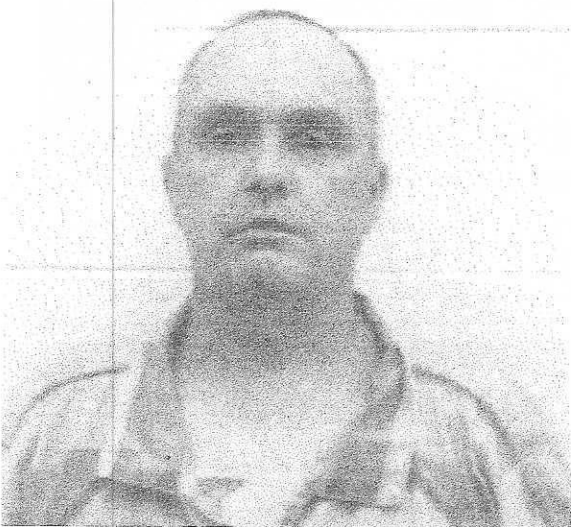

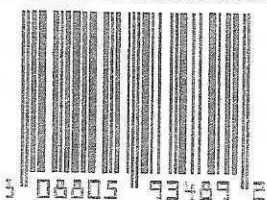

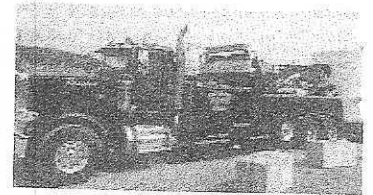
Officers with the Lenoir City Police Department, responded to Fort Loudoun Medical Center Drive, Lenoir City, TN (Fort Loudon Medical Center) in regards to a psychiatric patient that broke a door to the hospital room that he was in and began fighting with the nurses and the security guard. On scene Officers quickly made contact with the patient who was located in the room with the broken door, the patient was identified as Miguel Gutierrez. GUTIERREZ was identified by Officers just prior to this incident due to him escaping from Fort Loudon Medical Center and running from Officers into Walmart in Lenoir City. During the investigation,

Hospital Security, victim 1, and Registered Nurse, victim 2 stated that while they were approaching the door to GUTIERREZ'S room to speak with him, GUTIERREZ broke the door to the that room he was in and then proceeded by running at the two of them. Victim 1 reported that when GUTIERREZ began running towards him, that he pushed him to the ground and fell on top of him. Victim 2 then reported that she was attempting to help with the situation regarding victim 1 and GUTIERREZ at which time she stated GUTIERREZ kicked her left leg. After GUTIERREZ kicked victim 2 in the leg he attempted to exit the hospital again at which time victim 1 was able to regain his feet and stated that he drew his taser from his holster and began giving verbal

commands to GUTIERREZ to stop at which time he cooperated and went back into his room. Shortly after the brief conflict Officers arrived on scene and placed GUTIERREZ under arrest. Hospi-

tal staff advised that the door to room 9 that GUTIERREZ was in had been damaged and stated that they did not know how much it would cost to fix at the moment. This did occur in Lenoir City, TN.

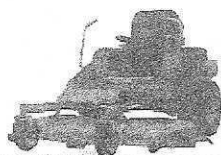
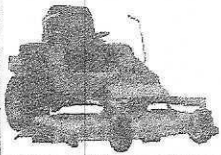

Dennis Palmer, 49, Peterson Road Greenback, was charged with Domestic Assault.

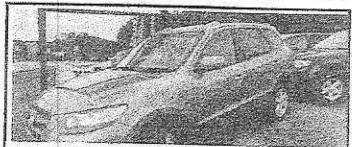

Before arrival, dispatch notified Deputy the suspect took the victim's keys to her car and fled the scene. Upon arrival, Deputy made contact with the (victim/complainant). Charged etd. from pg. 4 was in fear due to the aggressive behavior of Mr. Palmer during the altercation and was afraid Mr. Palmer was going to physically harm her after he already pushed her. Upon further investigation, Deputies were capable of making contact with Alcoa Police Department to advise them Mr. Palmer might be in the area. Alcoa Police Department Officers noticed the individual and made a traffic stop. Victim filled out a domestic assault victim statement form. Deputy then transported the victim to her vehicle and made contact with Mr. Palmer at 111 S Hall Road in Alcoa. Sonar (Sound Navigation and Ranging) Tools

tripod that is dropped from the surface. It sends a signal to computers on the surface, and the surface team directs the divers where to search.

Side scan "Towfish" unit: This torpedo-like sonar is designed to be towed behind or alongside a boat to cover wider search areas.

Buoyancy Devices

The following devices help control buoyancy, as well as offer an extra air supply.

The following devices help control buoyancy, as well as offer an extra air supply:

Buoyancy compression (BC) device: A vest-like device with a wing on the back that can be manually inflated or deflated to control buoyancy; also contains removable weight pouches. When diving with surface-supplied air, the diver's emergency tank connects to the BC.

Emergency tank: An aluminum cylinder that weighs 32 pounds and contains 80 cubic feet of gas (21% oxygen) under 3,000 pounds per square inch of working pressure. This tank provides about 30 minutes of air to use in case of emergency.

Dry Suit and Fins

Dry suit: Designed to keep out water and provide thermal insulation, dry suits also protect divers from chemical and environmental hazards. Made primarily with vulcanized rubber, up to three layers of clothing can be worn underneath the dry suit, depending on the water temperature and diving location. The dry suit seals for a water-tight fit. Dry suits usually cover the head, body, and feet, but separate dry gloves may be used to specifically protect hands.

Fins: Made from hard rubber, fins are equipped with spring snaps or quick-release units in the back for easy entry and removal. Fins are generally used when divers operate in stronger currents.

Munson Boat

This boat acts as the primary dive platform for USERT. It is equipped with a dive door for easy on/off access for divers and has a crane-like device called a davit that allows the boat to winch a large remotely operated vehicle (ROV) on and off the deck.

Kirby Morgan Superlite 77 Helmet

This standard commercial steel diving helmet weighs about 30 pounds on the surface. Features include:

Block: This allows the diver to switch from surface air to emergency gas supply carried in the tank on their back.

Block switch: The switch ventilates the helmet and prevents deadly carbon dioxide buildup; it also functions like a portable air-conditioning unit to cool the diver's face.

Nose piece: This allows the diver to clear their ears while descending to equalize the air pressure in the ear canal.

Regulator: This uses a venturi switch to adjust air intake.

Quad valve exhaust: This allows air bubbles to exit the helmet when the diver exhales.

Inside helmet: This includes a blue hood designed for a comfortable fit.

Ear speakers: This enables communication between the surface team and fellow divers.
