One Charged After Misuse of 911 System in Ldn

Adult Obesity Prevalence Remains High; Support for Prevention and Treatment Needed

New population data from 2022 show 22 states have an adult obesity prevalence at or above 35%, compared to 19 states in 2021, according to data from the Centers for Disease Control and Prevention (CDC). Just ten years ago, no state had an adult obesity prevalence at or above 35%. The 2022 Adult Obesity Prevalence Maps

highlight the need for population-based interventions to ensure that all people have access to healthy foods, safe places for physical activity, stigma-free obesity prevention and treatment programs, and evidence-based health care services such as medication and surgery.

The 22 states with an adult obesity prevalence at or above 35% include: Ala-

bama, Arkansas, Delaware, Georgia, Indiana, Iowa, Kansas, Kentucky, Louisiana, Mississippi, Missouri, Nebraska, North Dakota, Ohio, Oklahoma, South Carolina, South Dakota, Tennessee, Texas, Virginia, West Virginia, and Wisconsin.

The 2022 maps show that obesity impacts some groups

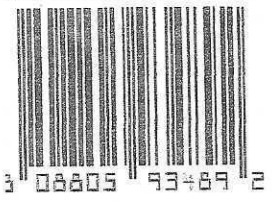

Stabbing

David Ellis, 30, Old Hwy 95 Lenoir City, was charged with Aggravated Assault x2, Attempted 1st Degree Murder.

Deputy A. Gann LCSO, was dispatched to Old Highway 95 in Lenoir City for a 911 hang up. Before arrival, Dispatch notified the deputy the caller was back on the line and that it was a possible stabbing call. Upon arrival, Deputy made contact with the (complainant/witness). The deputy ordered all subjects out of the house due to not knowing the nature of the call or the location of the suspect and offender at the time. Deputy then made contact with a witness and victim. The deputy noticed the victim's shirt to have a large amount of blood on his shirt and immediately grabbed his department-issued "green bag" medic bag. Deputy applied pressure to the neck

and head area where two lacerations were found and called for EMS. Before EMS arrival, the victim was asked what caused the incident, to which he stated Mr. David Ellis (offender) and victim were talking and then got upset towards the victim and started yelling and said "You think I'm crazy."

Once EMS arrived on the scene, the victim was transported to UT Medical Center. Deputy then gathered information from the witnesses and secured the scene until Detective S. Gaumer arrived on the scene by having the witnesses stay away from the crime scene and take a seat on the sidewalk and inform them that a detective was on the way to ask them a few questions. Deputy then reviewed camera footage from the front porch security camera showing the incident taking place on the front porch. The camera footage showed the victim and Mr. Ellis on

the porch appearing to have a conversation. Mr. Ellis then enters the residence multiple times and comes back to the porch with bags and appears to be grabbing his belongings. It was seen on camera footage that once the victim started to stand up from his seat on the front porch, Mr. Ellis then attacked the victim by stabbing the victim multiple times with a knife.

Mr. Ellis then continues to attack the victim by getting on top of the victim and continues to stab him in multiple areas. Once Detective

Gaumer arrived on the scene, Detective Gaumer took over the scene.

Mr. Ellis was located on 75 Northbound on the overpass bridge above Old Highway 95. Mr. Ellis was threatening suicide by standing on the edge of the bridge and threatening to jump off. Mr. Ellis was taken into custody at that time and transported to the Fort Loudon Emergency Room to be evaluated. Mr. Ellis was then transported to the Loudon County Jail. This did occur in Loudon County, Tn.

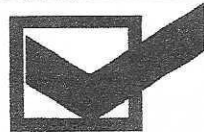

Heather Edwards, 43, Carding Machine Road Loudon, was charged with Domestic Assault x2.

Sgt Cogdill, with the Loudon police department, responded to a possible suicide threat at Carding Machine Rd, apt# 231. Upon arrival, officers met with complainant/victim. She stated her mother, Ms. Heather Edwards, had been making suicidal comments for the past three days, and earlier that afternoon, she had taken a knife from her that she had been putting against her wrist during that altercation. Ms. Heather Edwards pushed victim after the knife was put down. After speaking with Heather, she told all three officers she didn't want to

harm herself. She stated she was sexually frustrated when speaking with her daughter and their roommate/victim 2, the roommate said that before law enforcement was called, She and Heather Edwards verbally argued over the roommate cleaning a cat's litter box. When the roommate refused, they started arguing. That's when the roommate called the victim. When Ms. Heather Edwards found out that victim 2 had called her daughter, she began to push her. During this investigation, this officer determined Ms. Heather Edwards to be the primary aggressor and was arrested for two counts of Domestic Assault. She was transported to the Loudon County Jail. During the incident, Ms. Edwards threw herself on the ground while in

custody and refused to get up. Sgt Cogdill, and Officer Valletta had to pick Ms. Edwards up and carry her to the patrol unit outside. Actions did occur in the City of Loudon.

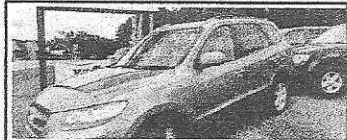

State-based adult obesity prevalence by race, ethnicity, and location is based on self-reported height and weight data from the Behavioral Risk Factor Surveillance System. 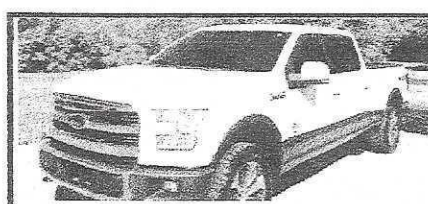

Later, after his older brother, Willard, returned from WWII in late 1945, Ray and Willard enrolled at the University of Tennessee (first at Martin then, two years later, at Knoxville) where they simultaneously obtained degrees in mechanical engineering and graduated in 1950. Ray had a wide range of interests over the years which included jewelry making, wine making, writing poems, limericks, and odes, scuba diving, biking, golfing, fishing, birdwatching, and visiting the national parks. He enjoyed designing and building unique bird houses that encouraged birds to take up residence in the yard, and he delighted in sharing amusing aspects of their behavior with his children and grandchildren. Ray was a loving and devoted husband, father, grandfather, uncle, and friend whose greatest pleasure was getting together with family on every occasion possible; long trips were never an obstacle, and being present for each grandchild's graduation was a top priority. A diligent, thoughtful communicator, Ray stayed in touch with regular phone calls, email and texting in his later years, and beautiful handwritten letters that frequently included newspaper clippings he thought would be interesting, entertaining, or helpful to the lives of his recipients. Ray thought always in terms of helping the "other person" first; his kindness and generosity brought people together and set a magnificent example for how to live a truly meaningful life. Preceded in death by his parents, Wes and Lucille Doty of Bruceton, TN, his son, Curtis Wesley Doty, and his brother, James Willard Doty of Dayton, TN, whom he counted as "the best brother and friend anyone could ever have", Ray is survived by his beloved wife of 72 years, Betty Wilson Doty of Loudon, TN (formerly of Bruceton, TN), sons Raymond Kimble Doty, Jr. of Loudon, TN, and David E. Doty (Janet) of Cincinnati, OH, and daughter, Holly D. Whittlege (William) of Sudbury, MA. Ray was also blessed with eight grandchildren which include Charles Doty (Katie), Peter Doty, Nicholas Doty: Taylor Doty, Morgan Skiba (Eric), Samantha Fornaris (Anthony); William Whittlege, James Whittlege (Emily), five great grandchildren, and numerous nieces and nephews. A Memorial Service to honor Ray will take place on Monday, November 20, 2023, at 11am at the Tellico Village Chapel of Click Funeral Home and Cremations, 145 Chota Centre, Loudon, TN 37774. 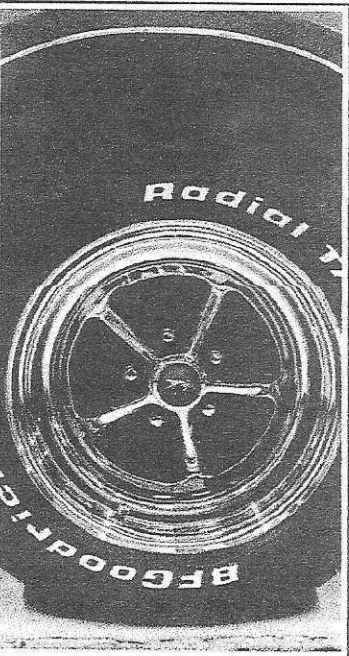

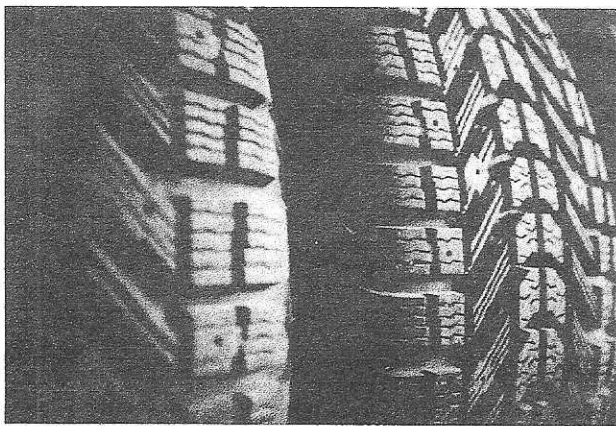
