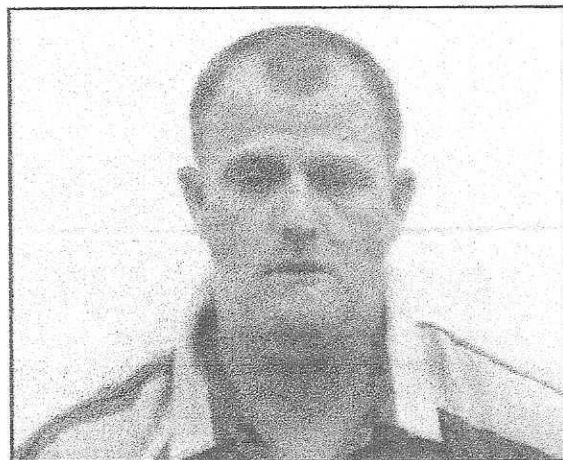

## Marshall Co. Register of Deeds' Spouse Pleads Guilty to Theft

### Register Approved Wife's False Time Sheets

An investigation by the Tennessee Comptroller's Office has resulted in a misdemeanor guilty plea to a criminal information by the Marshall County Register of Deeds' spouse, Ritaanne Weaver, who worked as a deputy in the register's office.

Investigators determined that Weaver

received at least \$299.05 in improper payroll payments while being absent from work on three occasions. The register knew his wife was not in the office on the following dates, but he still approved her false timesheets.

On October 7, 2022, Weaver travelled to Baton Rouge, Louisiana for a football game on the following day. Weaver was paid for 7.5 hours on this date.

On November 9, 2022, Weaver travelled to a conference with the register, but she did not attend the actual conference; she went as the register's spouse and was paid for 7.5 hours on this date.

On December 16, 2022, Weaver did not show up to work. However, her timesheet reflected

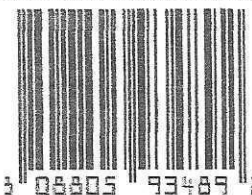

Regina Helton, 44, Abbott Road Lenoir City, was charged with Aggravated Assault, Assault, and Resisting Arrest.

Deputy Reagan LCSO, responded to Abbott Rd in reference in Regina Helton (Arrestee) being on this property making threats towards (Victim/Complainant) and (Victim). Upon arrival, Regina had returned to her home. While speaking with the complainant, they stated that she threatened to cause harm to them. When they told her to leave their property, she refused and continued to threaten them.

Complainant/victim also stated that they were afraid that Regina would cause harm to them or their children. They also said that if she was on their property

again, then they would assume that it was to cause harm to them. At that time, Deputy attempted to make contact with Regina at her residence to which she refused to answer the door. Deputy then made contact with witness at Abbott Rd. The witness has cameras on his property that captured Regina Helton on the victims property. Later, Deputy responded back out to Abbott Rd in reference to the witness having more video of Regina leaving trash in his yard. Upon arrival, Deputy observed Ms. Helton on her front porch. When Deputy announced myself, she went back into her residence and locked her door. Narcotics Investigators C. Jenkins, C. Gray, Sgt Det. Kirkland CID 3, and Deputy Huskins responded. Sgt. Det. Kirkland attempted to speak with Ms. Helton on the phone to

attempt to have her step out of the home to which she refused. Knowing that Ms. Helton had an active felony warrant for Aggravated Assault and a warrant for Simple Assault from a prior incident with LCPD, they made entry into the residence. While clearing the residence, Ms. Helton had hidden herself in the back bedroom under clothes and blankets. Deputy then placed Regina Helton into custody and transported her to the Loudon County

Jail without further incident. This did happen in Loudon County, TN.

Daniel Allen LCSO, arrived at Sunnyside Rd for a wreck without injury. Deputy found the victim standing on the side of the road next to his 1993 Ford Explorer. The victim explained he was driving home when a black Honda Civic driving in his lane came towards him. The victim pulled into the ditch in an attempt to avoid the Honda. The Honda struck his vehicle and then went off the road on the opposite side into a brush line. The Honda had been driven by Iris Guzman. Deputy found Miss Guzman in the back seat of her parent's vehicle on the scene. Miss Guzman has a strong smell of alcoholic beverages coming from her breath.

Deputy asked Miss Guzman how much she had to drink. Miss Guzman denied having alcohol. Miss Guzman was asked to exit the vehicle and perform standardized field sobriety tests. Miss Guzman has a Lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and onset of nystagmus prior to forty-five degrees in both eyes. During the walk and turn Miss Guzman was unable to stand as instructed and maintain balance during the instruction phase, began prior to instruction, missed all 9 heel to toe steps in both directions, and performed an improper turn. Officer Parmer LCPD, was dispatched to The Home Depot, Abbie Drive, in regards to a shoplifter. The complainant, The Home Depot AP, advised that he recovered the stolen items, and that a male, wearing a black shirt and shorts, fled to the parking lot, where he got into an older-model, white, Toyota SUV, and drove towards Walmart. Officer arrived on scene and made contact with the complainant, who advised that the male loaded his cart with \$284.96 worth of merchandise and went past all points of sale, in an attempt to deprive The Home Depot of their merchandise. Once

confronted, the male stated that his wife had already paid for the items, then fled to the parking lot. The above did occur in Lenoir City, Loudon County, Tennessee.

Offender was identified as Zachary Brockway. Offender was stopped on 8-30-2023 by Officer Law at First Baptist Church. Offender was a passenger in the white Toyota Highlander seen at the Home Depot store and on FLOCK 90 minutes prior to the theft. Warrant 2023-CR-802 was issued on 9-8-2023 in Lenoir City Court for shoplifting.

Home Depot LP advised of the warrant and ID. HD advised that he had not been trespassed.

Officer J. Ketner LCPD, arrested Mr. Brockway for outstanding warrant in the parking lot of Smoothie King.

that she clocked in at 8:08am on that date. The register was captured on video footage walking into the office at 8:01am that morning. Weaver was paid for 7.5 hours on this date.

Investigators noted other questionable instances in which Weaver was possibly paid for hours not worked; however, investigators were unable to determine wheth-

er she was working during those times in question.

After meeting with investigators, Weaver resigned from her position in March 2023. She then rescinded her resignation days later. The register approved both her resignation and her rescinded resignation. Weaver resigned again on August 30, 2023.

Based upon this investigation, on September 20, 2023,



Weaver pled guilty to a criminal information charging her with one count of theft of property under \$1,000 in the Marshall County Criminal Court.

“Although the register is responsible for approving employees’ timesheets in his office, he should have taken additional steps,” said Comptroller Mumpower. “The register should have had his chief deputy approve his wife’s timesheets to mitigate the conflict of interest.”

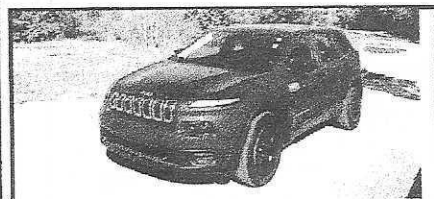

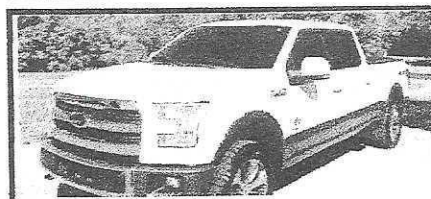

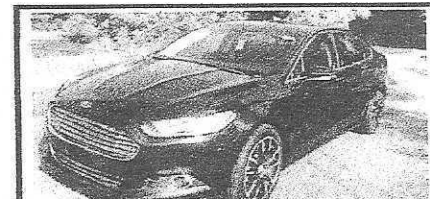

Later, after his older brother, Willard, returned from WWII in late 1945, Ray and Willard enrolled at the University of Tennessee (first at Martin then, two years later, at Knoxville) where they simultaneously obtained degrees in mechanical engineering and graduated in 1950. Ray had a wide range of interests over the years which included jewelry making, wine making, writing poems, limericks, and odes, scuba diving, biking, golfing, fishing, birdwatching, and visiting the national parks. He enjoyed designing and building unique bird houses that encouraged birds to take up residence in the yard, and he delighted in sharing amusing aspects of their behavior with his children and grandchildren. Ray was a loving and devoted husband, father, grandfather, uncle, and friend whose greatest pleasure was getting together with family on every occasion possible; long trips were never an obstacle, and being present for each grandchild's graduation was a top priority. A diligent, thoughtful communicator, Ray stayed in touch with regular phone calls, email and texting in his later years, and beautiful handwritten letters that frequently included newspaper clippings he thought would be interesting, entertaining, or helpful to the lives of his recipients. Ray thought always in terms of helping the "other person" first; his kindness and generosity brought people together and set a magnificent example for how to live a truly meaningful life. Preceded in death by his parents, Wes and Lucille Doty of Bruceton, TN, his son, Curtis Wesley Doty, and his brother, James Willard Doty of Dayton, TN, whom he counted as "the best brother and friend anyone could ever have", Ray is survived by his beloved wife of 72 years, Betty Wilson Doty of Loudon, TN (formerly of Bruceton, TN), sons Raymond Kimble Doty, Jr. of Loudon, TN, and David E. Doty (Janet) of Cincinnati, OH, and daughter, Holly D. Whitledge (William) of Sudbury, MA. Ray was also blessed with eight grandchildren which include Charles Doty (Katie), Peter Doty, Nicholas Doty; Taylor Doty, Morgan Skiba (Eric), Samantha Fornaris (Anthony); William Whitledge, James Whitledge (Emily), five great grandchildren, and numerous nieces and nephews. 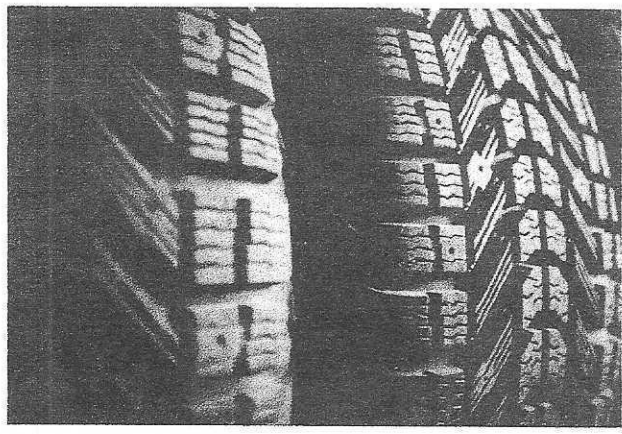

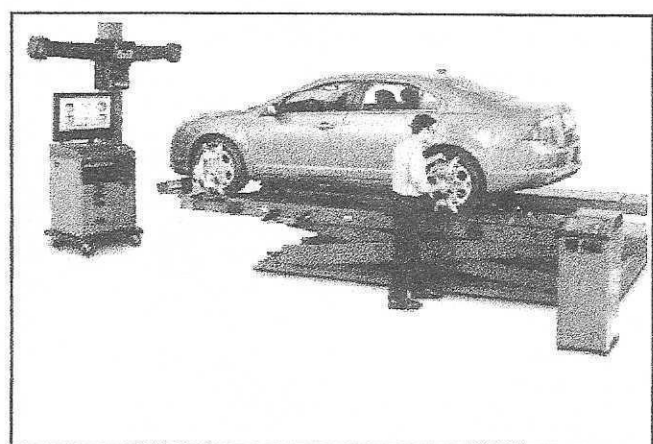
