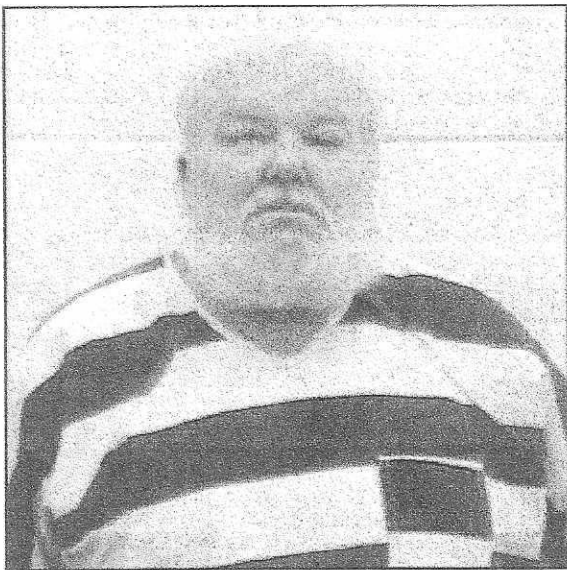

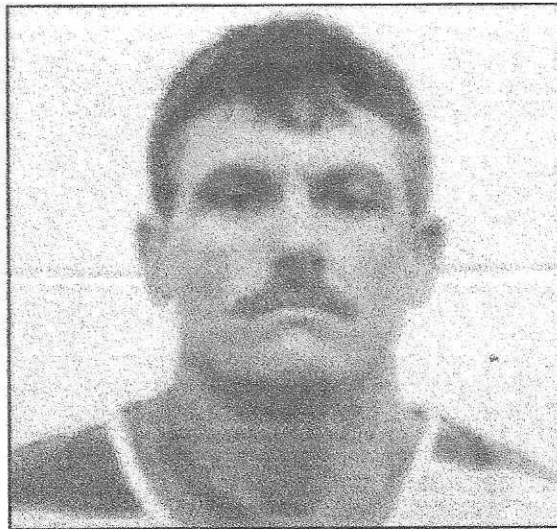

Former 12th Judicial District Drug Task Force Director Misappropriated \$7,246

An investigation by the Tennessee Comptroller's Office, working in conjunction with the Tennessee Bureau of Investigation, has revealed the former director of the 12th Judicial District Drug Task Force (DTF) misappropriated at least \$7,246 in confidential and seized funds between 2017 and 2021.

The 12th Judicial District Drug Task Force serves Bledsoe, Rhea, Sequatchie,

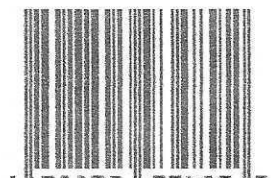

The 9th Judicial Drug Task Force executed a narcotics search warrant at Holland Trail in Lenoir City. Matthew Gibson, a male, Amy Everett, and Dustin Shirk were found in the residence and detained. While searching Gibson's room, agents discovered approximately 31.17 grams of methamphetamine, burnt aluminum foil, syringes, baggies, and a marijuana grinder. In Everett's and

Shirks room, agents found two baggies of methamphetamine weighing approximately 3.32 grams, along with syringes, a marijuana pipe, and additional baggies. Amy Everett, Dustin Shirk, and Matthew Gibson were taken into custody and transported to Loudon County Jail.

This incident occurred in Loudon County.

The 9th JDTF is comprised of law enforcement from the Lenoir City Police Department, Loudon Police Department, National Guard Counterdrug Unit, Federal Agency partners, and the 9th District Attorney General's Office

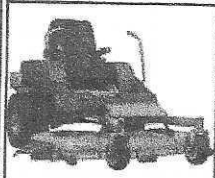

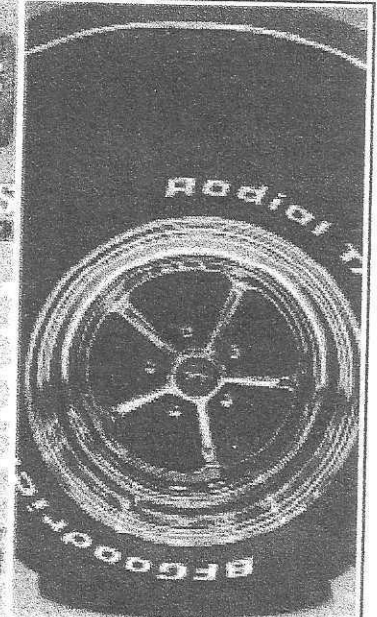

Theft

Anthony Kirkland, 37, Tomotley Road Maryville, was charged with, Assault Against First Responder/ Nurse x3, Resisting Arrest, Aggravated Criminal Trespass, Theft of Property, Vandalism, and Poss. of Drug Para.

Deputy Brockwell LCSO, arrived at Morganton Road for a trespasser call. When the deputy arrived on the scene, he spoke with the complainant/victim, about the trespasser. The complainant stated that he had observed a male, later identified as Anthony Kirkland (offender), walking around his property, cutting trees down, and possibly stealing fence posts. Due to the area of the incident, the deputy rode with the complainant where the offender was located, as his patrol vehicle would not have made it to the scene of the incident. The deputy observed the male described walking down the hill behind a tree that was on fire. The deputy identified himself and gave Kirkland verbal commands to stop walking away and to come speak with him. Kirkland refused to obey lawful command and kept walking away, eventually disappearing in the woods. The deputy ran down the hill, giving more verbal commands to stop. Kirkland continued to refuse the commands and started walking towards his vehicle. The deputy gave more verbal commands to Kirkland to stop what he was doing to come speak with him. Kirkland again refused verbal commands. The deputy attempted to grab Kirkland to gain control over him because of his evasive behavior. When

the deputy attempted to gain control of Kirkland, he actively resisted by pulling away and throwing punches, hitting me in the left upper lip with a closed-handed fist. The deputy continued to gain control of Kirkland using closed-handed strikes, hitting Kirkland back. The deputy then separated himself from Kirkland, deploying his taser and hitting him in the chest, which was not effective. Based on Kirkland's status and the taser not being effective, the deputy threw my taser as far as he could away from himself and Kirkland, as it was not going to be effective. Kirkland again continued to resist after being tased and struck me in the face with a closed-handed fist. The deputy then separated himself from Kirkland and drew his firearm, pointing it at Kirkland, giving him verbal commands. At this time, Kirkland picked up my taser and held it down to his side. Kirkland did not point the taser or try to use the taser as a weapon against the deputy. Kirkland turned his back towards me, walking back to his vehicle, and threw my taser in the bed of his truck. At this time, Cpl. Wallen arrived on the scene and drew her taser, hitting Kirkland in the chest and stomach. We then grabbed Kirkland, taking him to the ground, where Kirkland continued to actively resist. We eventually gained control over Kirkland and placed him in handcuffs. During this whole incident, based on training and experience, Kirkland showed multiple signs of impairment and an altered mental status. Kirkland was then transported to Fort Loudon Medical Center to evaluate his status.

Officer Garren and Officer Tatham LCPD, were dispatched to 911 N Highway 321 for a call for service in reference to a shoplifter. Once on scene, the officers made contact with the loss prevention team member, who advised officers that he observed the suspect trying to deprive the store of purchasing the items listed in attached receipt. The suspect was identified as Danny Ray Helton. Loss prevention provided Officer Tatham and Garren a letter from Walmart records that previously trespassed Danny Ray Helton from Walmart property effective December 26th, 2021 to indefinitely. This document was signed and understood

by Danny. See attached letter. Charged

Devin Shullaw, 38, Foute Town road Lenoir City, was charged with Criminal Trespass.

Cpl. Bengel LCSO, responded to Malone Road in reference to a Vandalism call. Upon arrival the deputy made contact with the Complainant, along with the Victim who stated that she found the rear and side windows

were broken on the house. The victim called the property owner and reported the damage to her. While speaking to the property owner, she stated that she has been having problems with the neighbor, the Suspect, Devin Schullaw. Devin was previously on the property several months ago and had broken the windows out of a trailer that is on the Malone Road property. When asked Devin admitted to the owner that he broke the windows and thought that it was alright because they were going to be tearing down the trailer. The owner instructed Devin that he was no longer allowed on her property. The owner would like to pursue charges and seek restitution. Said events occurred in Loudon County, TN.

Deputy Sean Yap LCSO, was operating stationary radar in the 10300 block of Martel Road when he observed a vehicle heading southbound on Martel Road

traveling at a high rate of speed. The deputy made a visual estimation of 60/35 mph at which time; the deputy activated the radar unit which displayed a speed of 62 mph. The vehicle continued to gain speed of 65/35 mph. The deputy proceeded to conduct a traffic stop at Martel Road. The deputy requested from the driver his license, registration, and proof of insurance. The driver was identified as Devin Shullaw by his driver license. A status check of his driver license revealed that he had a warrant out of Loudon County General Sessions for Criminal Trespass case number 20250130669-court docket 2025-CR-232. A check of the tag revealed it was expired on 2/28/2025. Devin was taken into custody for the warrant and issued two citations for speeding and expired tag. The vehicle was towed to Moneymaker's towing. This did occur in Loudon County Tennessee.

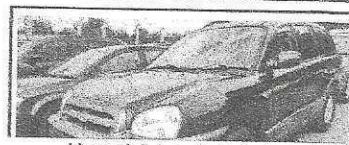

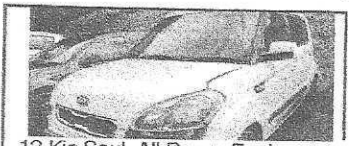

Grundy, Franklin, and Marion counties. During the investigation period, the DTF also served Van Buren and Warren counties.

Investigators determined the former director misappropriated funds by obtaining money for controlled drug purchases that were not supported by evidence, taking cash seized from the subject of a drug investigation, and taking confidential informant (CI) funds transferred from another agent. In one

instance, the former director created a document omitting the seizure of \$3,771 in cash. The same document contained the signature of another officer who confirmed his signature was not authentic.

Additionally, investigators question at least \$4,225 in confidential fund expenditures made by the former director for which no supporting documentation could be found to show that evidence or services were obtained.

"It is critical for law enforcement agencies to maintain clear, thorough docu-

mentation and strict oversight of both evidence and financial transactions," said Comptroller Mumpower. "Written policies must also be in place for the collection, recording, storage and destruction of evidence."

The former director's employment was terminated on May 31, 2021.

The results of this investigation have been communicated to the Office of the District Attorney General of the

11th Judicial District, who was appointed as Pro Tem in this matter.
