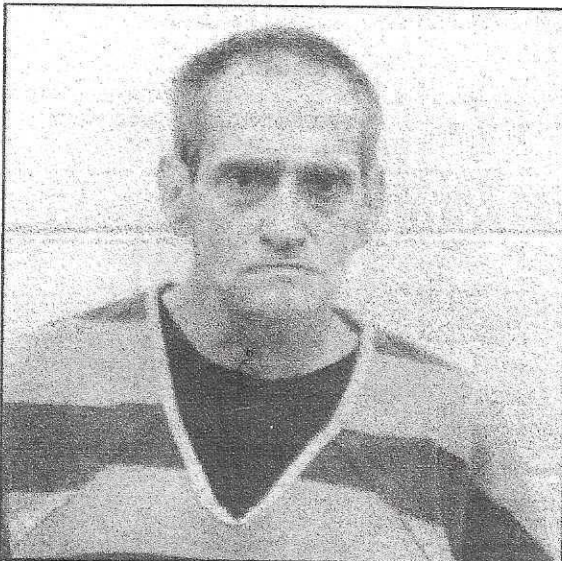

Former Probation Officer Indicted After Misappropriating Over \$17,000

Funds collected from probationers in Carroll and Weakley Counties

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of Teresa Dillingham, a former probation officer with Supervisory Services, Inc. (SSI), after investigators determined she misappropriated at least \$17,526.62 in court costs and fees collected from probationers.

Dillingham provided probation services to misdemeanor offenders in Carroll and Weakley

Charged

Jorge Chavez-Torres, 49, Kline Drive Loudon, was charged with Aggravated Assault.

Officers with LCPD, were dispatched to the Days Inn, in regard to a female in the lobby crying, stating that the male she rented a room with on 4/29, locked her out and wouldn't let her back in. Contact was made with the victim, who stated that her and (Jorge Chavez-Torres) rented a room together the night prior and when she went to the gas station, was told that she was not allowed back in by staff per Jorge. Officers noticed the victim to have multiple scratches,

bruises, and marks all over her body. When asked, she stated that on 4/27 her and Jorge were at his RV located at S Grand St, getting high on cocaine and stated that she became paranoid. She told Jorge that she needed to use the rest room and as she got up, Jorge grabbed her and body slammed her on the floor and got on top of her. The victim stated that she began screaming for help and Jorge then put both hands around her throat in an attempt to restrict her airway (Officers did observe markings in correlation to the victim story on her neck). During the incident, the victim advised that she bit Jorge on the face and chest in self defense. Eventually Jorge

got off of the victim and she left to go to Poplar St. Officers made contact with Jorge and the Days Inn and was read his Miranda Rights by Inv. Gallo and agreed to speak with officers. Officers did observe what appeared to be two bite marks in the exact location the victim described, and eventually admitted to Inv. Gallo that he and the victim got in a "tussle" because she was paranoid. Due to evidence, statements from both parties, and totality of the circumstances, Officer Eldridge LCPD, placed Jorge under arrest and charged him with Aggravated Assault and transported to the Loudon Co Jail. This did occur in Lenoir City, Loudon Co, TN.

counties. Between July 2023 and August 2024, she accepted payments from probationers but failed to remit them to the appropriate court clerks.

Dillingham concealed the misappropriation by falsely updating probationers' records to indicate they had completed their supervision, even though their court payments had not been received by the courts. As a result, some probationers were burdened with unnecessary hardships, including duplicate court costs and fee payments and unwarranted violations.

In addition to the misappropriated funds, investigators identified \$940 in questionable

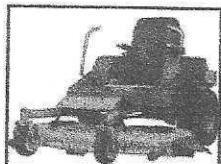
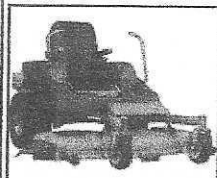

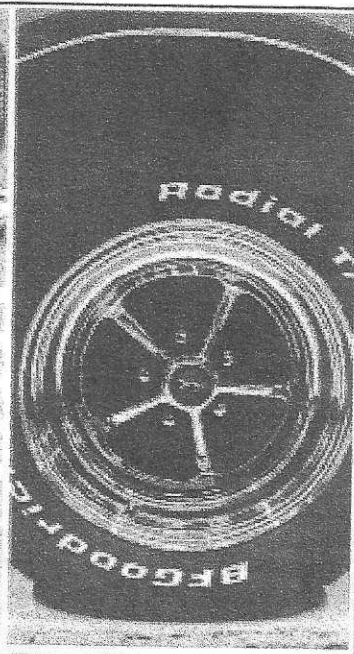

Lisa Roberts Alred, 49, Monument Street Lenoir City, was charged with, Public Intoxication.

Deputy B. McCall LCSO, was entering the EZ Stop convenience store located at 501 West Broadway Street when he was approached by the store clerk. The clerk advised that a female inside the store appeared to be under the influence of an unknown substance.

Upon entering the store, the deputy observed the offender, later identified as Lisa Lannell Roberts Alred, standing in the checkout line. She appeared to be nodding off and was responding very slowly to the clerk's requests. The deputy further observed Mrs. Alred struggling to count her change to pay for a drink. At one point, she asked the clerk if she could "just write a letter to pay for it." Mrs. Alred was unsteady on her feet and exhibited slurred speech. The deputy followed Mrs. Alred outside and asked if she would speak with me, to which she agreed. While speaking with her, the deputy noticed that she was very fidgety and unable to stand still. When asked if she had consumed any illegal substances or alcoholic beverages, she replied, "I'm a Christian." the deputy then asked where she was headed, and she initially stated "home," claiming it was about 1/4 mile

away. However, she later said she lived at Monument Street, which is approximately 1.3 miles from the location. While deputies were conducting a welfare check, Mrs. Alred became agitated, began raising her voice, and was uncooperative. At that time, she was detained and placed in handcuffs. Due to Mrs. Alred's level of intoxication, the behaviors she displayed, and in order to ensure both her safety and the safety of the public, she was placed under arrest for public intoxication and transported to the Loudon County Detention Center. This incident occurred in Loudon County, Tennessee.

payments that were not remitted to the courts but could not be definitively traced to Dillingham's personal use.

Dillingham resigned from SSI on August 6, 2024.

Based upon this investigation, in May 2025, the Carroll County Grand Jury indicted Teresa Suzanne Dillingham on one count of theft over \$10,000, one count of official misconduct, and one count of forgery over \$10,000.

"It's vital that courts and their probation service providers maintain strong controls over how funds are collected and remitted," said Comptroller Mumpower. "When payments are accepted without issuing receipts, and deposits are delayed, the opportunity for fraud increases."

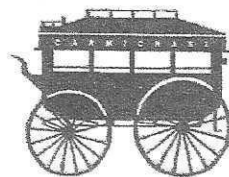

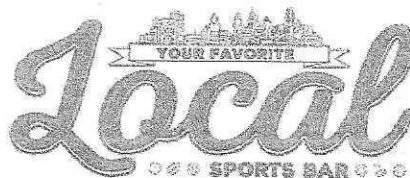

Resisting

Richard Botherton, 50, Corinth Church Road Loudon, was charged with Resisting Arrest, and, Speeding.

Deputy Edgmon, and Deputy Lewis LCSO, paced a 2008 Chevy Colorado with Tennessee tag 248BKBL at 45 Mph in a 30 Mph on Mulberry Street. The deputy initiated a traffic stop and made contact with the driver, Richard Botherton. Upon making contact with Mr. Botherton he was unable to provide a copy of registration, proof of insurance, and Tennessee DL. The deputy asked Mr. Botherton if there was anything illegal inside the vehicle and if the deputy could search it. Mr. Botherton stated no and declined consent. The deputy requested Deputy Curtis to her location. Upon Deputy Curtis's arrival on scene, Deputy Lewis asked Mr. Botherton

to exit the vehicle. Deputy Lewis asked Mr. Botherton to remove his hands from his pockets for officer safety and pat down. Mr. Botherton refused to remove his hands from his pockets and started actively resisting causing Deputy Curtis, Deputy Lewis, and myself to gain compliance for detention. After compliance was gained a pocket knife was observed laying at Mr. Botherton's feet that had fallen out of his pants pocket. Mr. Botherton was transported to Loudon County Jail. This did occur in Loudon County, Tennessee.

Crash

Betina Cansler, 51, Markwood Road Loudon, was charged with, DUI, Driving on Revoked/Suspended License, Resisting Arrest, Driving on Roadways Laned for Traffic, Use of Safety Belt, and Child Abuse or Neglect/Endangerment.

Trooper Morgan Snyder THP, was dispatched to a crash with injuries on United States Route 11 near Pond Creek Road. Upon arrival, the trooper found it to be a single vehicle in a ditch. The trooper made contact with the driver and subject, Betina S Cansler, who stated that she was driving north on US-11 when another vehicle that was traveling south crossed over the center dividing line. She stated that she swerved to avoid the oncoming vehicle, causing her vehicle to run off the right side of the roadway and crash into the ditch. There were no skid marks from the subject's vehicle. When speaking with the subject, the trooper observed her to have bloodshot watery eyes with drooping eyelids. She also had a cut on her head from the crash but had refused medical treatment. The passengers in the vehicle, a female and a juvenile were evaluated by emergency medical ser-

vices and released. In the presence of the subject, a Loudon County deputy stated that she was taking multiple prescriptions and that her driver's license was suspended. The trooper then asked the subject to perform field sobriety tests, to which she agreed. When asked about her drug use, the subject stated that she was taking multiple prescribed medications, two of which were to treat mental health issues, and the other was suboxone. When asked if she had ever been in trouble before, the subject stated that she recently got off probation for meth. Both Standardized Field Sobriety Tests and Advanced Roadside Impairment Detection Enforcement tests were conducted. The subject had lack of convergence of her right eye on one of the two attempts administered and no Horizontal Gaze Nystagmus. She had six out of eight clues on the Walk

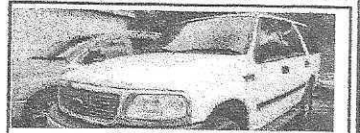

and Turn test and was unable to perform the One Leg Stand due to severe balance issues. She also had a 25-second Modified Rhomberg time and missed six out of six attempts administered on the Finger to Nose test. The subject was then placed under arrest for Driving Under the Influence First, at which time she resisted arrest by pulling and twisting away from Trooper Justin White. The subject was brought back under control

and promptly handcuffed and secured in the back of his patrol vehicle. The subject was read Implied Consent and agreed to provide a blood sample for chemical testing. She was transported to Fort Loudoun Medical Center, where a medical provider collected a blood sample for testing. The cut on her head was also treated at the hospital prior to transport to the Loudon County Justice Center. The child endangerment charge is for the juvenile, who was restrained in a front facing child

seat on the left side of the vehicle's second row seats at the time of the crash. This event

occurred on US-11 near Pond Creek Road in Loudon County, Tennessee.

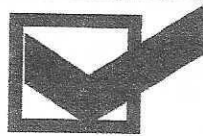

Primary Mitigations to Reduce Cyber Threats to Operational Technology

Overview

The Cybersecurity and Infrastructure Security Agency (CISA), Federal Bureau of Investigation (FBI), Environmental Protection Agency (EPA), and Department of Energy (DOE)—hereafter referred to as “the authoring organizations”—are aware of cyber incidents affecting the operational technology (OT) and industrial control systems (ICS) of critical infrastructure entities in the United States. The authoring organizations urge critical infrastructure entities to review and act now to improve their cybersecurity posture against cyber threat activities specifically and intentionally targeting internet connected OT and ICS.

Mitigations

The authoring organizations recommend critical infrastructure asset owners and operators implement the following mitigations¹ to defend against OT cyber threats.

Remove OT connections to the public internet. OT devices are easy targets when connected to the internet. OT devices lack authentication and authorization methods that are resistant to modern threats and are quickly found by searching for open ports on public IP ranges with search engine tools to target victims with OT components [CPG 2.X].

Cyber threat actors use simple, repeatable, and scalable toolsets available to anyone with an internet browser. Critical infrastructure entities should identify their public-facing assets and remove unintentional exposure.

Change default passwords immediately and use strong, unique passwords. Recent analysis of this cyber activity indicates that targeted systems use default or eas-

ily guessable (using open source tools) passwords. Changing default passwords is especially important for public-facing internet devices that have the capability to control OT systems or processes [CPG 2.A][CPG 2.B][CPG 2.C].

1 These mitigations align with the Cross-Sector Cybersecurity Performance Goals (CPGs) developed by CISA and the National Institute of Standards and Technology (NIST). The CPGs provide a minimum set of practices and protections that CISA and NIST recommend all organizations implement. CISA and NIST based the CPGs on existing cybersecurity frameworks and guidance to protect against the most common and impactful threats, tactics, techniques, and procedures. Visit CISA's Cross-Sector Cybersecurity Performance Goals for more information on the CPGs, including additional recommended baseline protections

(B) Sixty (60) days from the date the creditor received an actual copy of the notice to creditors if the creditor received the copy of the notice less than sixty (60) days prior to the date that is four (4) months from the date of first publication (or posting) as described in (1) (A); or

(2) Twelve (12) months from the decedent's date of death.

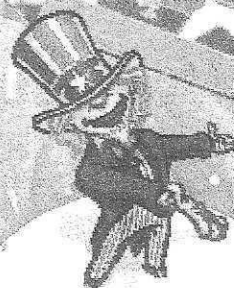

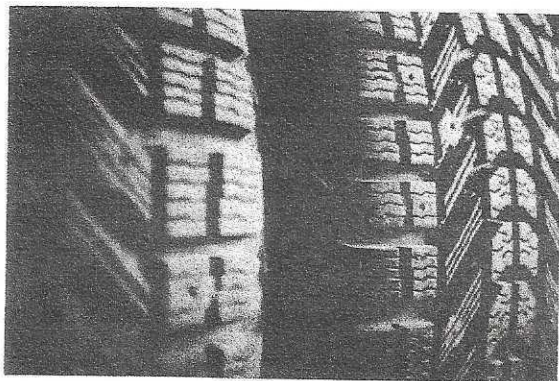
